Chairman Freeman asked if any Opposition was present and wished to speak. Seeing none, he inquired if there were others wishing to speak on the matter. Cal Boroughs, longtime resident of

St. Elmo and member of the Community Association of Historic St. Elmo, came forward. Mr. Boroughs read the following statement on behalf of the community association:

"This is a far different statement we would have thought we'd make a few weeks ago. On April 11, we were very disappointed to hear a decision of the planning commission to ignore the 2001 St. Elmo neighborhood plan, which stated that Hawkins ridge would not be developed, but preserved as a greenway, a plan adopted by the city council. this so concerns us that the planning commission would ignore the work of the neigh and the city council and grant approval to a zoning change that, in its own finding, would set a precedence for the future of Hawkins Ridge. Thankfully, we are in happier times now. We are grateful that Sunnyside Development has entered into a conservation easement with the Atlantic Coast Conservancy so that the desired Neighborhood for Preservation of Hawkins Ridge is now realized. We applaud them for this forward-looking solution. We are also thankful for the determined efforts of Councilman Chris Anderson and his commitment to helping our neighborhood. His behind-the-scenes work was indispensable. So you now have before you the request for a zoning change of a .99 acre property abutting the conversation area."

We acknowledge that you will likely approve this request with the added stipulations offered by Councilman Anderson. it is our desire that Sunnyside Development and Green Tech homes, while treating their properties with the utmost respect to both the legal requirements of the City Of Chattanooga, and the aspiration of the residents of St. Elmo residents, builds on this wise decision concerning Hawkins ridge and becomes a real partner with the St. Elmo neighborhood as they--the largest landowner in St. Elmo--pursue further development.

Councilman Anderson verified with Attorney Reisman that the two conditions he had requested were added in the final draft of the ordinance before the Council. Attorney Reisman confirmed and read the conditions added to Section 2 of the ordinance:

<u>SECTION 2.</u> BE IT FURTHER ORDAINED, That this rezoning shall be approved subject to limiting use to one single family residential dwelling and no more than fifty (50%) percent of the site can be disturbed.

Upon no further comments or questions, **Councilman Anderson moved to approve**, seconded by Vice Chair Mitchell. The motion carried.

A discussion ensued with Mr. Defoor, who stated that neither Erlanger nor UTC (neighboring the proposed properties) had voiced opposition to the height increase. Mr. Bridger also confirmed that this property was not under the Form-Based Code zone.

**Councilman Hakeem moved** to change the maximum height to *eight (8) stories*. He was seconded by Councilman Grohn. Chairman Freeman confirmed that he had made contact with the neighborhood association regarding their concerns. Mr. Defoor stated that he had been unable to reach someone from representing the neighborhood, but confirmed that letters had been mailed to residents of Fortwood and Lincoln Park regarding the rezoning request.

Attorney Reisman presented certificates for nine local stores to sale wine in grocery stores. He confirmed that the City Attorney had checked that stores had met zoning requirements and undergone background checks. He explained that after the certification, the stores must apply to the Tennessee Alcoholic Beverage Commission for a preliminary license that will allow them to stock wine. After July 1, 2016, they will receive their permanent license to begin selling wine in grocery stores. Councilman Anderson clarified again that, while the Council is issuing certificates today, off-premise consumption would not be allowed until July 1. Attorney Reisman confirmed that citizens may see the wine stocked, but the stores would not sale wine in grocery stores until July 1. Certificates for each of the above-listed stores were signed in the open meeting by five councilpersons.

## RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Reisman read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Freeman recognized the following persons:

- Nathan King (Orchard View) He found it interesting that the Council had comments and questions about the Homeless Veterans report today, but the Council did not have comments or questions after Bro. Muhammad's address last week. He asked the Council not to congratulate "quietness" over initiative. He asked if the Council would comment on the People's State of the City Address. He voiced concerns about the public not being allowed to speak at the Council's 3:00 p.m. meetings, and not being able to speak on agenda items at the 6:00 p.m. meetings. He stated that there is a non-democratic process serving the ruling classes in government.
- Pastor Timothy Careathers (Westside Baptist Church) He was thankful that the Council heard from people last week who are living on the margins. He informed the Council that he left the meeting last week feeling enlightened, but not encouraged. In spite of questions and comments made from the public, he felt the Council chairman was more concerned with moving on in haste last week. He stated that we, the people, want a formal response to the People's State of the City Address, and asked for that response in the next two (2) weeks—by May 24. He said that the people will see what the Council thinks about the people from their response. He said the Council has "got our votes" and needs to "be our voice." He asked the Council to consider the suggested initiatives suggested last week by Bro. Muhammad that called for reallocating the \$1 Million proposed for street cameras to the People's Youth Initiative and the People's Formerly Incarcerated Rehabilitation Board. He also noted that the People's State of the City that was distributed to them last week, but Bro. Muhammad will leave copies for any councilperson needing it.
- Donna Christian Lowe (Co-managing partner, Main Street Innovations) She thanked the Council for their process and their diligence in what they do. She reminded them of the needs of the Glass Street Area and commented on some of the marketplace activities taking place at the Glass Street Collective, such as marketing classes for children. She informed the Council of the "Frankly Speaking" podcast launched by entrepreneur Michelle Peterson, which will air tomorrow at 4:30 p.m. She informed the Council of a doughnut shop that will be launched in 30-60 days on Glass Street. She said a contest was held where children designed the logo and name for doughnut shop. She invited the Council their event on tomorrow for the unveiling of the doughnut shop name.

• Monty Bell (Chattanooga) – He has been homeless for the past 17 years. After years of being a professional broadcaster, he returned to Chattanooga to teach "the King's language" (e.g., annunciation and diction). Upon returning, his character was under attack and the character assassination, he said, continues. He is disappointed in one Council member who has known him since high school and has not helped him in finding out the former employee who blacklisted him at the City. He repeated the motto: Stop the Silence/Stop the Violence. He said the Council remains in their comfort zone, protected in several ways, but, he said, there is nothing stopping a bullet from destroying him. He wants his name out of the criminal justice system. He wants his company back: Monty Bell Public Exposure Company. He asked that the Council get him off the streets.
