November 24, 1998

The meeting of the Chattanooga City Council was called to order by Chairman Crockett with Councilmen Franklin, Hakeem, Hurley, Lively, Pierce, Rutherford, and Taylor present. Councilman Eaves was absent due to recuperation from knee surgery. City Attorney Randall Nelson, Management Analyst Randy Burns, and Assistant Council Clerk Shirley Crownover were also present.

INVOCATION

Invocation was given by Councilman Taylor.

MINUTE APPROVAL

On motion of Councilwoman Hurley, seconded by Councilwoman Rutherford, the minutes of the previous meeting were approved as read and signed in open meeting.

REZONING

#1998-206 (DAVID WALKER)

On motion of Councilman Lively, seconded by Councilwoman Rutherford, AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE A TRACT OF LAND LOCATED AT 3501 ST. Chairman Crockett announced that a Resolution authorizing temporary
usage of the City's R-O-W at the Old Stage Run Subdivision entrance
along Cassandra Smith Road would be deferred two weeks by vote of the
Public Works Committee.

DONATION AGREEMENT

Councilwoman Rutherford stated that the following two resolutions were
discussed in Parks and Recreation Committee and comes to the Council
with the recommendation for approval and much appreciation.

On motion of Councilman Pierce, seconded by Councilman Hakeem,
A RESOLUTION AUTHORIZING THE PARKS AND RECREATION
ADMINISTRATOR TO EXECUTE A DONATION AGREEMENT BETWEEN
MICHAEL F. MCGAULEY, JOHN R. MCGAULEY, JR. AND THE
MARY V. MCGAULEY IRREVOCABLE TRUST, RELATIVE TO THE
DONATION OF APPROXIMATELY TWENTY-TWO (22) ACRES
LOCATED IN SOUTH CHATTANOOGA, BORDERED BY CHATTANOOGA
CREEK
was adopted.

Chairman Crockett asked Mr. Michael McGauley, who was present, if he
would like to say a few words. Mr. McGauley stated that this was an
opportunity for them to honor their grandfather and all the "pieces
fell together". He thanked the Parks and Recreation Dept. and Bobby
Davenport, noting that Councilmen Pierce and Taylor are familiar with
the project and stated he thought this was something we could all get
excited about for the future.

Chairman Crockett thanked Mr. McGauley for this gift, noting that it
was also a tribute to Charlotte Reynolds, a granddaughter who had
passed away.

COMPUTER -- YEAR 2000

Councilman Taylor stated that in looking at the Overtime Report and
noting a Computer Troubleshooting session, he questioned if we were
ready for the Year 2000 and were addressing this.

COMPUTER - YEAR 2000 (Cont'd.)

Adm. Boney responded that this was in his department, and they had been working on this two years and were compliant and felt good about this; that they were doing some real testing to make sure there would be no surprises; that the vendors are on target throughout the city.

At this point Councilman Pierce also brought up a concern that he had noticed concerning a real slowness in getting computer access and bringing up data. Adm. Boney responded that he would get someone to look into this.

Chairman Crockett stated that he had written a letter to Mayor Kinsey, Ken Hays, and Adm. Boney stating that he would like to have a committee meeting with a full briefing on the issues that had just been raised by Councilman Taylor; that this would be discussed at a future time in committee, and he thanked Councilman Taylor for bringing up this subject.

COMMITTEES

Councilwoman Rutherford reminded the Council of the Parks and **Recreation Committee scheduled for Tuesday, December 1st at 3:30 P.M.** which would be the final discussion before the 2008 Plan is voted on.

Chairman Crockett stated that in the absence of a Chairman of the Budget and Finance Committee that Vice-Chairman Lively would chair a **Budget and Finance Committee on Tuesday, December 15th at 4:00 P.M. to discuss the Capital Budget.**

Councilman Hakeem reminded the Council of the Economic Development Committee scheduled for **Tuesday, December 1st at 5:00 P.M.** regarding the Planning Study proposed for Ridgedale.

Chairman Crockett stated that Councilman Franklin would serve on the committees that former Councilman Swafford had served on.

Chairman Crockett stated that in the absence of Councilman Eaves, who had had surgery on his knee and it was pretty painful for him to get around, that he would like to set a **Safety Committee following the Committee of the Whole Meeting scheduled for Tuesday, December 8th** (immediately following the Public Works Committee).

At this point Councilman Pierce stated that he felt uncomfortable as Chairman of the Legal and Legislative Committee, and would like for Chairman Crockett to appoint someone else or chair it himself. Chairman Crockett responded that Councilman Pierce had brought important issues to the committee; that he would be looking at the committee structure in the near future and would be making some adjustments.

RECOGNITIONS

Chairman Crockett recognized Scout Stephen Lee who was in the audience and was working on his Citizen's Merit Badge. He also recognized some young people from UTC who were present.

SISTER BEY

Sister Bey approached the Council and stated she would like a better understanding of Resolutions (e) and (f); that she would like it in writing "in black and white" and was not taking this lying down. Chairman Crockett explained to her that it was a donation of some property to the City of Chattanooga.

EDDIE HOLMES

Eddie Holmes of the NAACP was present. First of all he thanked Chairman Crockett for the part he had played in getting him appointed to the Human Rights and Human Relations Committee. Secondly, he stated that he knew the Council was interested in Fairness and Tax Equity, and he would like for the school districts to be a part of discussions and that the schools in the city limits receive their proper share.

MR. MARCEL

Mr. Marcel approached the Council regarding fire safety changes that he would like to see put into effect. He mentioned an incident where he and his son had been trapped in a back bedroom with bars, and they could not get out; that there needed to be some new changes to the information that the Fire Dept. was giving out regarding survival; that he felt like his child was killed because of the information that the Fire Dept. delivered -- that the size of the mouth needed to be measured. He stated that he also did home improvements, and he would like to see changes in the Fire Alarm Building Code regarding smoke detectors; that any home over \$50,000 should be required to have heat detectors, and he would like to see the City of Chattanooga pioneer this idea and be the first in the country to change the Fire Alarm Code; that if this would save one life it would be worth it.

Chairman Crockett noted that Chief Copperger was in the audience and would take these comments into consideration.

ADJOURNMENT

Chairman Crockett adjourned the meeting until Tuesday, December 1, 1998, at 6:00 P.M.
