At this point, Councilman Pierce wanted to know what all was going on, as he was not here last week.

Adm. Leach explained that Parks and Recreation have a project to redo a good part of Warner Park and will be re-designing the stormwater, which was a run-off issue and were also combining the sewers at Engel Stadium and Warner Park; that they were being dovetailed together, and we were doing it all at the same time. He explained that there were three different contracts for the same purpose.

Councilman Pierce asked if this was part of the project concerning Engel Stadium and the University?

Adm. Leach explained that it was south of Engel Stadium that the University is interested in; that this also involves the Railroad, and we are waiting on them to deed over the property. He reiterated that it was really the property south of Engel Stadium that the University was interested in; however we have contracts in the entire region and these are designs for both sides of the Railroad Track.

Councilman Pierce indicated that he had no problem with this but understood that at a future date we might be donating this to the University.

Adm. Leach explained that the University desires to put a track and some intramural fields on the site.

AGREEMENTS (CONT'D)

Councilman Pierce wanted to know if this would be donated to the University after we move the sewers? Adm. Leach responded that he could not answer that; that as far as he knew, we own this property jointly with the County, and the Railroad owns one-half of the parking lot.

At this point, a young man from the audience noticed that Resolution (f) had not been read. It was explained to the young man that this had been deleted from tonight's agenda. Chairman Page also explained that Resolutions did not allow time for public hearings.

was adopted.

As many Councilmembers had received calls about the bidding process on the agreement, Dan Johnson was asked to speak.

Mr. Johnson stated that they started last August to investigate technology for surveillance cameras for Coolidge and Renaissance Parks, as these were two leading places with problems. He explained that they went through a long process and had decided upon this technology and that Mark Keil had visited various places, including Knoxville, to see their cameras, and we selected wireless technology, which we were going to employ. He explained that the cameras are mobile and on a State Contract, which we utilize when we can because it speeds things up because bids have already been taken.

AGREEMENT CAMERAS (CONT'D)

At this point, several in the audience raised their hands to speak, and Chairman Page allowed one person to come forward.

Aaron Lance of Tremont Street spoke first, stating that he was a representative of the City of Chattanooga citizens that disagree with this technology—that in his assessment the answer should be "No", because he had not done anything wrong; that he did not want a camera watching his every move; that this would not deter crime and was not the answer—that it was just a band aid and would not stop the crime, and we needed to be asking why the crime was taking place and looking at such things as economic desperation, no jobs, no education, and no hope! He stated that these cameras would monitor people like rats in a laboratory; that the cameras might go in, but they would not solve the problem. He ended by saying he did not support this, and we needed to find another way to cure the sickness.

Chairman Page thanked the young man for his interest in government.

DONATION(COMPUTERS)

On motion of Councilwoman Rutherford, seconded by Councilwoman Bennett.

A RESOLUTION AUTHORIZING ACCEPTANCE OF THE DONATION OF FORY (40) COMPUTERS VALUED AT TEN THOUSAND DOLLARS (\$10,000.00) FROM THE TENNESSEE VALLEY AUTHORITY (TVA) TO THE DEPARTMENT OF EDUCATION, ARTS & CULTURE AS PART OF THE MAYOR'S COMPASSION INITIATIVES THROUGH TECHNOLOGY PROGRAM

was adopted.

CONTRACT

Councilman Rico, seconded by Councilwoman Bennett, moved to approve a Resolution authorizing a contract with Volkert & Associates, Inc. for design work on the Manufacturer's Road Streetscape in an amount not to exceed \$85,500.00.

Councilman Benson stated that this was discussed in the Legal and Legislative Committee meeting today, and it received an affirmative recommendation for approval. He explained that this was a commitment that the State made to RiverCity and now the State was coming back saying that they did not have the \$85,500.00. He stated that it concerned him that the State would not honor this, and he had mixed emotions and wondered if we were acting prematurely. He asked Adm. Leach if there had been any negotiations with the State—that we have streets that need paving, and we have the same inflation to deal with that the State does, and he questioned them forgetting their obligation.

Adm. Leach noted that this was discussed today; that he was not optimistic that the State would participate further; that the State did buy the right-of-way and property owners are doing the curb and guttering, and we will do the paving; that the State had participated, and this is all about timing. He reiterated that the State had participated, and they frankly did not have the funded means to produce \$85,500.00. He stated that this had become a cooperative effort really, and the State had bought the right-of-way, which was significant money.

Councilwoman Rutherford stated that she was very sorry, but she did not think this was urgent—that the condos were not opening tomorrow! Councilman Rico removed his motion, and Councilwoman Rutherford moved that this be deferred, and we communicate further with the State. This was seconded by Councilman Benson.

The question was asked if there could be further discussion and Attorney Nelson explained that a motion to table is non-discussable. In that case, Councilman Benson withdrew his second to defer.

CONTRACT (CONT'D)

Councilwoman Robinson stated that timing was everything! She noted that the State did come in and acquire the right-of-way and that property owners are willing to put in curbs and gutters, and we will do the paving. She stated that she thought this was important and that Green Life and Rock Creek were making a tremendous investment, and she thought this was a very good investment for the City.

Councilman Benson still questioned if it would hurt to defer this and see if the State could find the money.

Adm. Leach explained that if this were delayed it could not be completed in a timely manner; that we would be behind in construction, and we wanted to make the timing coincide with the opening of the buildings.

Councilwoman Rutherford wanted to know when the buildings would be opened, and Adm. Leach responded in the Fall. Councilwoman Rutherford stated that she thought we should go back to RiverCity and see if they will participate in the cost or do something with the State; that this leaves us holding the bag for \$85,500.00 because the State did not fulfill their obligation, and the City of Chattanooga is having to pick this up; that she thought we should ask the State again before we ask our taxpayers to pay this.

Councilwoman Bennett explained that they had met with RiverCity, and they said it would be some years out before the State could do the work; that they met with the developers, and they are very willing to do their part; that this is a time-sensitive project with the Bridge opening soon, and we have been very careful looking at dollars and cents. She stated that she thought this was very critical and wished we could wait two years, but we can't.

On motion of Councilman Rico, seconded by Councilwoman Robinson, A RESOLUTION AUTHORIZING A CONTRACT WITH VOLKERT & ASSOCIATES, INC. FOR DESIGN WORK ON THE MANUFACTURER'S ROAD STREETSCAPE IN AN AMOUNT NOT TO EXCEED EIGHTY-FIVE THOUSAND FIVE HUNDRED DOLLARS (\$85,500.00)

was adopted, with Councilwoman Rutherford voting "no".

NORTH SHORE MORATORIUM

Attorney Nelson explained that there would be two additional Resolutions that were added at the end of the Legal and Legislative Committee meeting. He proceeded to read the Resolution, explaining that this would be a moratorium on the issuance of new construction building permits as opposed to building permits for remodeling and interior improvements. The area we are talking about is in North Chattanooga on Forest Ave. to Tremont Street. He stated that it was his understanding that this is all zoned residential now.

On motion of Councilwoman Robinson, seconded by Councilwoman Bennett.

A RESOLUTION DECLARING A MORATORIUM ON ISSUING OF NEW BUILDING PERMITS EXCEPT FOR SINGLE-FAMILY DETACHED RESIDENTIAL STRUCTURES IN AN AREA HEREIN BELOW DESCRIBED UNTIL JULY 31, 2007

was adopted, with Councilwoman Rutherford and Councilman Rico voting "no".

Councilwoman Robinson explained that the North Shore Land Use Plan is near completion, but until this is affirmed, this is good for the neighborhood. She stated that many of the houses are single-family but some zoning is left over, and we are working to change this. She stated that this would be supportive of the neighborhood in general.

Councilwoman Rutherford explained why she was voting against this—that we are taking the prime real estate season and building season and putting on a moratorium, which she thought would hurt. She added that she could support a 30-day moratorium but not a 90-day one.

NORTH SHORE MORATORIUM

Attorney Nelson again read the Resolution, stating that this was a moratorium on a much larger area—an area bounded on the east by the Veteran's Bridge, Thompson Street, and Beck Avenue, on the south by the Tennessee River, on the west by US Highway 27, and on the north by Pine Ridge Street, Chambliss Street, Peak Street, and the opened and unopened right-of-ways of Colville Street. He noted that this was discussed in committee meeting.

On motion of Councilwoman Robinson, seconded by Councilwoman Bennett,

A RESOLUTION DECLARING A MORATORIUM ON SELECTED REZONING REQUESTS IN AN AREA HEREIN BELOW DESCRIBED UNTIL JULY 31, 2007

was adopted, with Councilwoman Rutherford and Councilman Rico voting "no".

Councilwoman Robinson explained that this again supports the many hours of work that have gone into the C-7 Plan on the North Shore.

Councilman Benson noted in looking at the Personnel transactions that he sees we are losing another Animal Services Officer. He stated that he knew this would be taken away from the Police Department, but we still have to operate, and we are 2-3 short already. He noted that if one read the 311 Report, they would see five pages full of pick-ups of dogs in the community. He stated that he hoped we were not short-handed and something is being done.

Chief Cooper agreed that there is a need, and we still have to operate.

Also, Councilman Benson mentioned that the Council used to get Personnel Transactions where the salary was mentioned; that four police officers left this month, and there is no salary mentioned. He wanted to know why they stopped listing the salary?

Chief Cooper pointed out that we only lost one policeman—that the other two were suspensions.

Councilman Benson still maintained that we used to get the salaries, and we did not have a salary for the lady that was resigning.

PERSONNEL (CONT'D)

Ms. Kelley agreed that in the past they had reported salaries; that now they only list salaries if it is a "hire" or "promotion". She stated that they could put all the salaries back in.

Councilman Benson stated that the Council is being told that we are losing policemen because of the salary, and we don't know what their salaries are.

Ms. Kelley stated that she was not saying we are not short of personnel in Animal Services, but we have compensated some.

Chief Cooper stated that we are two short in Animal Services now.

COMMITTEES

Councilman Rico reminded Councilmembers of the **Public Works** Committee meeting scheduled for Tuesday, May 1st at 3:00 P.M.

Chairman Page announced that committee assignments would be coming forth within the next few days.

KENNY SMITH

Mr. Kenny Smith, a School Board member who resides at 4308 Fountain Ave. addressed the Council, He noted that several schools were under construction; that Apison was overbid but the number had been brought down. He stated that a majority of the subs are local subs. He mentioned that apprenticeships have grown in Chattanooga and that we are headed toward a shortage of skilled labor; however everything looks good construction-wise. He invited members of the Council to attend a School Board meeting whenever they could, stating that he knew this was a County issue but if we all worked together, we would get more done.

Chairman Page thanked Mr. Smith for coming tonight.

MARY PARHAM

Ms. Parham stated that she wanted to address the issue of cameras and was a representative of County schools. She mentioned that the Dean of Fine Arts at her school had been cut out because of funding and yet we are spending \$660,000 on cameras and putting them in an area, where she considered, had the least amount of crime in the entire city of Chattanooga (Coolidge Park). She stated that she thought the money would be better spent on community outreach and troubled youth; that the cameras were just putting a band-aid on the problem. She went on to say that she played Frisbee in the park and did not want "Big Brother" watching her; that she felt this was an infringement and a slap in the face.

Chairman Page thanked Ms. Parham for participating in government and saying what she thought was right, adding that one day she might be sitting on this podium.

Councilwoman Robinson also thanked the young people for coming tonight, explaining that the County does the funding for schools and the money being spent on the cameras could not go to school funding. She explained to Ms. Parham that a lot of people who go to Coolidge Park do not share her level of comfort; that in after hours people will feel safer with the cameras, and we want to provide a safe environment. She explained that this was a "balancing act", and it is our intention to give assurance that we have clean and safe parks.

Councilman Benson added that no one wants to give up freedom, but we have to respond to irresponsible actions to ensure that people do not misuse freedom; that parents had lost children at Virginia Tech, and he knew they wished that the school had had some foresight with some type of surveillance. He explained that we were trying to protect citizens, and he apologized if we were infringing on anyone's freedom, but explained that we saw this as protection.

Attorney Nelson added that these cameras would be portable and could be used citywide for high crime and crack houses. He emphasized that the cameras were for crime-fighting, also and not just strictly for Coolidge and Renaissance Parks.

DAVID RIVERIA

David Riveria of Tremont Street was the next speaker. He stated that he had heard mention that we had a shortage of police officers and yet we were talking about cameras. He stated that he thought it would be logical to increase human resources; that he thought this would be better economically and that he stood in solidarity with Mary Parham on her ideas about the educational system—that he thought it would be better to use the money there.

Councilman Rico explained that we do not have the money to hire the amount of policemen for this work; that he knew people did not like to be watched, but he did not think these young people realized what these cameras could do—that they could catch someone that was doing something wrong and get them off the streets.

STATE OF CITY ADDRESS
