COUNCIL MEETING MINUTES

for July 2, 2013 6:00 PM

CALL TO ORDER

Chairman Yusuf Hakeem called the meeting to order with Vice Chairman Chip Henderson, Assistant City Attorney Phil Noblett, Councilwoman Carol Berz and Councilmen Chris Anderson, Moses Freeman, Russell Gilbert, Larry Grohn, Jerry Mitchell and Ken Smith all present.

Also present was Randy Burns, Management Analyst; and Nicole Gwyn, Deputy Clerk

PLEDGE OF ALLEGIANCE

Councilman Mitchell led the assembly in the Pledge of Allegiance. He invited Mr. Carl Greene, a member of St. Marks United Methodist Church, to bring the invocation.

PROCEDURAL ADVISEMENT

Chairman Hakeem requested that cell phones be placed on silent or vibrate. He also advised that the main doors at the front of the assembly room would be locked at 6:00 p.m., allowing attendees to exit, but not re-enter through those doors.

SPECIAL PRESENTATION

"Eric Jones, II and Terence Norman" By Council Chairman Hakeem

Chairman Hakeem recognized Mr. Jones and Mr. Norman for being young men of outstanding character and valor, and for being an inspiration to others. Mr. Jones and Mr. Norman placed in the National African-American History Challenge by the 100 Black Men of America.

Councilman Smith presented a plaque to Mr. Jones, a Hixson High School graduate who intends to participate in the Navy ROTC at the University of Memphis. Councilman Freeman, a member of the 100 Black Men of Chattanooga, presented a plaque to Mr. Norman, who is a senior at Hixson High School who is active in the ROTC.

ORDINANCE #12736

AN ORDINANCE AMENDING CHATTANOOGA CITY CODE TO DELETE ALL REFERENCES TO THE HUMAN SERVICES DEPARTMENT IN ARTICLE IX. CHAPTERS 2-641 THROUGH 2-660 RELATIVE TO THE RENAMED AND REORGANIZED CHATTANOOGA YOUTH AND FAMILY DEVELOPMENT DEPARTMENT; ARTICLE III, DIVISIONS 1 AND 2, CHAPTERS 2-138, 2-139, AND 2-143 RELATIVE TO HUMAN RESOURCES; ARTICLE I, CHAPTERS 24-30 AND 24-37: ARTICLE II. CHAPTER 24-63. AND ARTICLE VII. DIVISION 2. CHAPTER 35-252 RELATIVE TO TRANSPORTATION; ARTICLE 1, CHAPTERS 32-13 AND 32-14; AND ARTICLE V, DIVISION 18, CHAPTER 38-285 RELATIVE TO ECONOMIC AND COMMUNITY DEVELOPMENT; ARTICLE XII, CHAPTER 11-377; ARTICLE I, CHAPTERS 26-7, 26-13, AND 26-14 RELATIVE TO PUBLIC WORKS; ARTICLE VI, CHAPTERS 2-581 AND 2-584; AND ARTICLE I, CHAPTER 26-24 RELATIVE TO GENERAL SERVICES TO BE CONSISTENT WITH NEW ADMINISTRATIVE DEPARTMENTS **EXISTING** IN THE CURRENT ADMINISTRATION.

ACTION: APPROVED

Ordinances – First Reading:

The following ordinance was read:

ORDINANCE #12737

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, CHAPTER 7, RELATIVE TO ANIMAL PERMITS. AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 7, RELATIVE TO ANIMALS AND FOWL TO REFERENCE "THE ANIMAL CENTER" AND TO AMEND CHATTANOOGA CITY CODE, CHAPTER 7, RELATIVE TO ANIMAL PERMITS BY CREATING NEW PROVISIONS FOR DEALER PERMITS, KENNEL PERMITS, ANIMAL PERFORMANCE PERMITS, ANIMAL RESCUE PERMITS, URBAN CHICKEN PERMITS, AND DOGS IN OUTDOOR DINING AREAS PERMITS.

Councilman Anderson made a motion, seconded by Councilman Freeman, to adopt the ordinance with one additional amendment to the bill: to move the setback from 10' to 15'.

A discussion ensued, in which Attorney Noblett enumerated on the amendments to the ordinance package thus far, including a change in the caption for the ordinance:

- 7-495 Adding: "...two-thirds of those active members as defined by that neighborhood association, may out of the provisions..." and "No permit will be issued when an applicant is prohibited from possessing chickens based on the terms of a restrictive covenant..."
- 7-552 Annual permit fees for dogs in outdoor dining areas will be \$50
- 7-485 (b) Changing setback from 10' to 15' as follows: "...coop and the fenced enclosure must be set back at least fifteen feet (15') from the property line..."
- 7-484(a) "No more than eight (8) Urban Chickens are allowed for any single-family dwelling."

Attorney Noblett indicated that the latest version of the ordinance package would be available to the public on the city's website.

Councilman Anderson moved to adopt the amended, substitute animal control ordinance package today that deals with general provisions for permits, dealer permits, kennel permits (insofar as it does not relate to zoning ordinances), animal performance permits, animal rescue permits, urban chickens and dogs in outdoor dining areas permits, including the amendment to the setback from 10' to 15' in Section 7-485(b). Councilman Freeman seconded the amended motion.

After Attorney Noblett read the rules of procedure for those wishing to address the Council, Chairman Hakeem allowed members of the public to make comments regarding this ordinance:

- Ron Roy (of Ashton Street) Opposes urban chickens: Wanted to point out the food chain had changed very much since 1776 and also wanted to point out the health issues associated with chickens; believes the 15' barrier is not sufficient; believes urban chickens will have negative effects on real estate.
- Susan Roy (of Ashton Street) Opposes urban chicken: Played audio of the four (4) chickens in coops next to her daughter's property; her daughter's family has been negatively affected in indescribable ways; hopes the city will examine the health issues and financial issues of allowing urban chickens.
- Kathy Trundell (of North Chattanooga) Opposes urban chickens: doesn't believe citizens are informed enough about this issue; has a chicken coop next door and was surprised that the city is voting to allow urban chickens; recommends allowing people to vote on whether or not to allow urban chickens.

After further discussion, Councilman Grohn made a motion to defer for one week, seconded by Councilman Gilbert. Chairman Hakeem called for a roll call vote:

After further discussion, Councilman Mitchell made a motion, seconded by Vice Chairman Henderson, to amend the ordinance package to include that no permit may be granted without written permission of all adjoining neighbors on the initial application.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedures for persons wishing to address the Council on non-agenda items. After which, Chairman Hakeem recognized the following persons:

• James McKamey, Jr. (of Hwy. 58 community) - Brought attention to police brutality cases in Chattanooga; wanted to know what citizens could do to provide a greater level of accountability for Chattanooga police.

Councilman Hakeem discussed some of the steps and resources the city has undertaken for accountability. Councilman Gilbert also asked Mr. McKamey to speak with him after the meeting.

• Frank DePinto (of Chattanooga) - He took a 60-second moment of silence to protest what he called the "death" of his constitutional rights during the Council's meeting on June 18, 2013.

After the moment of silence, Mr. DePinto yielded the floor to return to his seat. At that time, Attorney Noblett notified Mr. DePinto that he could not address the Council again until August 6, 2013. Mr. DePinto acknowledged the rules of procedure.
