

# City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES

August 6, 2013 6:00 PM

 Patrick Kellogg (of N. Hawthorne St.) - He is excited about this expenditure and will do surveys to see what the community wants to happen with this land. He would like to consider what is "economic development" in relation to the land use. He believes a covenant on the land is needed.

Chairman Hakeem thanked Mr. Kellogg for his comments. After further discussion, the motion to approve the resolution passed 8-to-1, with Councilman Smith voting "NAY."
