CALL TO ORDER

Chairman Yusuf Hakeem called the meeting to order with Vice Chairman Henderson and Council members Carol Berz, Chris Anderson, Moses Freeman, Russell Gilbert, Larry Grohn, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton, Management Analyst Randy Burns and Deputy Clerk Nicole Gwyn were also present.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Hakeem recognized the following persons:

- Karl Epperson (Boynton Drive) He voiced concerns about affordable housing in light of
 the development taking place behind the Westside community. He also spoke on an
 increase of rats at Patten Tower that he attributes to the fire in April.
- **Donald O'Connor (Chattanooga Tea Party)** He supports equality, but does not support same-sex partner benefits. He stated that city-funded benefits are already equally available to all employees.

- Janelle Jackson (Concerned Citizens for Justice) She and CCJ support equal benefits for equal work in regards to domestic partner benefits. She and CCJ believe there is only one correct choice: support equal benefits for equal work.
- Megan Smith (Chattanooga) She supports equal benefits for equal work and asked the Council to consider the issue from a constitutional standpoint. She also asked all other supporters in the assembly to stand as a show "as one voice."
- Robert Harrison (North Chattanooga) He asked the Council to consider equal benefits
 for equal work as a way of helping Chattanooga grow as a progressive, metropolitan city
 that accepts change. He voiced concerns about LGBTQIA employees being "devalued"
 and "dehumanized" without equal benefits for equal work.
- **Gill Schropshire (District 7)** He voiced concerns that he and his neighbors have not been able to reach their Council representative. He would like to schedule a meeting with his representative.
 - o Chairman Hakeem asked Mr. Schropshire to speak with his Council representative after this meeting and schedule an appointment then.
- Summer Ramirez (Chattanooga) She works for a company that provides domestic
 partner benefits for her spouse, which is one reason why she has remained in the city.
 She asked the Council to consider domestic partner benefits from the standpoint of
 retaining families and employees in the city.
