"Domestic Violence Awareness Month"

Presented to Valerie Radu, Director of the Family Justice Center

Presented by Vice Chair Dr. Carol Berz on behalf of Mayor Andy Berke

Vice Chair Dr. Berz presented the following proclamation to Valerie Radu, Director of the Family Justice Center:

Whereas: October has been proclaimed National Domestic Violence Awareness Month

by the President of the United States since 1987; and

Whereas: The family is the foundation of a safe and healthy community and it is a goal

of this mayoral administration for our communities to be safe; and

Whereas: Domestic violence affects all citizens of Chattanooga, crossing all racial,

social, religious, ethnic, geographic, and economic groups; and

Whereas: On average, nearly 20 people per minute are victims of physical violence by

an intimate partner in the United States. During one year, this equates to

more than 10 million women and men; and

Whereas: In our country, intimate partner violence accounts for 15% of all violent

crime; and

Whereas: Ending domestic violence requires a collaborative effort involving ever part

of our society and requires our law enforcement and justice system to work together to hold offenders accountable for their crimes and protect victims

and their children.

Now Therefore,

I, Andy Berke, Mayor of the City of Chattanooga, do hereby proclaim the month of October as

Domestic Violence Awareness Month

In Witness Whereof, I have hereunto set my hand and caused the Seal of the City of Chattanooga to be affixed this the 22^{nd} day of October, 2014

Dr. Radu also introduced Robin Brewer of the Partnership for Families, Children and Adults, and Cathy Allshouse of Southeast Tennessee Legal Services, stating that both work exclusively and extensively with victims of domestic violence, helping them through the court system.

"Pancreatic Cancer Awareness Month" Presented to Charlie Steinhice and the Pancreatic Cancer Action Network Presented by Councilman Chris Anderson

Councilman Anderson presented Charlie Steinhice and the Pancreatic Cancer Action Network with the following proclamation:

Whereas: Pancreatic cancer is one of the deadliest cancers, currently the fourth leading

cause of cancer death in the United States, and is projected to become the second by 2020 with a five-year relative survival rate at a startling rate of six

percent;

Whereas: In 2014, an estimated 46,420 people will be diagnosed with pancreatic cancer

in the United States and 39,590 will die from the disease, approximately 820 of

those in Tennessee;

Whereas: When symptoms of pancreatic cancer present themselves, it is generally in

late stage; 73 percent of pancreatic cancer patients die within the first year of their diagnosis while 94 percent of pancreatic cancer patients die within the

first five years;

Whereas: The Pancreatic Cancer Action Network is the national organization serving

the pancreatic cancer community in Chattanooga and nationwide through a comprehensive approach that includes public policy, research funding, patient services, and public awareness and education related to developing effective

treatments and a cure for pancreatic cancer;

Whereas: The Pancreatic Cancer Action Network and its affiliates in Chattanooga

support those patients currently battling pancreatic cancer, as well as those

who have lost their lives to the disease, committed to nothing less than a cure;

Whereas: The good health and well-being of the residents of Chattanooga are enhanced

as a direct result of increased awareness about pancreatic cancer and

research through early detection, causes, and effective treatments;

Therefore, be it resolved

that on this 28th day of October 2014, the Chattanooga City Council does designate the month of November 2014 as

PANCREATIC CANCER AWARENESS MONTH

in Chattanooga, Tennessee.
