COUNCIL MEETING MINUTES

September 22, 2015 6:00 PM

CALL TO ORDER

Council Chairwoman Carol Berz called the meeting to order with Vice Chair Moses Freeman and Council members Chris Anderson, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Chip Henderson, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton and Council Clerk Nicole Gwyn, CMC, were also present.

PLEDGE OF ALLEGIANCE

Councilman Anderson led the Assembly in the Pledge of Allegiance. He also invited Bassam Issam of the Islamic Center of Greater Chattanooga to lead the invocation.

APPROVAL OF LAST MINUTES

On motion of Councilman Smith and seconded by Councilman Gilbert, the minutes of the last meeting (September 15, 2015) were approved as published.

ORDINANCES - FIRST READING:

AGENDA ITEM VI(a):

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 31, ARTICLE I, SECTION 31-14 RELATIVE TO MULTI-USER PRIVATE SEWER SYSTEMS.

Attorney Hinton noted changes to sub-section D that addresses the extension of credit. He indicated that this had been removed. He then requested that the Council move to substitute the current version with the revised version. A discussion ensued. Justin Holland, Deputy Administrator of Public Works, responded to questions from the Council. Brent Goldberg, Chief Operating Officer, joined the discussion to clarify who would be affected by moving lateral lines to the city sewer system.

Councilman Smith moved to defer one (1) week, seconded by Councilman Mitchell. Chairwoman Berz noted that the ordinance would be discussed further in Strategic Planning next week. Upon no further discussion, the motion carried.
