 The committee met today in open meeting for updates on the Chattanooga Ambassadors Program and My Brother's Keepers. The committee also heard updates on Family Connect.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- Hannah Kuhn (Chattanooga) She is concerned with river conservation. She informed the Council of the recent article in the New Knox News regarding river pollution in Chattanooga being on an international scale. She made comments on the microplastic levels being the highest ever. She reminded the Council how it took three years to clean up the air pollution in the city. She believes the City can organize to limit excess plastic usage, just as it did to limit air pollution. She challenged the Council and the community to organize on this issue to clean the water.
- **Joseph Boswell (Chattanooga)** He represents the YMCA and wanted to introduce the YMCA's Leadership Club that teaches youth about government and leadership in Chattanooga. Students show interest in business, politics and activism.
- Anthony Gladden (Chattanooga) He founded the "Choices with Chess" program for teaching youth in the art of playing chess. He thanked Councilwoman Coonrod and Councilman Byrd for seeking volunteers for the program. The pilot program is currently in Orchard Knob Middle. It was based on a program in Chicago. The program helped students excel. He is transitioning the program to YFD centers now. He connected with chess instructor Thomas Lane of Chattanooga State and asked Mr. Lane to speak about his work with the program.
- Thomas Lane (Chattanooga) He has been working with the chess program and thanked Councilwoman Coonrod for connecting him with Mr. Gladden. He believes that chess transcends socioeconomic and other barriers. He noted that Mr. Gladden is planning a block party and chess tournament to raise funds for the program. He envisions active engagement throughout the city for this program and told ways in which individuals may help. He believes that most solutions to problems are not top down. He believes chess helps us become more intentional in our thinking and actions.
- Austin Sourbright (Chattanooga) He represents the Chattanooga Area Labor Council
  and asked the members of the Labor Council to stand for recognition. His organization
  would love to connect with the Council as a whole and individually in the future.
- **Gary Ball (Tower Construction)** He has addressed the Council twice before regarding surplus property and city tax liens. He saw that Hamilton County was offering 1001 S. Holly Street for a minimum bid of \$1,000. He wanted something in writing so that his company may bid on it. He wanted to know if the liens were attached, and if all surplus city property available and can have liens removed.
