The investigation report showed sewage coming from the lateral cleanout cap and spilling onto the road. Public Works Wastewater Division televised the main sewer line and found a blockage in the lateral. It was later determined that the lateral line was broken 25 feet underground beneath the roadway. The property owner was quoted \$45,634.04 from South East Total Service, LLC, to repair the lateral and restore the roadway. Being unable to afford the cost and still under ongoing enforcement actions from the Public Works Stormwater Division, the property owner asked to go to City Court to determine if the C-SLAP program under City Code could be used to get a no-interest loan on the repairs using South East Total Service, LLC, as the contracted plumber. On April 7th, 2022, the Judge ruled that C-SLAP could be used to finance the repairs using the requested contractor. The order was signed on May 9th, 2022, and work on the lateral line finished on June 6th, 2022  EVENT TYPE: Emergency |
