COUNCIL MEETING MINUTES

October 25, 2022 6:00 PM

CALL TO ORDER

Council Chairman Darrin Ledford called the meeting to order. A quorum was present that also included Vice Chair Raquetta Dotley and Councilpersons Carol Berz, Demetrus Coonrod, Chip Henderson, Isiah Hester, Jenny Hill, Marvene Noel, and Ken Smith. SPECIAL PRESENTATION

Public Hearing - Westside Evolves Plan

Prior to the hearing, Chairman Ledford discussed the time limits for the hearing, then opened the floor to Eric Myers, Executive Director of Chattanooga Design Studio, who gave an <u>overview</u> of the Westside Evolves plan that included a slide <u>presentation</u>. After the presentation, Mr. Myers responded to questions from Vice Chair Dotley about the building and relocating phases of the plan.
