CALL TO ORDER

Council Chairman Darrin Ledford called the meeting to order. A quorum of eight was present that also included Vice Chair Raquetta Dotley and Councilpersons Carol Berz, Chip Henderson, Isiah Hester, Jenny Hill, Marvene Noel, and Ken Smith. Councilwoman Demetrus Coonrod was not present at this meeting. Other participants present were Phil Noblett, Interim City Attorney, and Nicole Gwyn, Council Clerk. Councilwoman Berz asked Ms. Satterfield if the final conditions agreed to by Administration were included in the RFP currently presented. Ms. Satterfield yielded to Mr. Thongnopnua, who advised that the final conditions had been emailed to the Council, but not incorporated in the RFP as currently presented. Councilwoman Berz informed the Council of the following three conditions added Administration has agreed to add to the final version of the RFP:

- Bifurcation notice at the beginning of RFP process;
- Creation of an oversight committee appointed by each of the nine councilpersons; and
- Clawback material in two pieces: (1) physical by the a reversionary clause, and (2) the service clawback by reduced payment due to lack of performance.

Chairman Ledford ruled to treat these conditions as an amendment to the current RFP. Therefore, **Councilman Henderson moved** to approve issuing the RFP to get the matter on the floor. Vice Chair Dotley seconded. **Councilwoman Berz moved** to amend based upon the amended criteria read into the record. Councilman Henderson seconded. The motion carried. **Councilwoman Berz moved** to approve as amended. Councilman Henderson second. The motion carried.
