January 31, 2023 @ 6:00 PM

CALL TO ORDER

Council Chairman Darrin Ledford called the meeting to order. 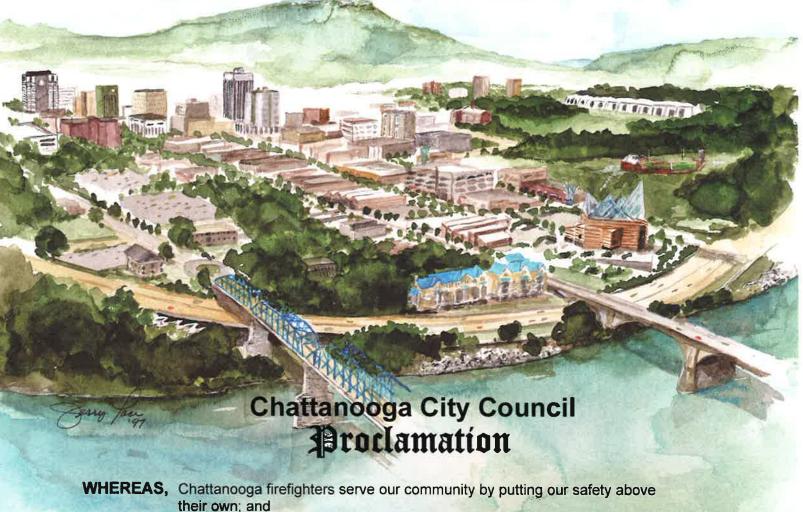

WHEREAS, the International Association of Fire Fighters (IAFF) and the Firefighter Cancer Support Network (FCSN) have declared January as Firefighter Cancer Awareness Month;

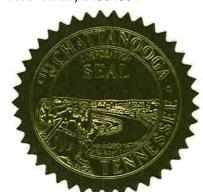
