## CALL TO ORDER

Vice Chair Dotley called the meeting to order. ## PROCLAMATION - "World Autism Awareness Month" By Chairman Darrin Ledford

Chairman Ledford asked Dave Buck of Chattanooga Autism Center, and Erskine Oglesby, Jr., the center's board chair, to join him at the podium.
