October 24, 2023 6:00 PM

Later in the meeting, Attorney Noblett informed the Council that their rules of operation state: "It shall take five (5) 'yes' or five (5) 'no' votes to adopt or defeat any action." Therefore, he advised the Chair to bring this item back to the Council agenda next week since there weren't five votes on the losing or prevailing side. Councilman Smith voiced his objection on behalf of the losing side of the motion. Chair Dotley ruled that this ordinance would be added to next week's agenda (October 31) for another vote since today's motion failed to garner five votes on either side.

Karen Rennich, Deputy Director of Regional Planning, gave a presentation on this case. Her presentation included the following: Case summary, map of zoning, surrounding land uses, site photos, site plan, plan name/recommendation, staff recommendation, and Planning Commission recommendation. Discussion ensued about the following:

- Shared Parcel
- The north 100 feet
- Current uses

- Applicant's planned uses
- History of the two parcels
- Current STVR listing

Chris Anderson, Senior Advisor for Legislative Initiatives, affirmed that no new STVRs can be licensed in this area. Chair Dotley confirmed that there was no one present in opposition to this case. Therefore, she opened the floor to members of the Applicant.

Representing the Applicant:

- Michael Stewart (Attorney, Chambliss, Bahner & Stophel P.C.) He discussed the Applicant's planned use for an event space, the split zoning request, and the parcels being combined in 2020. He also noted the Applicant's willingness to accept a condition regarding the STVR. [View here for full comments.]
- Hanna-Claire Boggess (Attorney, Chambliss, Bahner & Stophel P.C.) She discussed the Applicant's event venue, the online STVR listings, the fence between the parcels, the long-term resident on the premises, and the fifteen signatures they have from surrounding neighbors in support of the rezoning. planned uses. Both attorneys responded to questions on the Applicant's event venue, "The Betty," which is operating on the property and advertised on various STVR websites. Councilman Henderson demonstrated that he could use his phone to rent a room on the premises online now.

Upon no further questions, Councilman Henderson spoke on the quiet enjoyment of the neighborhood. Councilwoman Noel spoke on how an event hall was not appropriate for this neighborhood. Therefore, **Councilwoman Noel moved** to deny. Councilman Henderson seconded. The motion carried.
