- Zones within the Westside Context Area may apply a parking discount of 0.5 spaces per residential unit. Shred parking is allowed and encouraged; and
- The Clear Pedestrian Zone shall be an eight-foot (8') minimum of an A Street and a six-foot (6') minimum for a B Street in the W-N- and W-PK Zone.
