December 5, 2023 3:30 PM

Whereas:

Gunther is four and a half (4.5) years old with three (3) years of faithful police

service. During his service, he assisted in the recovery of 150 firearms, 5,200 rounds

of ammunition, 154 shell casings, and 6 explosive devices; and

Whereas:

In March 2023 a mass was removed from K-9 Gunther's right lumbar area. This mass was identified a malignant type of tumor. Although Gunther has been doing well since the removal of this mass, he requires ongoing monitoring every 3-6 months to ensure that this tumor has not metastasized to other areas of his body. Because of the malignant nature of Gunther's tumor, the veterinarian has advised

that Gunther's projected lifespan has been dramatically decreased; and

**W**hereas:

Due to Gunther's predicted lifespan being approximately 30 months and due to ongoing care and monitoring, Veterinarian Blair Comman has recommended K-9 Gunther to be retired and placed in the care of his handler, Lt. Sean O'Brien; and

Whereas:

Gunther's handler and officer, Lt. Sean O'Brien, understands the responsibility of

Gunther's retirement; and

Whereas:

Gunther's handler and officer, Lt. Sean O'Brien, will keep K-9 Gunther and is willing to accept all responsibilities for Gunther's future care such as medical,

food, and housing; and

Whereas:

The City of Chattanooga is grateful to K-9 Gunther and his handler, Lt. O'Brien, for their service to the Chattanooga community for the last 3 years as their service and commitment have undoubtedly had a positive and long-lasting impact on the safety and well-being of our great city.
