COUNCIL MEETING MINUTES

March 12, 2024 3:30 PM

CALL TO ORDER

Council Chair Raquetta Dotley called the business meeting to order at 3:32 p.m. A quorum was present that also included Council Vice Chair Jenny Hill and Councilpersons Chip Henderson, Ken Smith, Darrin Ledford, Isiah Hester, Carol Berz, and Demetrus Coonrod. Councilwoman Marvene Noel arrived after the call to order.

During the course of the hearing, Mr. Shults (Regional Planning) made a partial presentation [view here] on the case that included a summary of the application, aerial view, and site plan. He noted that there were no members of the Opposition at the Planning Commission, but there had been one letter of opposition received.

On behalf of the Applicant:

- Tripp Ward [view <u>here</u>] He is the Food City Real Estate Development Manager.
 He informed the Council about a letter sent in support of the rezoning. He spoke on
 the added condition of a berm on Ballard Drive. He displayed a revised plan for the
 site based upon their flagship site.
- **Patrick Addison** [view here] He is the V.P. of Residential Care at the Tennessee Baptist Children's Home. He spoke on the space that would be created if the rezoning is approved and spoke on the other TBCH properties on Ballard Drive.

Councilwoman Berz informed the Council about the two options that Mr. Ward presented to the neighborhood and the neighborhood's choice of building on the C-2 track.

On behalf of the Opposition:

Dee Dee Fram [view <u>here</u>] – She represented the residents who attended the
neighborhood meetings. She read three examples of Food City not being a considerate
neighbor. She spoke on what she perceived as strongarm tactics by Food City.

Councilwoman Berz informed the Council of a petition from the residents at the retirement home who all chose Option B proposed by the Applicant. She also further elaborated on the stronghold tactics that had taken place regarding this case.

<u>Rebuttal</u>: Mr. Ward spoke further on the berm. He also informed the Council of a "nuisance issues" list that he sent to Councilwoman Berz.

Councilwoman Berz questioned Mr. Ward on the shades and lighting. She questioned Mr. Pitcairn (Public Works) on the egress, ingress, and sidewalk. During which, Mr. Ward agreed to accept the recommendations of the traffic study, if done, regarding the sidewalk. Mr. Pitcairn confirmed that a traffic study would determine if a crosswalk is needed with the sidewalk. Vice Chair Hill spoke on the tone of the email from the developer [see attached] on this rezoning. After all questions and comments, Councilwoman Berz moved to deny. Vice Chair Hill seconded. The motion carried.



To: Carol Berz

Dr. Berz,

If you have a few minutes this morning, I would really like to speak with you. I have left messages yesterday and today.

We received the news yesterday that you have decided that you are going to turn down the zoning request for our property that Food City has proposed. I am confident that you are attempting to do what you believe is best for the neighborhood. I respect that.

However, as a neighbor that has occupied 74 acres in the community for the last 70 years we respectfully disagree. We do not believe the consequences of turning this down will be beneficial to the neighbors or to us (as TBCH serving children). Here are our reasons:

- 1. This decision means that TBCH will receive \$620,000 less for that 1.55 acres. 100% of those dollars are dedicated to the redevelopment of our campus which would be beneficial to the neighborhood and broader community.
- 2. Now Food City will go forward with the exact same store size on less acreage so there is really not a substantial gain for the neighbors--although we think Food City will be a benefit to nearby residents.
- 3. Now Food City will not be creating a berm along Ballard which would have been a plus for the neighborhood.
- 4. As much as we don't want to, now we will be forced to try and maximize the sale or development of the 1.55 acres--which means we will have to densify the site according to zoning in place. We are scrambling to now figure this out, but it appears that we can probably get between 25 to 30 units on the site. Again, we do not really want to have to go this route. We don't really want those units in that location. However, we have to be good stewards of this land so we can build what the children need. We have to maximize the sale of that lot, which is why we thought the plan of letting Food City purchase that piece made sense.
- 5. Turning this down will not save the trees. We cannot afford to pay for someone else's green space by not developing the property that we have been entrusted with.
- 6. Preventing Food City from creating the pad site (which already zoned C-2) is not really going to impact the neighborhood positively. Our goal has always been to clean up and improve the Lee Highway frontage. That pad site would have contributed to that goal.

I know you were wanting us to delay this; however, due to Food City's current lease term that was not an option.

Dr. Berz, I know you are doing what you believe is best for the neighborhood. We are just disappointed that we weren't brought into all of these conversations when you were making your decision.
