- Whether revenue will be spent other than downtown (Coonrod)
- Addressing impact of diversity in affordable housing (Coonrod)
- What the "cost more" looks like (Smith) Ms. Allen agreed to provide follow-up on this topic.
- Options if the county did not approve the TIF (Smith)
- Explanation of parcels (Ledford)
- Whether projects already completed will start funding the TIF loan faster (Ledford)
- Continuing looking at affordable housing options (Coonrod)
- Jobs creation through the project (Coonrod)
- Supporting beautification of the area (Coonrod)
