PLANNING AND ZONING COMMITTEE MINUTES:

January 07, 2020

Call to Order

Councilman Darrin Ledford, Committee Chair, called the meeting to order at 3:20 p.m. in the Assembly Room of the John P. Franklin, Sr. City Council Building. A quorum was present, including Council Chairman Erskine Oglesby, Vice-Chairman Chip Henderson, and Council members Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, and Ken Smith. Approval of Minutes

Ordinances - Final Reading - Agenda Item 5A

Councilman Byrd commented about a constituent's buffer concerns and mentioned waiting to hear from the developer on this project. He also asked Mr. Bridger about the planned number of units to be built. Mr. Bridger agreed to produce an estimated number by the 6:00 p.m. meeting. Upon no further comments or questions, the issue was closed.

Ordinances - First Reading - Agenda Item 6B

Councilwoman Berz stated that this item would be deferred, and asked Mr. Bridger to follow up regarding the developer's expectations. Upon no further comments, the issue was closed.

Resolutions - Agenda Item 7F

Councilman Ledford informed the Council that this resolution was a result of collaboration between himself and the community. Upon no further comments, the issue was closed.

The applicant wants to zone the land for a farm, but the site is less than five acres, so it needs a special permit, which answered Councilman Ledford's unasked question.
