

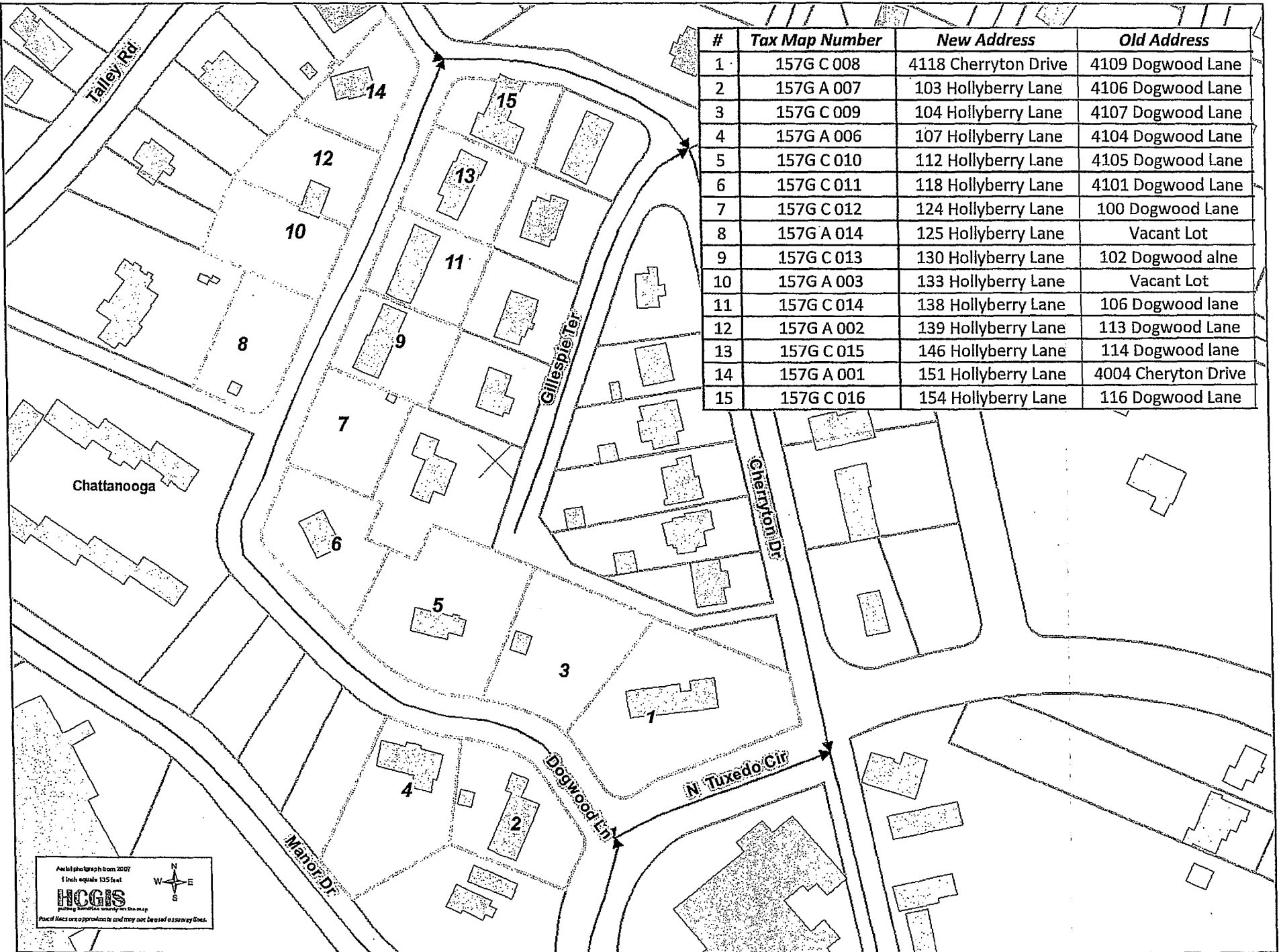
RESOLUTION NO. 25638

A RESOLUTION TO CHANGE THE RIGHT-OF-WAY NAME OF THE 4000-4199 AND 100-199 BLOCKS OF DOGWOOD LANE TO THE 100-199 BLOCK OF HOLLYBERRY LANE, AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, DUE TO DUPLICATE STREET NAME AND INCONSISTENT BLOCK RANGES ON THE STREET.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the right-of-way name of the 4000-4199 and 100-199 blocks of Dogwood Lane be and are hereby changed to the 100-199 block of Hollyberry Lane, as shown on the map attached hereto and made a part hereof by reference, due to duplicate street name and inconsistent block ranges on the street.
