A RESOLUTION AUTHORIZING THE ADMINISTRATOR FOR THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT TO EXTEND AN EXISTING MASTER SERVICES AGREEMENT WITH CIVICPLUS, INC., IN SUBSTANTIALLY THE FORM ATTACHED, FOR OPEN SPACES / OUTDOOR CHATTANOOGA AND CITY PARK RESERVATION MANAGEMENT, FOR A TERM OF TEN (10) MONTHS, FROM APRIL 25, 2021 THROUGH FEBRUARY 24, 2022.

**FIRST AMENDMENT TO MASTER SERVICES AGREEMENT**

This First Amendment to Master Services Agreement (“First Amendment”) is made and entered into as of the \_\_\_\_\_ day of \_\_\_\_\_ 2021, by and between the City of Chattanooga (“City”) and CivicPlus, Inc. (“Contractor”) (collectively, the Parties). The Parties agree as follows:

**RECITALS**

- A. The Parties entered into the Master Services Agreement dated April 25, 2018 (the “Agreement”).
- B. The Parties renewed the Agreement for an additional term of April 25, 2019 through April 24, 2020 (the “First Renewal”).
- C. The Parties renewed the Agreement for another additional term of April 25, 2020 through April 24, 2021 (the “Second Renewal”).
- D. The Parties now wish to amend the Agreement as provided herein.

**AMENDMENT**

- 1. Term. The Agreement is amended by extending the Second Renewal term for a period of ten (10) months. Such extension period shall not go past February 24, 2022.
- 2. No Other Amendments. Except as expressly amended herein, the Agreement remains in full force and effect.
