BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That it is hereby authorizing the Interim Administrator for the Department of Economic Development to apply for, and if awarded, accept a public art grant from the Lyndhurst Foundation to support the completion of the artwork "Moonrise" by artist Mark Fornes of TheVeryMany, LLC, located at the Wheland Foundry Trailhead, and to authorize the execution of the grant, in the amount of \$75,000.00, for a revised artwork contract, in substantially the form attached, with the artist in the amount of \$445,750.00.

# CITY OF CHATTANOOGA PUBLIC ART STANDARD FORM AGREEMENT

This PUBLIC ART STANDARD FORM AGREEMENT ("Agreement") governs the purchase, creation and installation of temporary and permanent works of art ("Artwork") on property owned and/or operated by the City of Chattanooga ("City"), a Tennessee Municipal Corporation.

In consideration of the mutual promises and covenants contained herein, the City and THEVERYMANY, LLC ("Artist"), as further defined herein, (collectively "Parties") agree as follows:

#### 1. Effective Date.

This Agreement is effective as of the date signed by the City.

#### 2. Governing Documents.

The following documents are Exhibits to this Agreement and incorporated herein by reference, unless otherwise indicated in writing and signed by both parties:

- a. City Purchase Order Standard Terms and Conditions (EXHIBIT A)
- b. Scope of Work/Specifications and Compensation Schedule (EXHIBIT B)
- c. Conservation Record and Maintenance Form (EXHIBIT C)
- d. Artwork Site Diagram/Drawing (EXHIBIT D)

#### 3. City Purchase Order Standard Terms.

In the event of a conflict between the terms set forth in this Agreement and the City Purchase Order Standard Terms and Conditions ("City Standard Terms"), the City Standard Terms shall prevail, unless specifically noted otherwise and agreed to by the parties in writing.

#### 4. Term.

For TEMPORARY EXHIBITS, the term of the Agreement shall be for a period of two years from the Effective Date said Agreement may be renewed for three (3) additional one (1) year terms on mutual agreement by Parties. For PERMANENT EXHIBITS, the terms of the Agreement shall terminate thirty (30) days after the City's written acceptance of the installed Artwork; but in no instance shall the Agreement extend beyond five (5) years from the Effective Date. Certain provisions shall survive the termination of the contract period, including the provisions governing Indemnification and Hold Harmless, Insurance, ID Rights and Waivers, Representations and Warranties, and Licensing.

## 5. Scope of Work.

The Artist shall prepare a Scope of Work and Compensation (**EXHIBIT B**) that shall set forth the following:

- a. Project phases and deliverables at each phase (conceptual design, final design/structural design, fabrication and installation)
- b. Project milestones and deadline for completion of each milestone
- c. Proposed site visits/meetings
- d. Costs associated with all work and expenses and an applicable payment schedule.

# 6. Work Completion and Change Orders.

Artist understands that he shall complete the work in accordance with the schedule set forth in Scope of Work, **EXHIBIT B**. Any amendments to the schedule require a written change order to be approved in writing by the appropriate City public art director. In the event so designated in the public art guidelines, the change may be approved by the public art governing body, board or committee ("Approval Body"). Any responsibilities of the City related to the design, fabrication or installation must be specifically set forth in **EXHIBIT B**, in a section entitled "City Responsibilities."

#### 7. Approval.

The Public Art Director or City designated Approval Body shall review and approve the Artwork at the designated project phases. The City's approval, through its Public Art Division or through a designated Approval Body, shall not release the Artist of the responsibility for the correction of mistakes, errors or omissions contained in the approved plans.

The Parties acknowledge that certain elements of the Art Work are to be fabricated at locations away from the designated City property ("Site"). The City reserves the right to inspect each of the elements prior to transporting to the Site and prior to installation.

## 8. Project and Site Information

As promptly as possible after the execution of this Agreement, the City shall provide background materials and information on all matters affecting the installation of the Work at the Project including plans, specifications, drawings, surveys, engineering reports and geo-technical reports as necessary for the Artist to design the Work in accordance with this contract. The Artist shall be entitled to rely on the accuracy and completeness of all information furnished by the City.

In no event shall Artist be responsible to search for, test for, investigate the presence of, monitor, remediate, abate, clean up, remove, dispose, contain, treat, detoxify or neutralize asbestos, polychlorinated biphenyls (PCB's), petroleum, other hazardous or toxic materials, radioactive material or any other pollutant within the Site. In connection with performance of Artist's services, the Artist shall be entitled to rely on

the accuracy and completeness of all site information, test results and any other data furnished by the City or the City's consultants and contractors of either of them.

## 9. Transportation and Installation.

Artist is responsible for arranging transportation and installation of the Artwork on the designated Site in consultation with the appropriate City Public Art and Public Works personnel. Artist is responsible for any costs associated with storing the Artwork in advance of the scheduled installation date.

#### 10. Licenses and Permits.

The City shall assist Artist in securing and purchasing any and all required licenses, permits and similar legal authorizations necessary for the installation of the Artwork on the Site.

The City shall inform Artist in writing of any limitations to the Artwork, during any stage of its design, fabrication or installation at the Site, imposed by zoning or environmental laws and/or regulations. Artist shall be entitled to rely on the accuracy, completeness and timely delivery of all such information.

## 11. Representations and Warranties.

Artist represents and warrants that to the best of his belief:

- a. The Artist has full power and authority to enter into this Agreement.
- b. The Artwork is solely the result of the artistic effort of Artist, and Artist is the sole creator of the Artwork.
- c. The Artwork is a unique and original creation from the Artist that has not been previously created or sold in any form (except as related to the procurement forming the basis of this Agreement).
- d. The Artist is the owner of the Artwork.
- e. The Artwork is the exclusive work of the Artist.
- f. The Artwork is free and clear of all liens.
- The Artist has free and clear right to sell the Artwork.
- h. The Artwork, or duplicate thereof, has not been accepted for sale elsewhere.
- i. The Artwork is not in the public domain.
- j. The Artwork does not infringe on the proprietary right at common law or intellectual property rights of any third party.
- k. Artist will not enter into any agreements with any other person or entity that conflict with the terms of this Agreement.

#### 12. Warranties-Quality and Condition.

Artist represents and warrants that all work will be performed in accordance with professional workmanlike standards and be free from defective or inferior materials and workmanship, including any defects consisting of inherent vice, or qualities that cause or accelerate the deterioration of the Artwork.

Artist represents and warrants that the Artwork and materials used are not currently known to be harmful to the public health and safety. Artist will accordingly provide a list of materials and substances used in the completion of the Artwork.

If within one year after acceptance of the Artwork, City observes any breach of warranty that is curable by Artist, Artist shall, at the request of the City, promptly cure any breach to the satisfaction of the City and consistent with professional conservation standards, at no cost or expense to the City. City agrees to provide reasonably prompt notice to the Artist of any breach.

The warranties described above exclude damage caused by fire, smoke, extraordinary weather conditions, natural catastrophe, abuse, vandalism, modification, improper or insufficient maintenance, improper operation, or normal wear and tear.

If within one year after acceptance of the Artwork City observes any breach of warranty described in this section that is either not curable by Artist or not timely cured by Artist and is caused by Artist's sole negligence Artist is responsible for reimbursing the City for all actual damages, expenses, and loss incurred by City as a result of the breach.

#### 13. Indemnification and Hold Harmless.

Artist, its employees, officers, contractors, and subcontractors shall indemnify (including attorney's fees) and hold harmless the City, its officials, employees, and officers, as well as Hamilton County, TN and its officials, employees, and officers (the "Indemnified Parties"), in the event of any claim, lawsuit, liability, judgment, or costs arising directly or indirectly from the Artist's negligent acts or omissions in the performance of this Agreement. Artist will have no obligation to defend, indemnify or hold harmless any Indemnified Parties to the extent that such claim, lawsuit, liability, judgment or costs are caused either by the Indemnified Parties' gross negligence or failure of the City, after it accepts and acquires ownership of the Artwork, to maintain and repair the Artwork in accordance with the Artist's General Maintenance Manual which is attached hereto as part of **EXHIBIT C** and/or are caused by the intentional and inappropriate touching, climbing or physical interaction of any third parties with the Artwork. To prevent such activities, the City shall install a sign next to the Artwork that states: "DO NOT CLIMB ON ARTWORK."

#### 14. Site Appearance.

Artist shall be responsible for maintaining the Site in a neat manner. Artist shall be responsible for any clean-up of the Site made necessary by the installation of the Artwork, including removal of equipment, materials and the repair of any portion of the Site or surrounding area damaged by the installation of the Artwork, excluding landscaped areas and any soft scape.

#### 15. Insurance.

During the term of this Agreement Artist shall, at its sole expense, obtain and maintain in full force and effect for the duration of the Agreement and any extension hereof and produce a Certificate of Insurance with insurance coverage levels as set forth in the City Standard Terms, **EXHIBIT A**.

#### 16. Acceptance.

City shall require written notice of final acceptance of the Artwork by the City. Until the point of Substantial Completion, any injury to persons or property caused by the Artist's Artwork or any damage to, theft of, complete destruction of the Artist's Artwork are the sole responsibility of the Artist.

#### 17. Final Inspection.

Final inspection of the Artwork shall be conducted by the City within fifteen (15) days of receiving written notice from the Artist of the substantially completed installation.

#### 18. Documentation.

Prior to receipt of final payment, Artist shall provide photographic documentation of the Artwork as detailed in Exhibit B, including: a written narrative description of the Artwork.

# 19. Copyright, Trademark, Service Mark and Infringement of Third Party Intellectual Property Rights.

Artist shall, at its own expense defend any suit which may be brought against the City to the extent it is based on a claim that the Artwork infringes upon the intellectual property rights of a third party.

Artist shall further indemnify and hold harmless the City against any award of damages and costs made against City by a final judgment of a court of last resort in any such suit.

All copyright and further reproduction rights to the Artwork remain with the Artist.

City shall provide the Artist immediate notice in writing of the existence of any such claim and give the Artist the full right and opportunity to conduct the defense thereof, together with all available information and reasonable cooperation, assistance and authority to enable Artist to do so.

City reserves the right to participate in the defense of any such action.

Artist shall have the right to enter into negotiations for and to effect settlement or compromise of any such action, but no such settlement or compromise shall be binding upon City unless approved by the City consistent with the requirements set forth in Chattanooga City Code. The provisions of this section 19. shall survive termination of this Agreement.

#### 20. License.

Artist grants a perpetual license to the City for the use of the Artwork for educational, community, and other non-commercial uses. In the event the City wishes to use the Artwork for commercial purposes, the Artist agrees to negotiate in good faith to enter into a separate agreement governing the use of the Artwork for commercial purposes.

# 21. Intellectual Property: Rights and Waivers.

#### a. Ownership.

Any artwork created for permanent installation under this Agreement shall be the property of the City. Ownership of the Artwork shall be transferred from the Artist to the City upon written final acceptance by the City. Upon final acceptance, City shall have a right to retain all plans, drawings, sketches and designs of the Artist pertaining to the Artwork and previously issued by Artist for maintenance, repair and historical documentation purposes only, unless otherwise specified herein. All material samples and mock-ups will remain property of the Artist. Upon substantial completion, Artist shall submit maintenance guidelines to the City.

#### b. Copyright.

Artist retains all intellectual property rights including, without limitation, copyrights. Artist may register the Artwork in his or her name with the U.S. Register of Copyrights at no additional cost to the City.

#### c. Reproductions.

Artist shall not create or display full-scale three-dimensional reproductions of the Artwork at any location other than the City Site without the City's permission, which shall not be unreasonably withheld or delayed), nor shall Artist grant permission for others to create or display full-scale three-dimensional reproductions, except with written permission of the City.

The Artist has the right to publicize the Work and its location in Artist's promotional, publicity and marketing materials, lectures and presentations. Artist shall be given reasonable access to the completed project and/or City's photographs and renderings to make such presentations.

# d. Exclusive License for Non-Commercial Reproductions.

Artist grants City the exclusive right to publicly display and reproduce images of the Work by photographic, electronic, digital, mechanical, or any other method that may become available following the installation of the Artwork for educational, procurement, public relations, arts promotional, tourism, and other non-commercial purposes. On any such reproductions, City will acknowledge Artist's authorship and provide copyright notification substantially in the following form: "Copyright [or ©] 20\_\_\_ MARC FORNES / THEVERYMANY. All rights reserved." and date of publication. In the event City wishes to use the Artwork for commercial purposes, City shall contact the Artist to negotiate a separate agreement.

Notwithstanding anything to the contrary in this Article 20, this Agreement, or any other agreements relating to the Artwork, the City's license as denoted herein does not include or extend to the City's grant of a license or permission in any form whatsoever to any contractors, subcontractors, fabricators, consultants or other Project participants to make or use any photographs, drawings, films,

videos or any other graphic or visual representation of the Artwork. In this regard, the City may not grant any such license or permission unless it obtains the Artist's prior written consent.

#### e. Publicity.

City shall have the right to use the Artist's name, likeness, and connection with the display or reproduction and distribution of the Artwork.

#### f. Credits.

Artist agrees that any reproduction made by Artist for publicity purposes shall refer to the City of Chattanooga's Public Art Division as "Public Art Chattanooga." City shall have the right to review and approve press releases generated by Artist or Artist's sub-contractors regarding the Artwork until the Artwork has been publicly dedicated and final acceptance has been issued.

Artist grants City permission to use his or her likeness in photograph, video or digital reproduction, for purposes of promoting the Artwork.

# g. Publication of Artists Instrument of Services / Fees.

All design documents, models, calculations, information and other for this project, in physical and/or electronic form, are "Instruments of Service". Unless required by law in response to a specific request, the City shall not publish or make available to the general public Artists "Instruments of Service", as defined in this Agreement. However, City shall not make public any information relating to Artist's proprietary information including, without limitation, means and methods of modeling, fabrication and installation and names of subcontractors/subconsultants retained by Artist or Artist's fee (inclusive of fees and costs for subcontractors, subconsultants, fabricators, transportation of Artwork and installers). Notwithstanding, the City shall at all times remain in compliance with relevant public records disclosure requirements in local, state, and federal law.

# 22. Maintenance, Repair or Restoration.

The Artist acknowledges that the Artwork must be durable, with due consideration given to the outdoor nature of the Artwork and its subsequent exposure to elements such as weather, temperature variation, and considerable movement of people and equipment. Artist must ensure that the Artwork's maintenance requirements will be reasonable in terms of time and expense.

With respect to any cleaning, maintenance, repair or restoration of the Artwork, Artist shall be consulted if possible if the need for repair or restoration arises. City will send written notice to the Artist at least thirty (30) days prior to the commencement of any repair and restoration work.

Artist understands that the Artist's participation shall be at no cost to the City. The nature of the repair shall not significantly alter the original appearance of the Artwork and shall be consistent with the Artist's repair instructions. The Artist shall not be responsible for bearing any costs associated with the

maintenance, repair or restoration of the Artwork for damage or deterioration to the Artwork that occurs at a point after the City's final written acceptance of the Artwork.

The City shall maintain the Artwork pursuant to the instructions provided by Artist and submitted by Artist on the Conservation Record and Maintenance Form attached hereto as **EXHIBIT C** and incorporated herein by reference.

Artist shall take reasonable measures to protect or preserve the integrity of the Artwork.

Artist warrants the foreseeable exposure to the elements and general wear and tear will not cause the Artwork to fall below an acceptable standard of public display.

Prior to receipt of final payment, Artist shall provide a maintenance manual with a description of all materials, products and fabrication methods used in the Artwork and the required care and upkeep involved, including: (i) product data sheets for any material or finish used; (ii) the names and contact information of relevant manufacturers or producers; and, (iii) to the extent the Artwork incorporates products covered by a manufacturer's warranty, Artist shall provide copies of such warranties. Artist warrants the responsible maintenance of the Artwork will not require procedures substantially in excess of those described in the recommended maintenance manual.

Repairs and restoration of the Artwork, if any, are to be distinguished from maintenance of the Artwork, as addressed above. City shall determine when and how repairs and restoration to the Artwork will be made. However, at no cost to City whatsoever, and to the extent practicable, Artist will have the opportunity to comment on and participate in all repairs and restoration that are made during the Artist's lifetime. City will give written notice to the Artist prior to undertaking repairs or restoration of the Artwork, and Artist will have 30 days from the date that the notice is sent by City to advise City, as specified in the notice, of Artist's wish to so comment and/or participate. Notice will only be sent by City to the address provided by Artist as set forth in **EXHIBIT A**. Artist is responsible for keeping City advised of Artist's current mailing address. Artist understands that City's repairs and restoration of the Artwork will be limited and determined in significant part by funding decisions of the City Council and other officials and departments. **The provisions of this section shall survive termination of this Agreement.** 

#### 23. Deaccessioning.

The Artist agrees and acknowledges that should deaccessioning of the Artwork become necessary at any point the City shall proceed with deaccessioning pursuant to the guidelines as may be established by the City's Public Art division or as may be established by an Approval Body.

#### 24. Resiting.

City intends that the Artwork shall remain in its designated site as set forth in the drawing attached hereto as **Exhibit D** and incorporated herein by reference; however, City reserves the right to relocate the Work. Upon resiting Artist shall be released of any liabilities.

# 25. Waiver of Consequential Damages.

City and Artist waive consequential damages for claims, disputes or other matters in question arising out of or relating to the services provided pursuant to this Project including, without limitation, claims relating to: loss of use; loss of profit; claims for delay impact or disruption; operational costs; market value and revenue; tax incentives/credits and rebates; insurance premiums; and project and/or City reputation. This mutual waiver is applicable, without limitation, to all consequential damages due to either party's termination.

#### 26. Attorney Fees.

The Parties agree that in the event either party takes legal action to enforce any provision of the contract or to obtain a remedy for any breach of the contract, the non-prevailing party shall pay all expenses of such action incurred at any and all stages of the litigation, including costs, and reasonable attorney fees for the prevailing party.

# 27. Death or Incapacity of Artist.

In the event of Artist's physical incapacity or death prior to the completion of the Artwork, all payments made up to the point of incapacity or death will be reasonably compensated. Upon payment to compensate Artist or Artist's estate for all work performed to the date of incapacity or death, the incomplete Artwork and any material paid for by City will become the property of City. However, if the Artwork is substantially designed and/or completed and it is feasible for the work to be fully completed without undue delay, City may elect to proceed under the terms of this Agreement and hereby has the consent of the Artist to proceed. In the event the City elects to proceed with the completion of the Artwork, all remaining work to be completed in accordance with this Agreement will be delegated to:

#### 28. Venue.

Any action between the parties arising from this agreement shall be maintained in the courts of Hamilton County, Tennessee.

#### 29. Compensation.

The pricing details are demonstrated in **EXHIBIT B**. Artist shall be paid as work is completed and City is accordingly invoiced based as milestones as set forth in **EXHIBIT B** are completed and approved by City.

There will be no other charges or fees for performance under this Agreement. City will make payments within thirty (30) days of receipt of invoice.

Should payment be delayed past thirty (30) days of receipt of invoice, Artist shall be entitled to hold all work until payment has been received. Artist shall not be responsible for schedule delays, additional fees or any other damages due to City's late payment of Artist's invoice.

#### 30. Taxes.

City shall not be responsible for any taxes that are imposed on Artist. Furthermore, Artist understands that it cannot claim exemption from taxes by virtue of any exemption that is provided to City.

## 31. Governing Law.

The validity, construction and effect of this Agreement and any and all extensions and/or modifications thereof shall be governed by the laws of the State of Tennessee. Tennessee law shall govern regardless of any language in any attachment or other document that the Artist may provide.

#### 32. Termination.

Breach. Should Artist fail to fulfill, in a timely and proper manner, its obligations under this Agreement, or if it should violate any of the terms of this Agreement, City shall have the right to immediately terminate the Agreement. Such termination shall not relieve Artist of any Liability to City for damages sustained by virtue of any breach by Artist.

Notice by City. City may terminate this Agreement at any time upon thirty (30) days written notice to Artist and a reasonable opportunity to cure. If the breach is remedied or reasonable steps to cure are initiated within the cure period, then the notice of termination shall be deemed withdrawn. If the breach can't be remedied, the City shall pay Artist all fees and costs incurred up to and including the date of Termination and said payment shall be made by City no later than thirty (30) days from the date of Termination. In addition, Artist shall be entitled to retain all payments made by City prior to the date of Termination.

Lack of Funding. Should funding for this Artwork be discontinued, City shall have the right to terminate the Agreement immediately upon written notice to Artist. However, any de-funding or failure to appropriate funds to the Project after the Artist has performed all or any part of its services pursuant to this Agreement, including but not limited to any services performed by Artist prior to the effective date of this Agreement, shall in no way abrogate, diminish or otherwise relieve the City from its obligation to compensate Artist for services rendered and reimbursable expenses incurred prior thereto.

# 33. City Property.

Any City property that is in Artist's possession shall be maintained by Artist in good condition and repair, and shall be returned to City by Artist upon termination of the Agreement. All goods, documents,

records, and other work product and property produced during the performance to this Agreement are deemed to be City property.

Breach of the provisions of the paragraph is, in addition to a breach of this contract, a breach of ethical standards which may result in civil or criminal sanction and/or debarment or suspension from being an Artist or subcontractor Artist under City contracts.

The Parties have read and understand the terms set forth herein. By signing this Agreement, the Parties affirm they have the authority to enter into this legally binding Agreement on behalf of the Parties hereto.

# **EXHIBIT A**CITY PURCHASE ORDER STANDARD TERMS AND CONDITIONS

- 1. ACCEPTANCE-AGREEMENT. Artist's commencement of work on the goods/non-professional services subject to the purchase order or shipment/performance of those goods/non-professional services, whichever occurs first, is considered an effective mode of Artist's acceptance of this purchase order. Any acceptance of the purchase order is limited to acceptance of the express terms contained on the face of the purchase order and these terms and conditions. Any proposal for additional or different terms or any attempt by Artist to vary in any degree any of the terms of this offer unless the variances are in the terms of the description, quantity, price or delivery schedule of the goods/non-professional services, but are considered a material alteration, and this offer will be considered accepted by Artist without additional or different terms. Additional or different terms or any attempt by Artist to vary in any degree any of the terms of this purchase order are considered material and are objected to and rejected, but the purchase order does not operate as a rejection of the Artist's offer unless it contains variances in the terms of the description, quantity, price or delivery schedule of the goods/non-professional services.
- 2. **GOVERNING LAW.** This Agreement shall be governed by the laws of the State of Tennessee and the Codes of the City of Chattanooga ("City").
- 3. **COMPENSATION AND PAYMENT TERMS.** For the completion of the Work, City shall pay Artist the contract sum set forth in the purchase order. Payments shall be made in amounts which are consistent with percentage of goods/non-professional services completed and invoiced by the Artist as set forth in the purchase order.

The City's delivered payment terms are payment within thirty (30) days except where the law provides otherwise. Payment may be sooner where cash discounts are offered for early payment, however, cash discounts offered will not be considered in determining lowest bidder. In no event will payment be made prior to receipt of an original invoice containing invoice and purchase order numbers and receipt of purchased item(s). The City is not liable for delays in payment caused by failure of the Artist to send invoice to the address referenced herein.

- 4. **INSPECTION/TESTING.** Payment for the goods delivered does not constitute acceptance of the goods. City has the right to inspect the goods and to reject any or all of the goods which are in City's judgment defective or nonconforming. Goods rejected and goods supplied in excess of quantities called for may be returned to Artist at its expense and in addition to City's other rights. City may charge Artist all expenses of unpacking, examining, repacking and reshipping those goods. In the event City receives goods whose defects or nonconformity is not apparent on examination, City reserves the right to require replacement. Nothing contained in this purchase order will relieve in any way the Artist from the obligation of testing, inspection and quality control.
- 5. **PRICE WARRANTY.** Artist warrants that the prices for the goods or nonprofessional services sold City are not less favorable than those currently extended to any other customer for the same or similar goods or nonprofessional services in similar quantities. In the event Artist reduces its price for the goods or nonprofessional services during the term of this purchase order, Artist agrees to reduce the prices charged to City correspondingly. Artist warrants that prices shown on this purchase order are complete, and no additional charges of any type will be added without City's express written consent. Any additional charges include, but are not limited to, shipping, packaging, labeling, custom duties, taxes, storage, insurance, boxing, crating.
- 6. **STANDARD OF CARE.** Artist shall exercise the same degree of care, skill, and diligence in the performance of services as is ordinarily possessed and exercised by an Artist under similar circumstances in the same area of practice. Artist makes no warranty or guarantee, either expressed or implied, as part of this agreement.

- 7. **INDEMNIFICATION.** Artist, its employees, officers, contractors, and subcontractors shall indemnify (including attorney's fees) and hold harmless the City, its officials, employees, and officers, as well as Hamilton County, TN and its officials, employees, and officers (the "Indemnified Parties"), in the event of any claim, lawsuit, liability, judgment, or costs arising directly negligent acts or omissions in the performance of this Agreement. Artist will have no obligation to defend, indemnify or hold harmless any Indemnified Parties to the extent that such claim, lawsuit, liability, judgment or costs are caused either by the Indemnified Parties' gross negligence or failure of the City, after it accepts and acquires ownership of the Artwork, to maintain and repair the Artwork in accordance with the Artist's General Maintenance Manual which is attached hereto as part of **EXHIBIT C** and/or are caused by the intentional and inappropriate touching, climbing or physical interaction of any third parties with the Artwork. To prevent such activities, the City shall install a sign next to the Artwork that states: "DO NOT CLIMB ON ARTWORK."
- 8. **INSURANCE.** Artist shall purchase and maintain during the life of this Agreement, insurance coverage which will satisfactorily insure Artist against claims and liabilities which arise because of the execution of this Agreement, with the minimum insurance coverage as follows:
- a. Commercial General Liability Insurance, with a limit of \$1,000,000 for each occurrence and \$2,000,000 in the general aggregate.
- b. Worker's Compensation Insurance and Employer's Liability Insurance, in accordance with statutory requirements, with a limit of \$500,000 for each accident.

If any of the above cited policies expire during the life of this responsibility to forward renewal Certificates within ten (10) days after the renewal date containing all the aforementioned insurance provisions. Certificates must specifically cite the following provisions:

- City of Chattanooga, its agents, representatives, officers, directors, officials and employees must be named an Additional Insured under the following policies:
  - a) Commercial General Liability
  - b) Worker's Compensation Insurance and Employer's Liability Insurance
- Artist's insurance must be primary insurance as respects performance of subject contract.
- iii. All policies, except Professional Liability Insurance, if applicable, waives rights of recovery (subrogation) against City of Chattanooga, its agents, representatives, officers, directors, officials and employees for any claims arising out of work or services performed by Artist under this Agreement.
- 9. **LIMITATIONS OF RESPONSIBILITY.** In no event is City liable for anticipated profits or for incidental or consequential damages. City's liability on any claim of any kind for any loss or damage arising out of or in connection with or resulting from this Agreement or from the performance or breach of this Agreement will in no case exceed the unit price allocable to the goods or nonprofessional services which gives rise to the claim. City is not liable for penalties of any description. Any action resulting from any breach of this Agreement by City as to the goods or nonprofessional services delivered must be commenced within one (1) year after the cause of action has accrued.

To the fullest extent permitted by law, the total liability, in the aggregate, of Artist and Artist's officers, directors, employees, agents, and independent professional associates, subcontractors, and any of them, to, City and any one claiming by, through or under City, for liability arising out of or in any way related to

Artist's Services, the Project, the Artwork, or this Agreement, shall not exceed the total compensation received by Artist under this Agreement.

- 10. **PROPRIETARY INFORMATION-CONFIDENTIALITY-ADVERTISING.** Contactor must consider all information furnished by City to be confidential and not disclose any information to any other person, or use the information itself for any purpose other than performing this Agreement, unless Artist obtains written permission from City to do so. This paragraph applies to drawings, specifications, or other documents prepared by Artist for City in connection with this Agreement. Contractor must not advertise or publish the fact that City has contracted to purchase goods from Contractor without City's written permission, nor is any information relating to the order to be disclosed without City's written permission. City agrees that commercial, financial or technical information disclosed in any manner or at any time by Artist to City is to be confidential, unless otherwise agreed in writing, or unless disclosure of such commercial, financial or technical information is required by local, state, or federal public records laws.
- 11. **RECORDS RETENTION AND AUDIT.** The term "Contractor" is used interchangeably to describe signatories to contracts, grants, and agreements with the City and applies to reflect the relationship with the City (Engineer, Contractor, Licensee, Supplier, Vendor, Contractor, Grant Recipient, etc.)
- a. All records relating in any manner whatsoever to the Project, or any designated portion thereof, which are in the possession of the Artist, or any of the Artist's independent contractors, associates, and/or subcontractors, shall be made available for inspection and copying upon written request to the City. Additionally, said records shall be made available upon request by the City to any state, federal or other regulatory authorities and any such authority may review, inspect and copy such records. Said records include, but are not limited to, all plans, specifications, submittals, correspondence, minutes, memoranda, tape recordings, videos, or other writings or things which document the Project, its design, and its construction. Said records expressly include those documents reflecting the time expended by the Artist and its personnel to perform the obligations of this Agreement, and the records of expenses incurred by the Artist in its performance under said Agreement. The Artist shall maintain and protect these records for no less than seven (7) years after the completion of the Project, or for any longer period of time as may be required by applicable law, good professional practice, and upon notice during the pendency of any claims or litigation arising from the Project.
- b. The City, or its assigns, may audit all financial and related records (including digital) associated with the terms of the contract or agreement, including timesheets, reimbursable out of pocket expenses, materials, goods and equipment claimed by the Artist. The City may further audit any of the Artist's records to conduct performance audits (to identify waste and abuse or to determine efficiency and effectiveness of the contract or agreement), or to identify conflicts of interest.
- c. The Artist shall at all times during the term of the contract or agreement, and for a period of seven (7) years after the end of the contract, keep and maintain records of the work performed pursuant to this contract or agreement. This shall include proper records of quotations, contracts, correspondence, invoices, vouchers, timesheets, and other documents that support actions taken by the Artist. Documents shall be maintained by the Artist, which are necessary to clearly reflect all work and actions taken. All such records shall be maintained in accordance with general accepted accounting principles. The Artist shall, at its own expense, make such records available for inspection and audit (including copies and extracts of records as required) by the City at all reasonable times and without prior notice.
- d. The obligations of this Section shall be explicitly included in any subcontracts or agreements formed between the Artist and any subcontractors or suppliers of goods or nonprofessional services to the extent that those subcontracts or agreements relate to fulfillment of the Artist's obligations to the City.

- e. Costs of any audits conducted under the authority of this section and not addressed elsewhere will be borne by the City, unless the audit identifies significant findings that would benefit the City. The Artist will reimburse the City for the total costs of an audit that identifies significant findings that would benefit the City.
- f. This Section shall not be construed to limit, revoke, or abridge any other rights, powers, or obligations relating to audit which the City may have by Federal, State, or Municipal law, whether those rights, powers, or obligations are express or implied.
- 12. **TERMINATION FOR CONVENIENCE.** City reserves the right to terminate this order or any part of this order at its sole convenience with thirty (30) days written notice. In the event of termination, Artist must immediately stop all work and immediately cause any of its suppliers or subcontractors to cease any further work. Artist will be paid a reasonable termination charge consisting of a percentage of the order price reflecting the percentage of the work performed before the notice of termination, plus actual direct costs resulting from termination. In addition, Artist shall be any work done after receipt of the notice of termination, nor for any costs incurred by Artist's suppliers or subcontractors which Artist could reasonably have avoided. Artist must not unreasonably anticipate the requirements of this order.
- 13. **TERMINATION FOR CAUSE**. City may also cancel this order, or any part of this order, with seven (7) days written notice for cause in the event of any default by Artist, or if Artist fails to comply with any of the terms and conditions of this offer. Late deliveries, deliveries of products which are defective or which do not conform to this order, and failure to provide City, upon request, with adequate assurances of future performance are all causes allowing City to cancel this order for cause. In the event of cancellation for cause, City is not liable to Artist for any amount, and Artist is liable to City for any and all actual damages sustained by reason of the default which gave rise to the cancellation If it should be determined that City has improperly cancelled this contract for a default, the cancellation is considered a termination for convenience.
- 14. **DISPUTE RESOLUTION.** Claims, disputes, or other matters in question between the parties to this Agreement arising out of or relating to this Agreement, or breach thereof, shall be subject to mediation in Chattanooga, Tennessee, in accordance with the following provisions:
  - The mediation shall be conducted by a mediator mutually acceptable to both parties.
  - b. The parties agree to share equally in the expense of the mediation.
  - c. Such mediation may include the Artist or any other person or entity who may be affected by the subject matter of the dispute.
  - d. Unless the parties agree otherwise, mediation shall be a condition precedent to the exercise of any legal remedy other than a proceeding seeking an immediate injunction or restraining order to protect the rights of a party pending litigation. Notwithstanding the issuance of an injunction or restraining order, or the refusal of a court to issue such an order, the dispute shall continue to be subject to mediation.
- Agreement for delays in performance caused by circumstances beyond the reasonable control of the nonconforming party. For purposes of this Agreement, such circumstances include abnormal weather conditions; floods; earthquakes; fire; epidemics; war, riots, or other civil disturbances; sabotage and vandalism; judicial restraint; discovery of unanticipated hazardous wastes; and inability to procure permits, licenses, or authorizations from any local, state, or federal agency for any of the supplies, materials, accesses, or services required to be provided by either City or Artist under this Agreement. Should such circumstances occur, the nonconforming party shall, within a reasonable time of being prevented from performing, give written notice to the other party describing the circumstances preventing continued performance and the efforts being made to resume performance of the Agreement. If the Artist is delayed in the performance of

the services for more than three hundred sixty-five (365) calendar days, either by the City or circumstances beyond his control, an equitable adjustment to the contract amount can be made to compensate for additional costs incurred.

For delays in performance by Artist caused by circumstances which are within its control, such delays shall be documented and presented to the Purchasing Department at the conclusion of Project and acknowledged by both City and Artist. Completed form shall be retained by City for a period of seven years and reviewed prior to Artist selection for future City projects. In the event Artist is delayed in the performance of Services because of delays caused by City, Artist shall have no claim against City for damages or contract adjustment other than an extension of time.

16. HAZARDOUS MATERIALS. Hazardous materials may exist at a site where there is no reason to believe they could or should be present. The City and Artist agree that the discovery of unanticipated hazardous materials constitutes a changed condition mandating a renegotiation of the scope of work or termination of services. City and Artist also agree that the discovery of unanticipated hazardous materials may make it necessary for the Artist to take immediate measures to protect health and safety. City agrees to compensate Artist for any equipment decontamination or other costs incident to the discovery of unanticipated hazardous materials.

Artist agrees to notify City when unanticipated hazardous materials or suspected hazardous materials are encountered. City agrees to make any disclosures required by law to the appropriate governing agencies, and agrees to hold Artist harmless for any and all consequences of disclosures made by Artist which are required by governing law. In the event the project site is not owned by City, the City agrees to inform the City of the discovery of unanticipated hazardous materials or suspected hazardous materials.

17. **COMMUNICATIONS.** Any notice to the City shall be made in writing to the address specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of Artist and City.

- 18. WAIVER. A waiver by either City or Artist of any breach of this Agreement shall be in writing. City's failure to insist on performance of any of the terms or conditions of this purchase order or to exercise any right or privilege, or City's waiver of any breach does not waive any other terms, conditions, or privileges, whether of the same or similar type
- 19. **SEVERABILITY.** The invalidity, illegality, or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of this Agreement shall be construed and enforced as if this Agreement did not contain the particular portion or provision held to be void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.
- 20. **INTEGRATION.** This Agreement represents the entire and integrated agreement between City and Artist. All prior and contemporaneous communications, representations, and agreements by Artist, whether oral or written, relating to the subject matter of this Agreement, as set forth in the Purchase Order, are hereby incorporated into and shall become a part of this Agreement.

- 21. SUCCESSORS AND ASSIGNS. City and Artist each binds itself and its directors, officers, partners, successors, executors, administrators, assigns, and legal representatives to the other party of this Agreement and to the directors, officers, partners, successors, executors, administrators, assigns, and legal representatives of such other party in respect to all provisions of this Agreement.
- 22. **ASSIGNMENT.** Neither City nor Artist shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement. Nothing contained in this Article shall prevent Artist from employing independent Contractors, associates, and subcontractors to assist in the performance of the Services; however, other agreements to the contrary notwithstanding, in the event Artist employs independent Contractors, associates, and subcontractors to assist in performance of the Services, Artist shall be solely responsible for the negligent performance of the independent Contractors, associates, and subcontractors so employed.
- 23. **THIRD PARTY RIGHTS.** Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than City and Artist.
- 24. **RELATIONSHIP OF PARTIES.** Nothing contained herein shall be construed to hold or to make the City a partner, joint venturer, or associate of Artist, nor shall either party be deemed the agent of the other, it being expressly understood and agreed that the relationship between the parties is and shall at all times remain contractual as provided by the terms and conditions of this Agreement.
- 25. **NON-DISCLOSURE.** Artist agrees not to disclose or to permit designated by the City as confidential, except to the Artist's employees associates, and subcontractors who require such information to perform the services specified in this agreement.
- 26. NON-DISCRIMINATION. Artist agrees to comply with all discrimination laws and regulations. Artist agrees not to discriminate against any participant in this Agreement on the basis of race, color, religion, sex, age or national origin. Artist further agrees to comply with all federal, state and local laws regarding treatment and accommodations for individuals with disabilities.
- 27. **DRUG FREE WORKFORCE.** Artist certifies that it will provide a drug-free workplace and agrees to comply with the applicable requirements of the Drug-Free Workplace Act of 1988.
- 28. **COMPLIANCE WITH LAWS.** The City has entered into this agreement with Artist relying on is knowledge and expertise to provide the services contracted for. As part of that reliance, Artist represents that he knows and understands the relevant and applicable federal and state laws that apply to the services provided through this contract, and agrees to comply with these relevant and applicable federal and state law. The Artist understands and acknowledges the applicability to it of the American with Disabilities Act, the Immigration Reform and Control Act of 1986, and the Drug Free Workplace Act of 1988.

- 1. <u>SCHEMATIC DESIGN:</u> Upon the execution of this Agreement and receipt of first payment Artist shall prepare a Schematic Design proposal. As part of this phase Artist shall:
- a.) Review current site plans, surveys, data and drawings provided by the City.
- b.) Schematic Design proposal
- c.) 3D modelling and 3D renderings of the Artwork Schematic Design.
- d.) Concept color studies if applicable and provide 3D renderings.
- 2. **DESIGN DEVELOPMENT**: Upon City's written approval of the Schematic Design and receipt of payment Artist shall proceed with Design Development. As part of this phase Artist shall:
- a.) Further development of the 3D geometry, and 3D renderings.
- b.) Advance color studies if applicable and provide 3D renderings.
- c.) Coordinate with structural engineer for preliminary structural design and engineering analysis.
- d.) A preliminary schedule.
- e.) Coordination with City and submission of Design Development Documents.

- 3. FABRICATION FILES: Upon City's written approval of the Design Development and receipt of payment the Artist shall proceed to Fabrication Files. As part of this phase Artist shall:
- a.) Produce and export fabrication files.
- b.) Coordinate with structural engineers.
- c.) Final structural engineering and provide signed and sealed structural engineering report.
- d.) Update estimated fabrication schedule.
- 4. 100% FABRICATION: Upon receipt of payment Artist shall proceed with the fabrication of the Artwork. Deliverables for this phase shall include:
- a.) Laser cutting and parts processing 100% complete.
- b.) All parts folded, if required.
- c.) Coating 100% complete.
- d.) All parts sorted.
- e.) Photo documentation that 100% of the off-site fabrication is complete and that the work has been crated and is ready to ship.
- 5. **INSTALLATION AND SUBSTANTIAL COMPLETION:** Upon receipt of payment Artist shall proceed with the Installation of the Artwork on Site. Deliverables for this phase shall include:

# GENERAL MAINTENANCE MANUAL / 24<sup>TH</sup> July, 2019

# RECOMMENDATION FOR GENERAL UPKEEP / MAINTENANCE:

DO:

- Min. twice annually cleaning with a neutral cleaning agent (pH between 5-8) such as water diluted dish washing liquid or a bleach water mix of 5% bleach & 95% water. Apply using a non-abrasive cleaning cloth or sponge without scouring pad. Rinse with clear water from a standard hose NO power-wash - and dry with a soft and absorbent microfiber cloth.
- Monitoring and twice annual inspection and maintenance as required.

#### DON'T:

- DON'T use abrasive cleaning and polishing agents.
- DON'T use abrasive cleaning agents, such as acid based cleaners for glass may result in damage such as spots or more widespread marking to the coated surface.
- DON'T use organic solvents for cleaning or preservation.
- DON'T use power wash tools or high air pressure.
