SECOND AMENDMENT TO OFFICE LEASE

THIS SECOND AMENDMENT TO OFFICE LEASE (the "Second Amendment") is made and entered as of the _____ day of _____, 202___ by and between THE CITY OF CHATTANOOGA, TENNESSEE and HAMILTON COUNTY MENTAL HEALTH COURT (collectively, the "Parties")

WITNESSETH:

WHEREAS, the Parties entered into an Office Lease with an Effective Date of July 1, 2019 (the "Lease"); and

WHEREAS, the Parties entered into a First Agreement to Exercise Option to Renew dated June 15, 2021; and

WHEREAS, the Parties entered into a First Amendment to Office Lease dated June 29, 2022;

WHEREAS, the Parties desire to amend the Lease;

NOW THEREFORE, for and in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. <u>Amendment to Lease</u>. The Lease is amended as follows:

Section 1, definition of **"Premises"** is hereby deleted in its entirety and replaced with the following:

"Premises" means the approximately 368 rentable square feet comprising the entire Tenant space in the Building, as shown on the premises floor plan attached as **Exhibit A** and incorporated herein by reference.

2. <u>Miscellaneous</u>. Except as specifically set forth in this Second Amendment the Lease remains unchanged and in full force and effect. Capitalized terms used but not defined in this Agreement shall have the meanings set forth in the Lease. This Second Amendment may be executed in one or more counterparts, all of which when taken together shall constitute a single instrument; provided however, that this Second Amendment shall not be effective until signed by the Parties. Facsimile or other electronic signatures shall be deemed originals.




