On 03/30/2021 at 14:00 hours, Officer Adam Krystaponis (75508) responded to a Fraud at 5821Lee Hwy. I was contacted outside of my regular shift by one of the employees at JM Pawn Broker at 5821Lee Hwy. Ms. Sheila Bingham had contacted me about some suspicious activity, so I went there to investigate. Upon arrival, I spoke with Ms. Sheila Bingham. Ms. Bingham stated that on 3/26 at approximately 15:00, a younger black male came in and sold her a rifle. Ms. Bingham stated he sold her a FN Scar 17S rifle, in flat dark earth color, with a S/N: H0C22924. Ms. Bingham stated that as part of the sale, he provided an ID in the name of Charles Cornett, with a picture on the ID tht appeared to match the individual (though he was wearing a medical mask). Ms. Bingham stated this same male came back approximately 30 minutes later, offering to sell the 5 magazines that went with the rifle. When she asked for his name to find the earlier sale, he stated his name was "Durm". When Ms. Bingham could not find any transaction with that name, this suspect provided a TN ID in the name of Jacob Durm (with the same picture as before, also matching the suspect). Ms. Bingham stated she called out this suspect on using fake IDs, and he left the store without gathering either his ID (in the name of Jacob Durm), or the magazines he was trying to sell. Ms. Bingham provided me with a picture of the first ID he provided, the actual ID he used 2nd, and a blurry picture taken by the store camera.

Upon running the serial number of the gun through INFO channel, it has not at this time been reported stolen. The first ID, in the name of Charles Cornett, had all of Mr. Cornett's information except a false ID number of which does not come back. Also the picture did not match the picture for Mr. Cornett in the state's system. The second ID had the same picture as the first, and all of the information on it came back to Mr. Jacob Durm, again except for the ID number of which did not come back. This second ID was turned into property, and a close photo of the ID picture is attached to this report. The phone number did not come back to anyone I could find, including Coplink. While I was speaking with Ms. Bingham, SA Saint-Louis with the ATF arrived on scene, and requested my original complaint to further investigate.

At this time, the firearm does not appear to be stolen or otherwise involved in a crime, it was left with Ms. Bingham. She stated she has to (by law) hold it for at least 30 days prior to doing anything else, so she stated she would package the magazines in paper bags if we later wanted to try to print them, and she would hold the firearm until she was told it was ok to sell it later. Without further identification of this suspect, charges will be pending.
