On 10/01/2018 at 2030 hours, Officer Brelsford (77566) a short time after Officer Blevins attempted to stop a black Ford Fusion with a partial tag of 4G, I, Officer Brelsford observed a dark-colored Ford Fusion with the tag 4G55R3 at the 4700 block of Brainerd Rd. The vehicle matched the description of the vehicle that had evaded Officer Blevins and was headed in the last known direction as the suspect vehicle. I observed the vehicle pull into the Mapco gas station at 4711 Brainerd Rd. When I pulled in the parking lot the vehicle immediately started to accelerate out of the parking and back into traffic on Brainerd Rd. At that point, I initiated my blue lights and stopped the vehicle in the turn lane on Brainerd Rd. Being that the vehicle stopped matched the description given of the suspect vehicle, had matching numerics as the partial tag, the suspect vehicle was coming from a high crime area, and the identity of the occupants was unknown; a felony stop was performed. I along with several other officers, first called back the driver of the vehicle and then passenger detaining them until it could be either confirmed or denied as the suspect vehicle. The driver was identified as Mike Wofford and passenger as Ruby James. It was quickly determined that Mr. Wofford and Ms. James were not the suspects that had evaded Officer Blevins. Officers on the scene explained what had occurred and why he had been stopped. When questioned why he immediately pulled out of the gas station after seeing police Mr. Wofford stated "I had been smokin" and I didn't want to have smoke coming out the windows when he got stopped. This statement meaning that he had been smoking marijuana. Officers explained the misunderstanding and misidentification of the vehicle based on the previously stated facts.
