COUNCIL MEETING MINUTES

January 12, 2016 6:00 PM

CALL TO ORDER

Council Chairwoman Carol Berz called the meeting to order with Vice Chair Moses Freeman and Council members Chris Anderson, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Chip Henderson, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton and Council Clerk Nicole Gwyn, CMC, were also present.

PLEDGE OF ALLEGIANCE

Councilman Smith led the Assembly in the Pledge of Allegiance. He invited Pastor Darryl Davenport, Senior Executive Pastor of Stuart Heights Baptist Church, to give the invocation.

APPROVAL OF LAST MINUTES

On motion of Councilman Anderson and seconded by Councilman Gilbert, the minutes of the last meeting (January 5, 2016) were approved as published.

ORDINANCE #13020

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SECTION 38-361 TO UPDATE THE FLOOD INSURANCE RATE MAP COMMUNITY PANEL NUMBERS.

AGENDA ITEM VI(b):

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PROPERTY LOCATED A 1335 O'GRADY DRIVE, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE TO R-3 RESIDENTIAL ZONE.

The Applicant, Tennessee Riverplace, was represented by Attorney Mark Litchford (of Grant, Konvalinka & Harrison, P.C.). On behalf of the Applicant, Mr. Litchford asked to withdrawn the

rezoning request. A discussion ensued. Upon no further questions, Councilman Henderson moved to accept withdrawal for R-3 zoning. The motion carried.

AGENDA ITEM VI(c):

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PARTS OF PROPERTIES LOCATED AT 2012 AND 2018 JENKINS ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE TO R-2 RESIDENTIAL ZONE.

A hearing ensued with the Applicant and Opposition present. John Bridger of Regional Planning began with a brief overview of the case. Vice Chair Freeman requested a full presentation, which Chairwoman Berz granted.

Chairwoman Berz recognized the Applicant, Lori Cantrell (Jenkins Road). Members of the Opposition did not accept Chairwoman Berz's invitation to address the Council.

Councilpersons asked Mr. Bridger to discuss Planning and Staff's recommendation to deny. Further discussion took place with the Applicant. Upon no further discussion, Vice Chair Freeman called the *question*. Chairwoman Berz ended the discussion and called for a vote. The motion carried.

ACTION: DENIED

AGENDA ITEM VI(d):

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PROPERTIES LOCATED AT 7712 AND 7716 SHALLOWFORD ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE TO RT-1 RESIDENTIAL TOWNHOUSE ZONE.

A hearing ensued with the Applicant and Opposition present. Mr. Bridger made a presentation and discussed Planning and Staff's recommendations. Chairwoman Berz recognized the Applicant, Sergey Lyashevskiy, and his attorney, Ben McGowen, of the firm Summers, Rufolo & Rodgers.

Chairwoman Berz also recognized the following members of the Opposition:

- Greg Vital (Owner, Morning Pointe)

Councilman Grohn moved to deny. Councilman Henderson asked Attorney Hinton about how long it would take to make another rezoning request if this item is denied tonight. Attorney Hinton stated that it would take nine (9) months. After further discussion, **Councilman Anderson moved** to defer one (1) month; the motion failed for lack of a second. Discussion continued with Mr. Bridger, Mr. Shulson and Mr. Vital.

Mr. Lyashevskiy was given the opportunity to make a rebuttal. During which, he gave a slide show presentation and provided handouts to the Council. Mr. Vital was also given the opportunity to make additional comments and respond to questions from the Council.

Vice Chair Freeman moved to defer 60 days with the following stipulations: the Applicant must meet with the neighborhood association to work out the mechanics and an agreement; and (2) the Applicant and the neighborhood association agree and understand that some form of condo must be built on the property.

Upon further discussion, **Vice Chair Freeman amended his motion** to defer for 90 days. Councilman Anderson seconded the amendment. The motion failed upon roll call vote as follows:

Councilman Grohn called the *question*. Chairwoman Berz ended the debate. **Councilman Grohn moved** to deny, seconded by Councilman Smith. The motion carried, with Councilman Freeman and Councilman Anderson voting "NO."
