RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Smith recognized the following persons:

- **Kristin Cooper** (Missionary Ridge) Ms. Cooper addressed the Council last week and stated that her grandmother was a victim of a storm water drain issue on her property. She stated that there is an easement on the property, but the City has informed her that there is not. She stated that her grandparents have been dealing with this for a number of years and they are all hoping that the City would address this as soon as possible.
- **Eva Mitchell** (Missionary Ridge) Also spoke to the storm drain issue on behalf of her parents. She spoke to the blockage in the water drain that is not allowing for the water to flow freely. She stated that she was hoping for the City would have a little humanity with this issue that is very concerning.
 - Councilwoman Coonrod asked Mr. Holland if there was any this issues could be addressed to which he responded. She also inquired about any referrals that could be given to the family.

- Chairman Smith also asked Mr. Holland for a briefing on the work done by City near the property.
- Austin Sourbright (Chattanooga) Gave the Council a flyer for the Town hall meeting that will be taking place this Saturday, March 9th from 11 am 12:30 pm. It will be hosted by community organizations: Hope for the Inner City, Unity Group of Chattanooga, Chattanooga Area Labor Council, Chattanooga Organized for Action, Glass House Collective, Urban League of Greater Chattanooga and Accountability for Taxpayer Money. They are hoping to educate local residents on how neighborhoods and citizen groups can push for limits on tax incentives offered to lure business and development to Chattanooga.
 - Councilwoman Coonrod expressed her concern for the Neighborhood Associations not being listed on the flyer. She also inquired about her Colleague, Councilman Byrd, not being mentioned as someone that these organizations were collaborating with.
 - Councilman Byrd echoed the sentiments of his colleague. He stated the he
 didn't want the community to see this type of events as a "Us vs. Them"
 mentality and he was hoping that all involved could come together and
 make sure that the community members that reside in the neighborhood
 were also part of the process.
