## **COUNCIL MEETING MINUTES**

March 21, 2017 6:00 PM

#### **CALL TO ORDER**

Council Chairman Moses Freeman called the meeting to order with Vice Chair Jerry Mitchell and Council members Chris Anderson, Carol Berz, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Chip Henderson and Ken Smith all present. City Attorney Wade Hinton and Council Clerk Nicole Gwyn, CMC, were also present.

#### PLEDGE OF ALLEGIANCE

Councilman Hakeem led the Assembly in the Pledge of Allegiance and read Hebrews 11:1 (NIV) of the Bible for the invocation. He also recognized the Vietnam Veterans who were in the Assembly today and paid homage to their ultimate sacrifice in service.

#### APPROVAL OF LAST MINUTES

On motion of Councilman Anderson and seconded by Councilman Gilbert, the minutes of the last meeting (March 14, 2017) were approved as published.

## **SPECIAL PRESENTATION**

"Desmond Doss Commemoration Ceremony and Vietnam Veterans Appreciation Week" Presented by Linda Mines, Historian

Councilman Henderson introduced Linda Mines, City and Country historian, who invited the Council to a commemorative ceremony honoring Medal of Honor recipient Desmond Doss, whose story was told in the 2016 movie, *Hacksaw Ridge*. The ceremony would take place on Thursday, March 23 at 12:00 p.m. at the Chattanooga National Cemetery.

She also informed the Council of the series of events taking place to commemorate Chattanooga's "Vietnam Veterans Appreciation Week." A schedule of events was distributed to the Council, describing the following events:

- Monday, March 27 at 5:00 p.m. First Tennessee Pavilion Free event honoring Vietnam veterans with a community picnic and featuring VA Commissioner Many Bears Grinders.
- Tuesday, March 28 at 10:00 a.m., 1:30 p.m. and 4:30 p.m. Tivoli Theater Three, free showings of the movie, *We Were Soldiers*, about the 1965 Battle of la Drang in the Republic of South Vietnam. There will also be a panel discussion of survivors of the battle.
- Wednesday, March 29 at 6:00 p.m. Chattanooga National Cemetery "Vietnam Veterans Appreciation Day" will include a candlelight ceremony and an individual roll call of the fallen.

Councilman Henderson also asked the veterans who were present to stand and tell their names and branch of service.

After a standing ovation, Councilman Henderson thanked the veterans for their service. Bill Raines asked for permission to address the Council. He thanked Ms. Mines for her work on the Desmond Doss recognition and asked for a round of applause for her. He also thanked Ms. Mines and Bud Allen for their work on the weeklong commemoration. He discussed the importance of this weeklong commemoration. Lastly, he thanked the Council and encouraged the community to come out to the events.

Councilman Gilbert expressed his thanks to the veterans and noted that their sacrifices enabled him to do what he does today. Councilwoman Berz noted the veterans' service as outstanding in war and in the community. Chairman Freeman expressed appreciation for the veterans' contributions and volunteerism in the community. Councilman Hakeem commended the veterans for their service in battle and their many years of service as a community leaders and exclaimed "Oohrah." Mr. Raines also left additional copies of the schedule of event calendars for the public and commemorative pins recognizing the 50<sup>th</sup> Anniversary of the Vietnam War.
