

City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES April 5, 2016 6:00 PM

CALL TO ORDER

Council Chairwoman Carol Berz called the meeting to order with Vice Chair Moses Freeman and Council members Chris Anderson, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Chip Henderson, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton and Council Clerk Nicole Gwyn, CMC, were also present.

PLEDGE OF ALLEGIANCE

Chairwoman Berz led the Assembly in the Pledge of Allegiance.

APPROVAL OF LAST MINUTES

On motion of Councilman Anderson and seconded by Councilman Gilbert, the minutes of the last meeting (March 29, 2016) were approved as published.

SPECIAL PRESENTATION

Chairwoman Berz informed the Assembly that the Chattanooga Ambassador's Program presentation currently listed in the agenda had been given in committee earlier today. Therefore, there would be no additional presentation on the program at tonight's meeting.

ORDINANCE #13037

AN ORDINANCE GRANTING UNTO E. 10^{TH} STREET RSD, LLC, A FRANCHISE TO MAINTAIN INSTALLED CONCRETE FOOTINGS EXTENDING ONE (1') FOOT INTO THE RIGHT-OF-WAY ALONG UNIVERSITY STREET, DOUGLAS STREET, AND AN UNNAMED TEN (10') FOOT ALLEYWAY, AND TO MAINTAIN A STORMWATER STRUCTURE AND WATER QUALITY UNIT WITHIN THE CITY RIGHT-OF-WAY ON EAST 10^{TH} STREET, AS SHOWN ON THE MAPS AND DIAGRAMS ATTACHED HERETO AND INCORPORATED HEREIN BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

ORDINANCES – FIRST READING:

ORDINANCE #13038

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 24, ARTICLE VIII, SECTIONS 24-242(4), 24-501, AND 24-502, RELATING TO SPEED ON THROUGH STREETS.

Councilman Anderson moved to amend by removing St. Elmo Avenue, 35 miles per hour from Ochs Highway to the city limits, and adding St. Elmo Avenue, 30 miles per hour from Ochs Highway to the city limits. He was seconded by Councilman Smith. **Councilman Henderson moved** to amend the amendment to reduce Manufacturer's Road to 30 miles per hour from *Cherokee Boulevard to U.S. Highway 27*. Councilman Anderson accepted his friendly amendment. Councilman Smith withdrew his second. Councilman Henderson seconded.

Discussion ensued with Blythe Bailey, Transportation Administrator, about whether an amendment was needed for Manufacturer's Road since the road was partially in a business district where 30 miles per hour would be the default speed. Attorney Hinton indicated that it would not be problematic to add Manufacturer's Road to the list of streets being reduced to 30 miles per hour. The motion carried. At the request of Councilman Henderson, Mr. Bailey also agreed to confer with CPD on the best method for alerting drivers of the lower speed limit on Manufacturer's Road.
