CALL TO ORDER

 She noted that today was her first day chairing this committee meeting. During the open meeting, the committee was able to pose questions to Public Works Administrator Justin Holland.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Mitchell recognized the following persons:

- Cynthia Stanley Cash (President, North Brainerd Neighborhood Association) She is one of the founding members of the Hamilton County Coalition of Homeowners, created, in part, to the issue of Short-Term Vacation Rentals.
 - She commended Councilwoman Coonrod for her questions on the lawn maintenance contract purchased last week and learned about the need for additional employees for landscaping.
 - She asked about Public Works helping the community of Eastdale with landscaping, especially work on the trees across from Pin Oak. She hopes that there will be more Public Works employees hired to enable the department to do more landscaping in the area.
 - She inquired about how to apply for boards and how to learn about openings. She informed the Council that she is interested in being on the Form-Based Code Board.
 - She requested that Public Works utilize invasive plant species, like with the Agawela Drive project, to help with the flooding down Germantown and Pin Oak, especially after the last round of recent storms.
 - She informed the Council that the water is corroded and smells like "toilet water" in the Indian Hills area.
 - Chairman Mitchell asked Ms. Sullivan to get information to Ms. Stanley-Cash about applying for a board. Ms. Sullivan informed the Assembly that the board information is on the city's website. She also agreed to meet with Ms. Stanley-Cash about board information.
- Tiffany Rankin (President, Lincoln Park Neighborhood Association) -
 - She requested that the Historic Zoning Commission add at least one Native American and more than one African American to its membership.
 - She informed the Council that Lincoln Park had not been notified about the design for construction of the storm drain on Central Avenue and asked why they were not informed. Lincoln Park saw the conceptual drawing, but did not see where the storm drain is located and its outcome.
 - Councilman Byrd informed Ms. Rankin (1) that the project had began prior to him coming to the Council; (2) that he reached out to Ms. Rankin and her mother prior about coming to the meeting tonight; (3) that he will ensure that the lines of communication are open with the community.

- Councilman Byrd requested that Mr. Holland give Ms. Rankin the same information that he had presented to the Council. Mr. Holland agreed to get information to Ms. Rankin, Councilman Byrd and the community about where the pipe is going.
- Ms. Rankin noted that she had not spoken to Councilman Byrd about the design and asked why she was receiving information after the vote for the construction.
