Councilwoman Berz opened the floor for Ms. Haley (Finance) to explain the need for this ordinance. Ms. Haley explained the City’s annual sale of surplus property and how the net proceeds from the sale are given to the Land Bank for use.

Councilwoman Berz asked if there was anyone present who wished to address the Council about the ordinance. Seeing one person, she opened the floor and recognized them:

Dr. Mauldin addressed the council with an overview of the summary report that they had received. He gave a presentation about the studies of inequalities in the City of Chattanooga. [View the full presentation [here.](#)] Discussion ensued and touched upon the following topics:

Dr. Mauldin ended the presentation and responded to Council questions. Councilwoman Dotley had questions about the framework and budget, and how would it apply to legislative work. Vice Chair Hill asked for more details regarding his recommendation of six policy areas. Vice Chair Hill asked about the disparities in incarceration rates related to race and gender.

Dr. Mauldin discussed the census and data collected by the policy map. He explained the data collection process, incarceration rates, use of force, citizen perception of safety, and census block group data collection. He explained disparities in geographic boundaries and council districts block groups.

Dr. Mauldin agreed to provide a full report with more specific information in two weeks. Upon no further questions or concerns, this portion of the meeting was closed.

Chairman Henderson reminded everyone that tonight is the second Tuesday, which is typically referred to as the Council's "Zoning Night."
