Vice-Chairman Smith expressed his pleasure in sponsoring this resolution as a father of three children who have played on this field. He invited John Strausberger and Mary Grimes, wife of

Cleveland T. Grimes, to address the Council. Mr. Strausberger discuss Mr. Grimes' impact on youth. Ms. Grimes described her husband as the "Soccer King" and described over 34 years serving the community and kids at this facility. After which, she received a standing ovation.

Councilwoman Berz informed the Assembly that there were many amendments to the draft agreement. Councilman Henderson confirmed that his suggestion for recruiting from neighborhoods that are underemployed had been taken into consideration for incorporation into the agreement. A discussion ensued that included the following:

- Attorney Hinton agreed to work with the Chamber and HomeServe USA on how the recruitment language in the agreement.
- Councilwoman Coonrod recommended partnering with Chattanooga 2.0 to ensure job readiness for certain communities.
- Councilpersons Coonrod and Oglesby thanked Accountability for Taxpayer Money (ATM) for researching this PILOT and bringing forth their policies and procedure document.
- Vice-Chairman Smith expressed thanks to HomeServe for the living wage jobs and commended the city for moving in the right direction with this PILOT.
- Attorney Hinton reviewed the compliance component of the PILOT for Councilman Oglesby.
- Councilwoman Berz informed the Council of a program with Gestamp, a previous PILOT recipient, working with schools to equip co-op students.
- Councilman Byrd encouraged people to spread the word in their communities about the coming employment opportunities.

Meeting Attendance

Councilwoman Coonrod recognized and thanked former councilperson Yusuf Hakeem for his presence in the Assembly today. She commended the Assembly for such a large turnout today and encouraged citizens to continue attending Council meetings.

Other Special Recognition

Councilman Gilbert noted that former councilperson John "Duke" Franklin, Jr. and Pastor Paul A. McDaniel were in the Assembly today.

Changing Council Rules

Chairman Mitchell instructed the City Attorney to add a resolution to next week's agenda that would change the Council's rules of procedure so that speakers on non-agenda items could have 6 minutes instead of 3 minutes to address the Council. Attorney Hinton agreed.

COMMITTEE REPORTS:

Budget and Finance Committee

Councilman Henderson reported:

 The committee met today in open meeting to discuss the reappraisal of the tax assessor that is resulting in an interim budget for FY18. Chief Finance Officer Daisy Madison gave a report on the reappraisal and interim budget.

• The committee also held a discussion on the Short-Term Vacation Rental district. He informed the Assembly that the first reading will take place on the June 13, 2017 agenda. Attorney Hinton will put the boundaries of the district in writing with the ordinance.

Public Safety Committee Councilman Byrd

He thanked the new Police Academy cadets who were graduating today.

Public Works and Transportation Committee Councilwoman Berz reported:

 The committee met today in open meeting for a report from the Department of Public Works. It included an educational session on the Consent Decree. She thanked the department for coming.

Youth and Family Development Committee Councilwoman Coonrod

• She reminded everyone of the milk products contract that had just been approved for the Department of Youth and Family Development.

Information Technology Committee Vice-Chairman Smith (No report)

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Mitchell recognized the following persons:

- Janet Burn (Highland Drive) She is a member of St. Peter & Paul on E. 8th Street. She is opposed to the conversion of downtown streets from 1-way to 2-way due to the negative impact on her church. She believes the 2-way conversion will cause problems for church attendees parking on the street.
- Ezra Robinson (Timber Knoll Drive) He informed the Council that people are burdened by construction in his East Brainerd community. He noted that a sidewalk had been left unfinished in one area, and that speeding cars are a problem. He requested 10-15 minutes to address the Council on his concerns.

- At the end of the Council meeting, Councilwoman Coonrod inquired about Mr. Robinson's request to address the Council. Mr. Robinson indicated that he and his board of directors could not meet until for another two weeks at least. Chairman Mitchell informed Mr. Robinson that he would speak with the Council on his request and that Mr. Robinson could contact the Council to follow-up.
- Dr. Elenora Woods (President, local chapter NAACP) She addressed the Council
 with several NAACP Officers with her: George Calhoun, Gail Mathis, James Mathis, and
 Yusuf Hakeem. She read a letter to Mayor Berke from the NAACP, requesting that the
 NAACP be involved with the Police Chief Selection process.
 - Councilman Gilbert discussed a letter from Pastor Kevin Adams about the next police chief, and voiced his support of Assistant Chief Edwin MacPhearson for the next Police Chief, based upon his years of service on the force and his in-depth knowledge of the community.
 - Councilwoman Coonrod voiced her support of Assistant Chief MacPhearson and questioned why some of the selection committee do not reside in the City. She also voiced concerns in the African-American community about the police.
 - Stacy Richards, Chief of Staff, addressed the questions about committee members who reside outside of the city limits. She also informed the Council that the Mayor's staff is working on a meeting on how to incorporate the NAACP into the selection process.
 - Vice-Chairman Smith voiced his support and expectation of the NAACP being at the table during the selection process, and hopes to expand the committee.
 - Councilman Byrd voiced his support of Assistant Chief MacPhearson for Chief and encouraged people to reach out to the Mayor about expanding the selection committee.
 - Councilwoman Coonrod also reminded the Council that the Fire Chief may retire soon and suggested looking at Captain David Brooks.
- Pastor J.R. Bridgeman (Thompkin Chapel AME Zion Church) He is the President of the Clergy Koinonia of Chattanooga. He informed the Council that the Koinonia shares the thoughts of Pastor Kevin Adams on selecting the new chief. He asked that Assistant Chief MacPhearson be made the next Police Chief and discussed having personally dealt with him in the past within the community.
- Monty Bell (Chattanooga) Mr. Bell made comments on several items:
 - o The image of black people
 - Crime in the media
 - His brother's car accident
 - News anchor Mort Lloyd apologizing for error in news story
 - His interest in news and media
 - An affidavit of complaint against his name
- Ali Stafford (Ashmore Avenue) She thanked the Council for considering a change to 6
 minutes for non-agenda speakers. She asked the Council to reconsider the
 "disproportionate" funding of the Chattanooga Police Department and consider investing in
 alternatives to CPD increases. She asked the Council to examine participatory budgeting.

- Helen Burns Sharp (Walnut Street) On behalf of the group, Accountability for Taxpayer Money (ATM), she thanked the Council for allowing them to distribute their recommended policies and procedures for jobs PILOTs. She informed the Council of a meeting set with Charles Wood soon. She also asked ATM members to stand and display their new t-shirts with messages about jobs PILOTs.
- **Peggy Petree (Main Street) -** Ms. Petree is a member of ATM. She has a Short-Term Vacation Rental property and invited the Council to tour and discuss STVRs with her.
