

City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES May 30, 2017 6:00 PM

CALL TO ORDER

Council Chairman Jerry Mitchell called the meeting to order with Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson, Darrin Ledford and Erskine Oglesby. Wade Hinton, City Attorney, and Nicole Gwyn, Council Clerk, CMC, were also present.

PLEDGE OF ALLEGIANCE

Councilwoman Coonrod led the Assembly in the Pledge of Allegiance. She called for a 2-minute moment of silence in honor of Memorial Day.

APPROVAL OF LAST MINUTES

On motion of Councilman Henderson and seconded by Councilman Gilbert, the minutes of the last meeting (May 23, 2017) were approved as published.

SPECIAL PRESENTATIONS:

PRESENTATION ON TYNER PLAYGROUND & HONORING JOHNNY O'NEAL & ALFRED CANTRELL Introduction by Lurone "Coach" Jennings Dept. of Youth and Family Development

Mr. Jennings gave his sentiments on the retirements of employees Johnny O'Neal and Alfred Cantrell. He then introduced Greta Hayes, Director of YFD's Recreation Division, who opened with a slide presentation on the new Tyner playground that was erected by 150 people in five hours. Ms. Hayes thanked the City, Councilwoman Berz, Snapple, Coca-Cola, KaBoom, for bringing forth the vision and resources for this project. She and Councilwoman Berz thanked IBEW and Steelworker's Union members, church members, city employees, various executives and community members who contributed to the building process. Councilwoman Berz commented on the many people who showed up just to take part in something positive, including Councilman Ledford. She also thanked Ms. Hayes for her work in the project.

Ms. Hayes asked Mr. O'Neal and Mr. Cantrell to come forward for recognition from the department and spoke about their impact on the department over the past 37 and 27 years, respectively in which they have worked. Both Mr. O'Neal and Mr. Cantrell thanked the City for the recognition and spoke about their work for the City. Chairman Mitchell spoke regarding his past years working with Mr. O'Neal and Mr. Cantrell. He also acknowledges former Parks & Recreation Director Larry Zehnder, who was present and had previously worked with Mr. O'Neal and Mr. Cantrell. Councilwoman Coonrod commented on Mr. O'Neal and Mr. Cantrell being God-fearing men with a passion to help youth. Councilman Byrd commented on all his years as a youth working with Mr. O'Neal and thanked them for impacting his life.

Information Technology Committee Vice-Chairman Smith (No report)

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Mitchell recognized the following persons:

- Joanne Holliday-Johnson (District 7) She informed the Council of two incidents: an officer putting her in a choke-hold and being kidnapped. She requested a lie detector test to prove her truthfulness on these claims. She also requested that the Council create activities for children in her community who are begging for money and playing without supervision in the streets.
- Cora Lanier (Dodson Avenue/District 9) She came on behalf of the Boyce Station community to request a concentrated effort by the City of Chattanooga to include the urban overlay and communities like hers in the economic development. She described "two Chattanoogas" and asked the Council to consider inequalities between downtown and neighborhoods in the urban overlay. She proposed that new monies generated from the new Short-Term Vacation Rental overlay be earmarked for neighborhoods.
 - Councilman Coonrod expressed support of the proposal and her desire to see improvements in areas other than downtown.

- Councilman Oglesby agreed with Ms. Lanier's concept of "two Chattanoogas" and expressed his intent to make to expand economic prosperity to underserved areas.
- Vice-Chairman Smith asked Attorney Hinton about earmarking tax dollars for neighborhoods, and about earmarking money from the hotel-motel tax for neighborhoods. Attorney Hinton gave his opinion, and asked Maura Sullivan, Chief Operating Officer, and Daisy Madison, Chief Finance Officer, to give their understanding as to why the monies collected from the hotel-motel tax cannot be earmarked for anything outside of the 21st century waterfront debt.
- Donna Lowe (Main Street Innovations) She proposed a standard operating procedure for the Council to communicate with their constituents that would increase councilpersons' response times and bridge the gap with the underserved.
 - Vice-Chairman Smith offered to set up a time to speak with Ms. Lowe about her proposal.
- Franklin McCallie (Reed Avenue/District 7) He echoed the sentiments of Ms. Lanier and commented on every community wanting to be great. He commended this Council and exhorted them to find a way to get monies collected to neighborhoods.
 - Councilwoman Coonrod commended Richard Bennett, of the organization, A Better Tomorrow, to come forward for special recognition. She commented the program he created and the work he has done for this city. She encouraged him to apply for funding that is available at the City.
 - After thanking Ms. Coonrod, Mr. Bennett commented on the need for men like Alfred Cantrell and Johnny O'Neal, his relationships with councilpersons, and his excitement for what he sees before him.
