RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Freeman recognized the following persons:

- Theresa Brown (Juandale Trail/District 5) She came before the Council again regarding the flooding that took place at her property last year. She met today with the Mayor and two of his staff members. She says the creek behind her home is not causing the flooding. She said the golf course on Shallowford Road is connected with the creek and that when control pumps release water from the city's property is flooding her property. She said it has already been decided to not take responsibility of the flooding. She brought pictures of the property damage. She wanted everyone to know that right is right and wrong is wrong, and God doesn't like ugliness.
 - Molly Cooper of the Mayor's Office said they have spoken several occasions with Ms. Brown. She has told Ms. Brown that if the City had any part in the flooding, it would have taken care of the damage. She said that they have spoken to everyone who controls water flow in the city, including TVA, and found that the City of Chattanooga is in no way responsible. She stated that the city engineer, Bill Payne, today told Ms. Brown that the water rising out of the creek is flooding the property.
 - Mr. Holland informed the Council that Ms. Brown has filed a complaint with the City Engineer. He has consulted with the Army Corp of Engineers, engineers from the Waste Treatment facility and the City Attorney's Office because of the complaint, and feels that the City has done due diligence and fully understand what's happening. He stated that the creek behind her home is in a flood zone and that the City cannot control all water. He stated that the creek is a waterway, so once it

rises to a certain level, it will flood in a flood zone area. He stated that the City does not control this.

Chairman Freeman allowed Ms. Brown to make a rebuttal:

She stated that representatives from TVA and Moccasin Bend came to her property when it flooded in 2009. She stated that the individual from Moccasin Bend told her that they have no choice but to flood her property to keep from flooding Brainerd. She stated that the flooding this year did not come from the side where the creek is located. After that flooding incident, she made an appointment with the individual from Moccasin Bend to come see the direction of the flooding, but he failed to show. Councilman Gilbert came to see it. She believes that the City does have control of the pumps.
