COUNCIL MEETING MINUTES

June 20, 2017 6:00 PM

CALL TO ORDER

Council Chairman Jerry Mitchell called the meeting to order with Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson, Darrin Ledford and Erskine Oglesby. Wade Hinton, City Attorney, and Nicole Gwyn, Council Clerk, CMC, were also present.

PLEDGE OF ALLEGIANCE

Vice-Chairman Smith led the Assembly in the Pledge of Allegiance and gave the invocation.

SPECIAL PRESENTATION

"World Refugee Day Proclamation" By Councilman Anthony Byrd

Councilman Byrd presented the following proclamation to Marina Peshterianu of Bridge Refugee Services:

Whereas, there are more than 65 million displaced persons in the world today--the highest in recorded history. More than 21 million of these people are refugees.

Whereas, in 2001, the United Nations designated June 20 as "World Refugee Day," a day of recognition each year to recognize the bravery and resilience of refugees, and their contributions to their new communities;

Whereas, Bridge Refugee Services has been resettling refugees in the Chattanooga area for 30 years. They have assisted more than 1,000 refugees to date and work tirelessly to support refugees in their efforts towards economic and social self-sufficiency;

Whereas, communities near and far, along with supporters and friends, will observe World Refugee Day with cultural celebrations and outreach activities for the entire community.

Now Therefore,

I, Anthony Byrd, Councilman for the City Council District 8, do hereby proclaim **Tuesday**, **June 20**, **2017** as a day of recognition for

WORLD REFUGEE DAY

in the city of Chattanooga, Tennessee.

A RESOLUTION AUTHORIZING A RENEWAL OF THE 2002 INTERLOCAL AGREEMENT BETWEEN THE CITY OF CHATTANOOGA AND HAMILTON COUNTY PROVIDING FOR THE COLLECTION AND ADMINISTRATION OF HOTEL/MOTEL TAXES BY THE COUNTY ON BEHALF OF THE CITY FOR A TERM OF FIVE (5) YEARS, AND AMENDING SECTION 7 OF SAID INTERLOCAL AGREEMENT FOR THE COUNTY'S COMPENSATION FOR THESE SERVICES UNDER THE AGREEMENT SHALL BE ONE (1%) PERCENT OF THE TOTAL TAXES COLLECTED PER ANNUM AND SHALL BE SUBJECT TO ANNUAL NEGOTIATION FOLLOWING THE INITIAL FIVE (5) YEAR TERM.

Councilman Henderson acknowledged that Bill Hullander, Hamilton County Trustee, was present in the Assembly to respond to any questions from the Council. Councilman Henderson also described for the Assembly that the old agreement had expired. He also informed the Assembly about the City anticipating Short-Term Vacation Rental proprietors in Chattanooga being added to the hotel/motel tax collection.

Councilman Henderson noted that a 2-percent (2%) discount to hotelier is being charged with this tax. Daisy Madison, Chief Finance Officer, if she would look into reducing that discount to 1% discount, which would help pay for what is being incurred today. Ms. Madison agreed to look into that with the State and noted that she had already called the State to determine if 2% is required by law. Councilman Henderson noted that he would like to see a legislation reducing that to a 1% discount.

Councilman Ledford asked to hear from Trustee Hullander, who informed the Council of how this agreement is a "win-win" situation for such services, and how audits of the 135 motels in Chattanooga resulted in a \$37,000 collection for the City.

Upon no further questions, **Councilman Henderson moved** to approve, seconded by Councilman Ledford. The motion carried.

He asked that the following wording be added at the end of the resolution: and at the end of each year, 12-percent (12%) of the net sales after taxes. He indicated that no amendment was needed. Maura Sullivan, Chief Operating Officer, apologized for not including this wording in previous open discussions. Upon no questions from the Council, the motion carried.

 Chairman Mitchell reported that the committee met earlier today in open meeting. He thanked administrators Justin Holland (Public Works) and Blythe Bailey (transportation) on behalf of Councilwoman Coonrod.

Youth and Family Development Committee Councilwoman Coonrod (No report)

Innovation Technology Committee Vice-Chairman Smith reported:

 The committee will meet next week (June 27) following the 3:00 p.m. Agenda Session for a discussion the small cell ordinance. The ordinance will be added to the July 11 agenda for first reading.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Mitchell recognized the following persons:

- Regina Kirk (District 5) She is a former UTC Mocs basketball player and SoCon Hall of Famer who now runs her own foundation, The Regina Kirk Foundation. She wanted to inform the Council of her foundation's annual golf tournament and requested resources and support from the Council in her efforts. She also discussed the work of her foundation and her goal of starting an innercity basketball league.
 - Councilman Byrd thanked her for her work with youth and confirmed the name of her organization. Ms. Kirk also informed the Council of her S.A.F.E. (Serving Athletes for Excellence) Camp.
 - Councilwoman Coonrod read the flyer about the golf tournament, which will take place on [September 7, 2017] at Moccasin Bend Golf Course, and asked the Council if that is something it would be able to support. Chairman Mitchell offered to discuss that at a later time.
- Gary Ball (Community Police Interaction Committee) He has been
 working with Baker South and Baker North. He wanted to remind the Council of
 various housing codes in Section 21 of City Code that could be utilized by the
 City and the Administrative Hearing Officer in dealing with condemned and
 blighted properties in his community. He asked for the Council to discuss what
 can be done for one property in particular that is vacant and becoming a
 nuisance.
- Dianna Mancini (East Lake/District 7) She heads up the Neighborhood
 Watch and asked the Council what could be done about the boarded up and
 condemned houses in her neighborhood. She also informed the Council of cars
 being parked too close to corners and intersections, which has caused
 problems for fire trucks.
 - Councilman Oglesby asked to speak with Ms. Mancini after the meeting.
 She agreed to stay.
- Cicely Roman (Foust St./District 7) She informed the Council that she has been writing down addressed of vacant and blighted properties in her community. She discussed properties on 7th Avenue, East 38th Street, Clio Avenue that are condemned, blighted and/or unsafe. She plans to bring videos and pictures of these properties back to the Council.
