# CALL TO ORDER

Council Chairman Moses Freeman called the meeting to order with Vice Chair Jerry Mitchell and Council members Chris Anderson, Carol Berz, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Chip Henderson and Ken Smith all present. # RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Freeman recognized the following persons:

• Aja Pryor (UTC) – She was upset that the Council has had several opportunities to amend the budget to include programs suggested by the People's State of the City.

[Councilman Anderson called a *point of order* because the budget was an agenda item that could not be discussed at this time in the agenda.] She said that the people are outraged and disappointed in the Council. She said that people are hopeless to the point of not showing up to today's meeting.

- Nathan King (Orchard View) He said that people are still dissatisfied with the Council's silence. [Upon speaking about the budget, Chairman Freeman asked Mr. King to respect the Council's rules.] He voiced opposition to the Central Avenue extension and reminded the Council of several factors, such as the Creek people's burial mound in that vicinity.
- Isabella Longman (Chattanooga) She gave a praise report about an elderly man who had wandered from a nursing home and was found by the Chattanooga police at the cemetery. She also informed the Council of shots that had been fired in a street adjacent to the National Cemetary. She commended the police because the matter was resolved without fatalities or injuries.
