CALL TO ORDER

Council Chairman Jerry Mitchell called the meeting to order with Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Darrin Ledford and Erskine Oglesby. Public Works and Transportation Committee Councilwoman Berz reported:

• The committee met today in open meeting and reviewed some large-dollar expenditures on next week's agenda.

Youth and Family Development Committee Councilwoman Coonrod (No report)

Information Technology Committee Vice-Chairman Smith reported:

• The Council passed the small cell ordinance on final reading today. He expressed thanks to Attorney Hinton and his team, consultants who lent their expertise and Blythe Bailey, Transportation Administrator.

RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Mitchell recognized the following persons:

- Fred Flack (Dodson Avenue/District 9) He acknowledged neighborhoods have achieved. He see good things happening in neighborhoods, especially in hard-hit areas. He acknowledged Police for doing their job in neighborhood growth.
- Kelly Moore (Bagwell City/District 2) She opposed the new sewage holding tank that will affect 30-plus residents on Memphis, Atlanta and Birmingham Drive in Bagwell. She informed the Council of raw sewage and mosquitos from the current pumping station, and asked that the station be moved to where there are no kids. She informed the Council that her association had 126 signatures out of 131 homes that oppose the holding tank.
- **Donald Sandefur (21st Century Historic Glenwood Assoc./Distrit 9)** He was the panel regarding the choice of police chief. He asked, once the chief is chosen, that the Mayor provide information on why the other two candidates were not selected.
- **Patrick Kellogg (Chattanooga)** He brought the bill of an elderly woman that reflects a negative amount in the "amount due" section. He wanted to know who to speak to about issuing a credit to this woman. he also wanted to know what amount of time it would take for the woman to get the money credited to her.
 - Maura Sullivan, Chief Operating Officer, offered to speak with Mr. Kellogg about the bill.
- Dr. Everlena Holmes (District 9) She attended Skype and face-to-face meetings with school superintendent candidates. During which, she asked Education Commissioner Candice McQueen about delaying the proposals regarding at-risk I-Zone schools and was told "no." She encouraged tax payers to do something about the schools and asked the Council to consider a separate school tax.
