RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

 - Councilman Gilbert asked if he had heard the racist words being spoken at the club. Mr. Adamson confirmed hearing the words and described the incident.
 - Councilman Hakeem asked Mr. Adamson to describe the kind of business where the incident took place.
 - Attorney Hinton stated that he would look into Public Accommodation law regarding this matter.
 - Councilwoman Berz asked Mr. Adamson to encourage the other individuals who witnessed the incident to come forward by sending her their names.
 She stated that she would forward those names to the City Attorney and her colleagues.


















Stringer's Ridge Park Overlook

Survey Program

- Implemented through Park Ranger staff
- Managed by Parks Outreach Coordinator
- Tablets used to collect data
 - Allows immediate entry & analysis
- Creates positive interactions with visitors
- Helps drive decisions for continuous improvements
- Clear indicator of performance as observed by visitors
- Establish service levels for each location and determine input needed to meet level
- Create specific targets for staff to meet quarterly
- Track performance of key indicators to see improvement or decline

Improve environmental & aesthetic quality of parks & greenways by organizing and promoting volunteerism and stewardship.

Volunteers provide time, talent, and resources


