#### **COUNCIL MEETING MINUTES**

August 22, 2017 6:00 PM

#### CALL TO ORDER

Council Chairman Jerry Mitchell called the meeting to order with Vice-Chairman Ken Smith and Councilpersons Carol Berz, Anthony Byrd, Demetrus Coonrod, Russell Gilbert, Chip Henderson, Darrin Ledford and Erskine Oglesby. Wade Hinton, City Attorney, and Nicole Gwyn, Council Clerk, were also present.

# **OTHER BUSINESS:**

# **Confederate Cemetery Request**

Councilman Henderson informed the Council that he learned that Mayor Berke had asked the City Attorney to file paperwork to remove the City of Chattanooga as a trustee for the confederate cemetery. After hearing this, he called the attorney to find out what was happening. He learned that the Sons of the Confederacy had been wanting to be named trustee, but there was the issue of the City being the trustee. He felt there may be opportunity for the Sons of the Confederacy to become trustees and allow the City to "get out of the way" in this matter. He asked the City Attorney to report to the Council on (1) the conversations that have taken place over the past year about the City getting out of the way, (2) a brief history of how the city became a trustee and (3) the legal process and ramifications of removing the City as a trustee. Attorney Hinton agreed to report back to the Council with the requested information.

# **District 9 Announcement**

Councilwoman Coonrod discussed how mailboxes are places where information is received and given, then she what is being called the "District 9 Mailbox Gathering," taking place on Saturday, September 9, 2017 from 10:00 a.m. – Noon at the Orange Grove Center on Derby Street. She noted that it will include breakout sessions with city departments. Community members will also work together on different solutions to improve the district.

# **Valor Luncheon**

Councilman Ledford wanted to discuss one of the messages that he had from attending today's Valor Luncheon. He told about hearing a story by Colonel Blackman about a young African-American man and a 62-year-old Caucasian man who came together for an adventure. At the end of the story, the two men said "I love you." The story touched his heart so much that Councilman Ledford turned to Councilman Byrd during the luncheon and said "I love you." Councilman Byrd gave his response: "I love you, too, brother." Councilman Ledford indicated that this is what the current Council is about and stands for in the city.

Budget and Finance Committee Councilman Henderson reported:

- The committee met today, starting at 9:30 a.m. and ending around 3:15 this afternoon. They did have a break for attending the Valor Luncheon today. The committee's third budget work session, where they heard presentations on Safer Streets and Smarter Students, Stronger Families and Safer Streets.

• The committee met last week for a Q&A session with then-Interim Police Chief David Roddy. He reported that it went very well because we now have a new Chief.

Youth and Family Development Committee Councilwoman Coonrod (No report)

• She wanted to express appreciation for everyone coming out to today's Council meeting. She referenced a Swahili phrase from the Lion King movie: Hakuna Matata, which means "No Worries." She encouraged citizens not to worry about the battles of the past, but strive to tackle the battles of today. She noted systemic problems such as mass incarceration and recidivism as some of the battles affecting citizens today. She encouraged everyone to not just be the "mouthpiece," but to also be the action in bringing forth needed changes.

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Mitchell recognized the following persons:

- Ricky Robinson (Chattanooga) He commented on the changes in the city and wanted
  to give his full support to Chief Roddy. He asked that the public give Chief Roddy a
  chance to make a difference.
  - Councilwoman Coonrod thanked Mr. Robinson for his words of support and was happy to have taken part in the reconciliation between him and Chief Roddy.
- Napoleon Williams (Chattanooga) Mr. Williams was the city's first African-American detective. He wanted to invite the Council to a Pray Vigil for Chattanooga, taking place on tomorrow (August 23) at 8:00 p.m. at the Historic Engel Stadium. The vigil would focus on stopping the violence in the city. He noted the "black-on-black" violence in the city.
- Brenda Shelton (Airport Rd./District 5) She came a couple of weeks ago to report a business across from her house that ran a noisy compressor late into the

night. She reported that the same business is now having its roof repaired, so she is now hearing hammering late at night. She also noted that there is a band practicing late at night in her neighborhood at a car wash parking lot. She has not been able to receive relief from the noise and promises to come back to the Council as long as the noise continues.

- Councilman Gilbert informed Ms. Shelton that he and Attorney Hinton have been discussing options for dealing with these disturbances, and asked her to speak with him and the attorney after this meeting. Ms. Shelton agreed.
- Cecily Roman (Foust St./District 7) She informed the Council of a house in her East Lake neighborhood that has been condemned, but people are hosting a flea market there on weekends. She also informed the Council of the house next door that is blighted, but not boarded up yet. She asked that code inspectors work on weekends so that they can witness the illegal flea market. She is also concerned that kids are hanging out at the blighted property.
  - Councilman Byrd informed Ms. Roman that discussions took place today on blighted properties and that the budget will reflect the Council's efforts with this problem.
