A RESOLUTION AUTHORIZING THE ADMINISTRATOR FOR THE DEPARTMENT OF ECONOMIC DEVELOPMENT TO ENTER INTO AN AGREEMENT WITH THE CHATTANOOGA AREA REGIONAL COUNCIL OF GOVERNMENTS (SOUTHEAST TENNESSEE DEVELOPMENT DISTRICT) FOR THE MANAGEMENT OF THE CITY'S ENVIRONMENTAL PROTECTION AGENCY (EPA) BROWNFIELDS CLEANUP GRANT, FOR A TERM OF THREE (3) YEARS BEGINNING ON SEPTEMBER 1, 2024, AND ENDING ON AUGUST 31, 2027, WITH THE OPTION TO RENEW FOR ONE (1) ADDITIONAL YEAR.
