# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on nonagenda items. After which, Chairman Smith recognized the following persons:

 Avery Gray – She is the mother of the 14-year-old female who had an interaction with a Chattanooga police officer while behind the wheel of a running vehicle. She expressed her concerns as a mother and spoke to the effect this incident has had on her child. She stated that she was under the impression that Tennessee Law did not allow for police officers to get involved in incidents of evictions/repossessions and she just wanted to know why this situation had to be dealt with in the matter it had.

Councilwoman Coonrod expressed that she sympathized and empathized with Ms. Gray. She asked the City attorney if officers could be involved in these types of situations, to which Mr. Noblett addressed the detail of Tennessee Law. Councilwoman Coonrod asked Chief Tucker if there was a video (body camera) that he could be provided to the Council. Chief Tucker did state there was an ongoing investigation and he could make no further comments regarding the events.

Councilwoman Coonrod stated that she would like to connect Ms. Gray with the Economic & Community Administrator to see what other resources could be available to her and her daughter.

Councilman Byrd expressed empathy for this situation. He asked Ms. Gray to articulate what she wants to come out of this and what justice looks like for her. He asked if Ms. Gray had hired legal counsel and involved internal affairs in the matter. He did state that we all would like for justice to be served.

• Marie Mott (Oak Grove Neighborhood) – Came to the lecture after being told she was not able to speak within a 30 day period as she had done twice already. She stated that she should be allowed to speak and expressed that her first amendment right was being infringed upon and that City Council rules were not above the Constitution. Chairman Smith expressed what the rules were and that he had to uphold them. He then entertained a motion from the Council.
