### **COUNCIL MEETING MINUTES**

November 29, 2016 6:00 PM

#### **CALL TO ORDER**

Council Chairman Moses Freeman called the meeting to order with Vice Chair Jerry Mitchell and Council members Chris Anderson, Carol Berz, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Chip Henderson, Jerry Mitchell and Ken Smith all present. Deputy City Attorney Phil Noblett and Council Clerk Nicole Gwyn, CMC, were also present.

# PLEDGE OF ALLEGIANCE

# "Proclamation - World Pancreatic Cancer Day" By Councilman Chris Anderson and Charlie Steinhice

Councilman Anderson presented Mr. Steinhice and the Pancreatic Cancer Action Network with the following proclamation:

WHEREAS In 2016, an estimated 53,070 people in the United States will be diagnosed with pancreatic cancer, one of the deadliest cancers, and 41,780 will die from the disease;

WHEREAS Pancreatic cancer surpassed breast cancer this year to become the third leading cause of cancer death in the United States, and it is projected to become the second leading cause by 2020;

WHEREAS Pancreatic cancer is the only major cancer with a five-year relative survival rate in the single digits at just eight percent;

WHEREAS When symptoms of pancreatic cancer present themselves, it is generally in later stages, and 71 percent of pancreatic cancer patients die within the first year of their diagnosis;

WHEREAS Approximately 870 deaths will occur in Tennessee in 2016;

**WHEREAS** Pancreatic cancer is the seventh most common cause of cancer-related death in men and women across the world;

WHEREAS There will be an estimated 418,451 new pancreatic cancer cases diagnosed worldwide in 2020;

WHEREAS The good health and well-being of the residents of Chattanooga are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes and effective treatments;

# RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Noblett read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Chairman Freeman recognized the following persons:

- Rhonda Van Billion (Beck Avenue) She informed the Council of a citizen
  planning to buy an alley on Beck Avenue that is so close to her house that she can
  touch automobiles passing through it. Her warranty deeds indicates that the alley
  is private. She wanted to know if the owner would have the right to sale the alley to
  others.
  - Blythe Bailey responded to questions from Councilman Henderson about topographical changes/issues, whether city code distinguishes between an alley and a street, whether there are city standards for an alley and whether city code would prevent opening an alley that is too steep.
  - Vice Chair Mitchell reminded the Council that this item had been deferred until the December 13 agenda, and that the Council Clerk had found records indicating that the alley had only been partially, not entirely, closed.
  - Chairman Freeman questioned whether there was a closure for the alley and whether the city can affect a private easement.
  - Councilman Smith agreed to hear this closing and abandoning item during next week's Public Works and Transportation Committee meeting. He also agreed to allow affected residents make comments to the Council on this item.
- Lynn Crabtree (Jarnigan Avenue) She is concerned about the same alley on Beck Avenue and thought everything was settled about closing this alley in 1988. She said the alley is impassible and is surprised that it may be opened again.
- Helen Burns Sharp (Walnut Street) She spoke in favor of the Standard Coosa Thatcher Lofts PILOT, but had just learned that the PILOT resolution was on next week's agenda. She suggests that the Council schedule two weeks between hearing a PILOT matter in committee and the agenda reading.

- **Jasmine LeBlanc (13<sup>th</sup> Avenue)** She spoke on behalf of the East Lake Neighborhood Association and asked the Council to waive fees for use of the East Lake park for a community-wide Posada event in December.
  - Councilman Anderson asked Maura Sullivan, Chief of Staff, if Administration could get this fee waiver item on next week's agenda. Ms. Sullivan confirmed that it would be ready for next week.
  - Councilman Anderson moved to add the item to next week's agenda. He was seconded by Vice Chair Mitchell. The motion carried.
