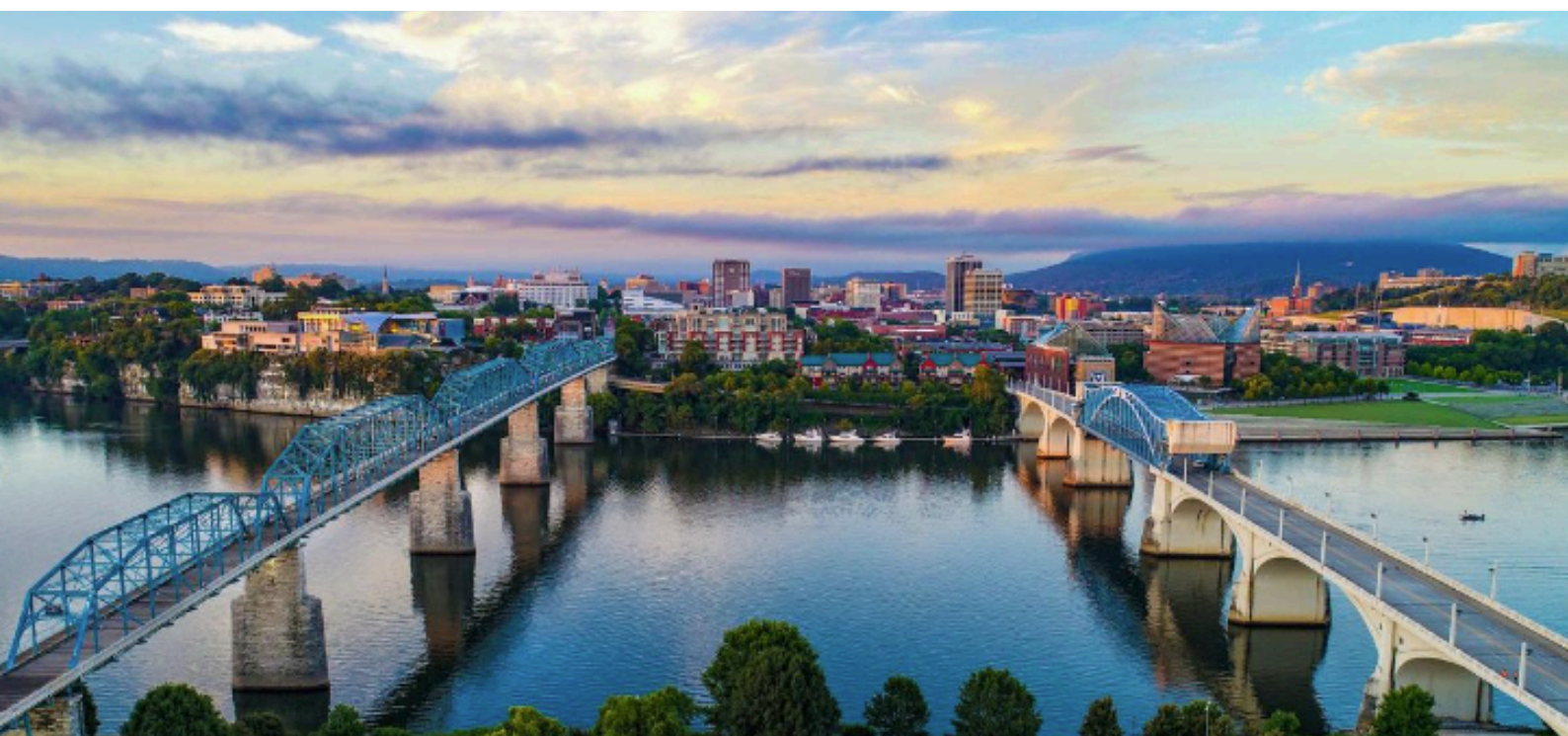

# BREAKDOWN OF THE NUMBERS



The data presented in this report reflects the latest information stored in the Chattanooga Police Department's law enforcement databases.

Since databases entries are continuously updated, expunged, or unfounded, some statistical figures may fluctuate over time.

For instance, a homicide investigation might initially be categorized as an aggravated assault until the victim's medical status is officially confirmed as deceased.

Moreover, it's crucial to not only consider the numerical values under analysis but also the percentage changes. Unusually high percentage changes can sometimes result from a small dataset rather than indicating a substantial shift.

The primary operations of the Chattanooga Police Department are broken into five categories; Neighborhood Policing Bureau, Criminal Investigations Bureau, Special Operations Bureau, Community Development & Support Services Bureau, and Administration.

## Real-Time Intelligence Center

**2,438**

In 2023, our real-time intelligence investigators responded to 2,438 calls for service/requests for video footage. Investigators were able to find usable video footage in 72% of cases worked.

## Victim Services Unit

**1,900**

In 2023, our Victim Services Unit provided services to 1,900 victims, witnesses, and survivors of crime within Chattanooga. A total of 16,367 services were provided by the Victim Services Unit in 2023.

## Crime Analysis Unit

**1,614**

In 2023, our Crime Analysis Unit provided 1,614 analytical reports to officers/investigators, community partners, and outside agencies. The Crime Analysis Unit focuses on tactical, strategic, administrative, and crime intelligence analysis for the CPD.

## Drone Unit

**268**

The Drone Unit seeks to increase situational awareness, enhanced safety, and improved overall operational efficiency through unmanned aircraft systems. In 2023, our Drone Unit deployed 268 times.

## Crisis Co-Responder Unit

**200**

In 2023, there were a total of 2,682 mental health calls in Chattanooga. To help relieve patrol officers of these calls and provide further crisis aid to individuals, the Crisis Co-Responder Unit (CCRU) responded 200 times. Additionally, the majority of calls CCRU responded to were diverted from emergency rooms and confinement.

## Community Outreach Unit

**50+**

The Community Outreach Unit was established to create positive community relationships with the general public. In 2023, the Community Outreach Unit hosted over 50 events, meetings, and programs, all geared towards community engagement.

## CRIMES AGAINST PROPERTY

Crimes against property are defined as incidents that unlawfully destroys another property or deprives an owner of property against the owner's will. The crimes against property included within this report include burglary, larceny/theft, theft from motor vehicle, robbery, and auto theft.

## CRIMES AGAINST PERSONS

Crimes against persons are defined as incidents where an individual has either used or threatened physical force to injure another person such as assault, homicide, kidnapping/abduction, rape, or sexual assault.

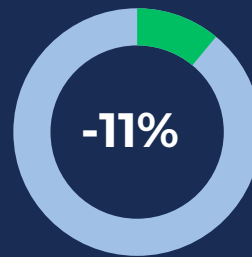
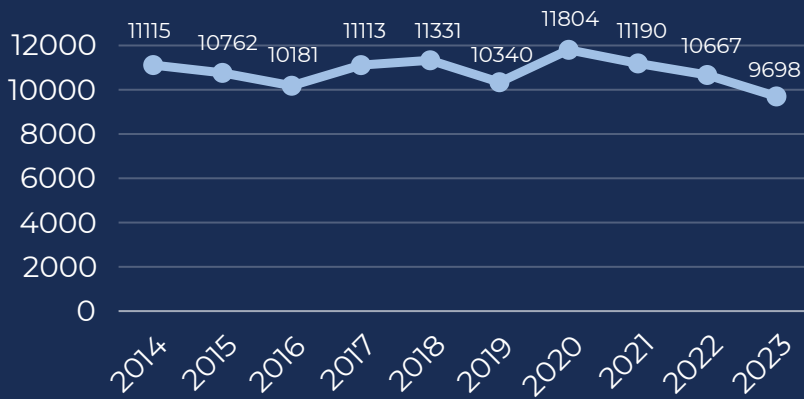
Crimes against society involve criminal activity such as drug-related offenses, driving under the influence, public intoxication, disorderly conduct, or weapons law violations.

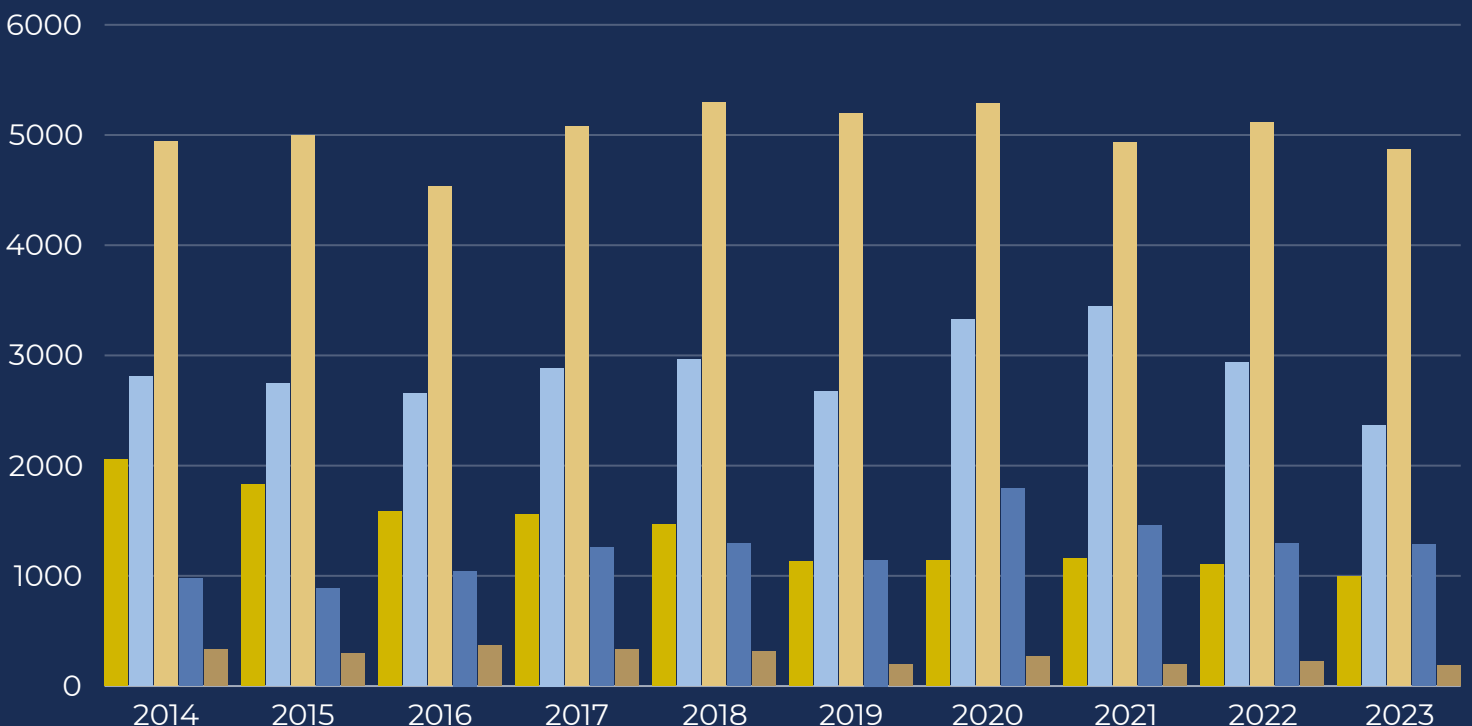
## CRIMES AGAINST PROPERTY TEN YEAR TREND BY YEAR

## CRIMES AGAINST PROPERTY TEN YEAR TREND BY CRIME TYPE



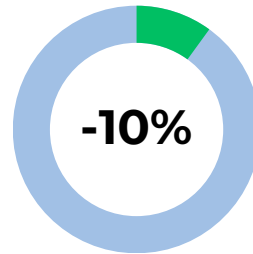
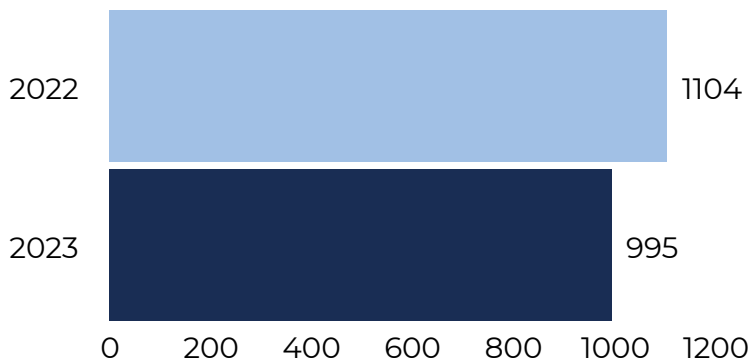




# BURGLARY & LARCENY/THEFT

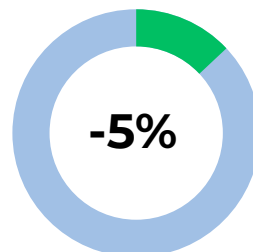
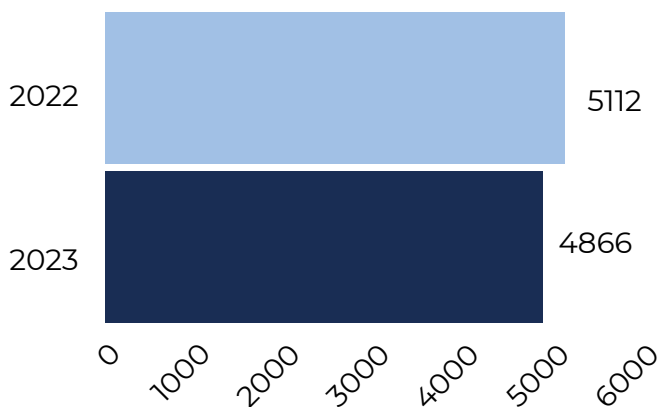
Burglary is the unlawful entry into a building or other structure with the intent to commit a felony or a theft.[1]

Larceny theft is the unlawful taking, carrying, or leading property from the possession or constructive possession of another.[2]

There was a 10% decrease in burglaries.



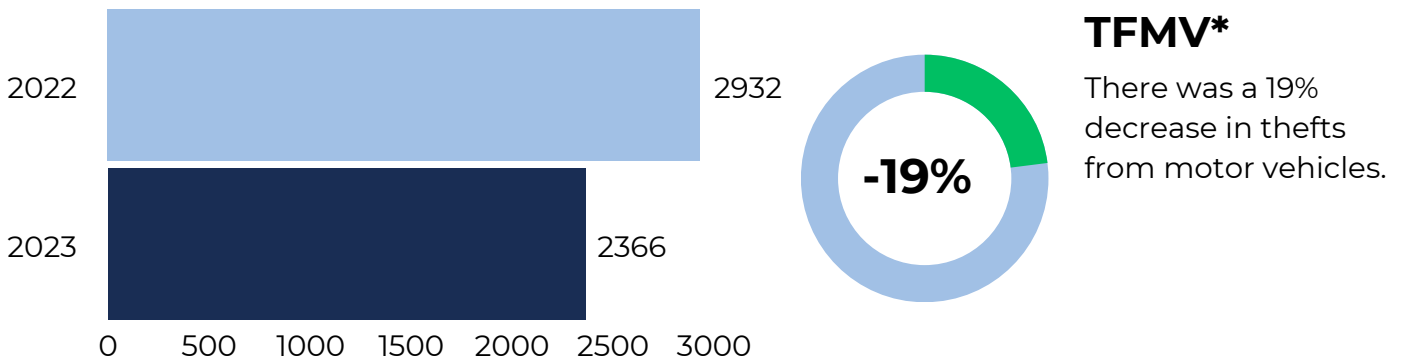
## LARCENY/THEFT

# THEFT FROM MOTOR VEHICLE (TFMV)

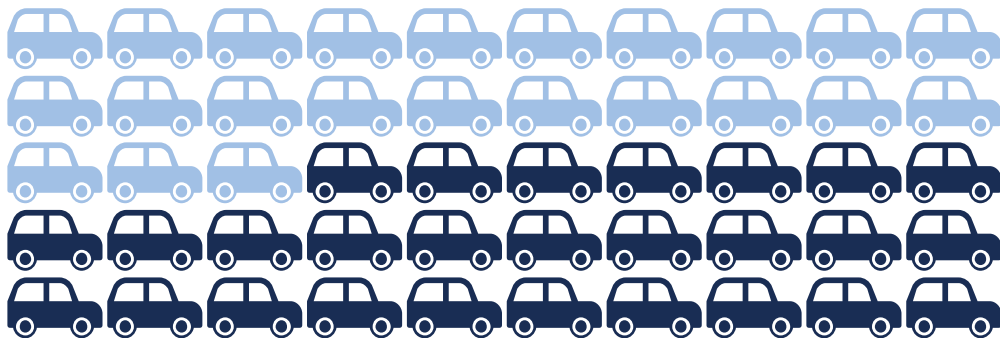


For this analysis, theft from motor vehicle incidents were excluded from the larceny/theft category to be reflected within its own category. Theft from a motor vehicle is the unlawful taking, carrying, or leading property from a motor vehicle.[1]



## FIREARMS STOLEN FROM THEFT FROM MOTOR VEHICLES & AUTO THEFTS

In 2023, there were 396 firearms stolen from vehicles (theft from motor vehicles and auto thefts).



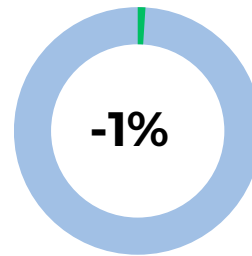
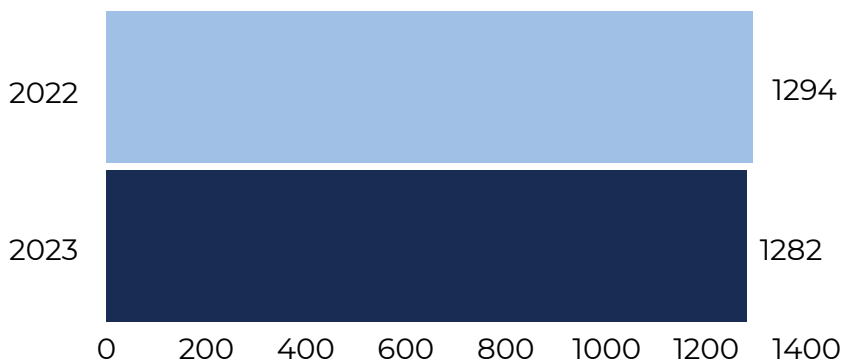
46% of those 396 firearms were stolen due to vehicles being left unlocked (as shown above).

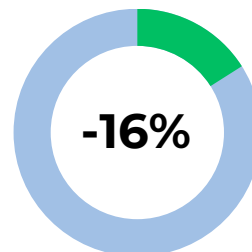
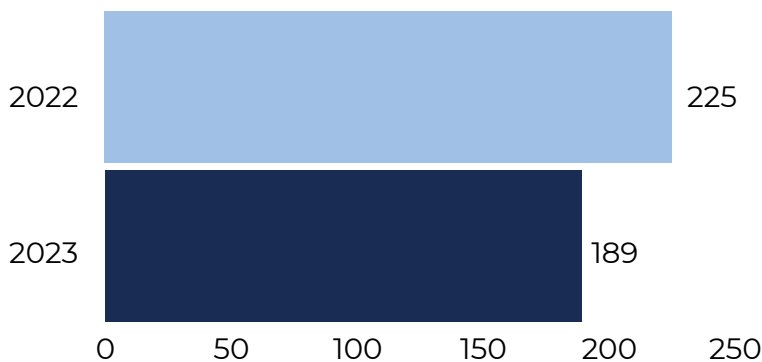
Auto theft is defined as a theft of a motor vehicle.[1]

Robbery is the taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence.[1]

There was a 16% decrease in robberies.

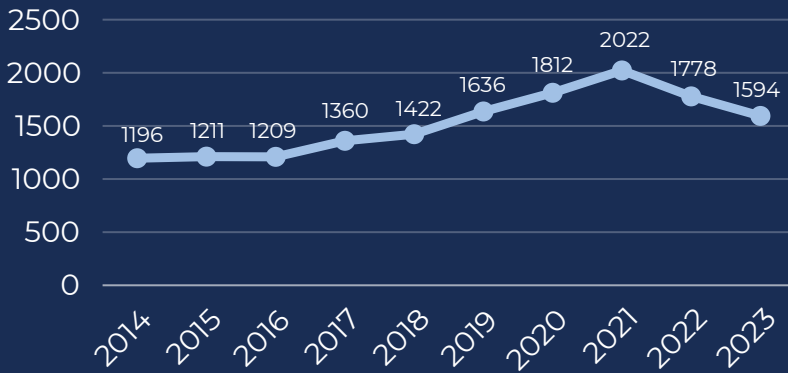

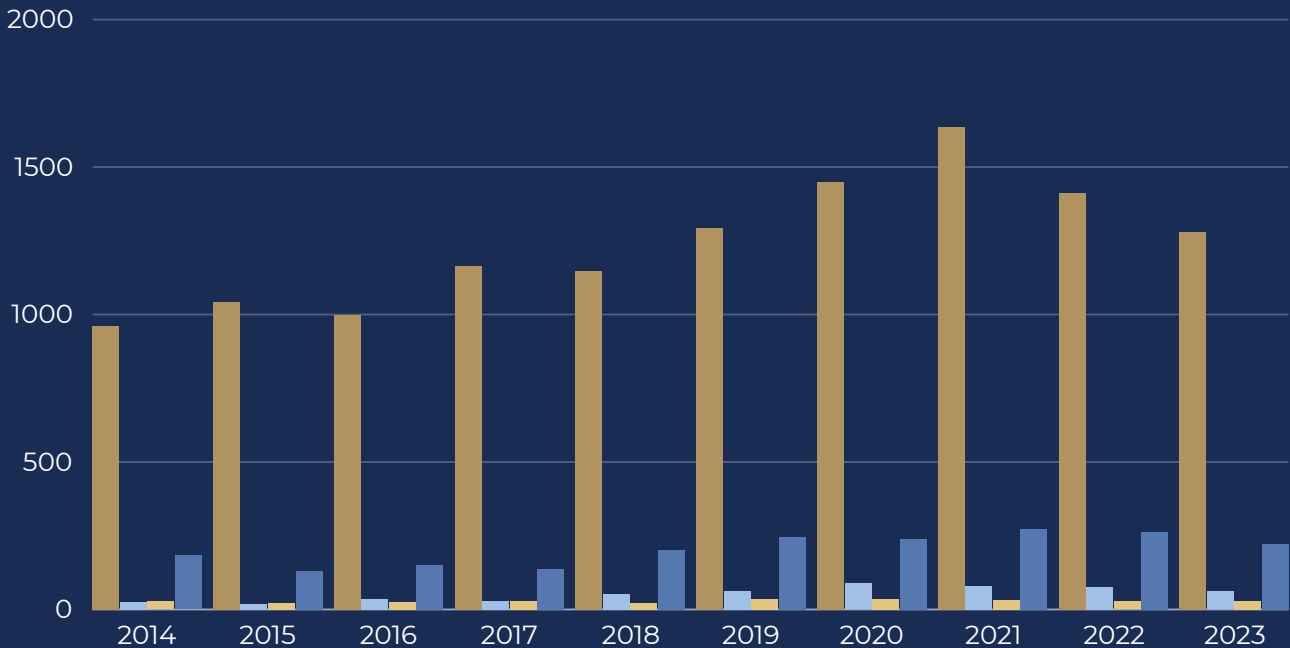
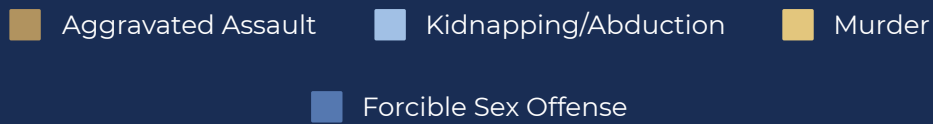
## CRIMES AGAINST PERSONS TEN YEAR TREND BY YEAR

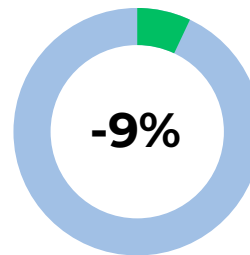
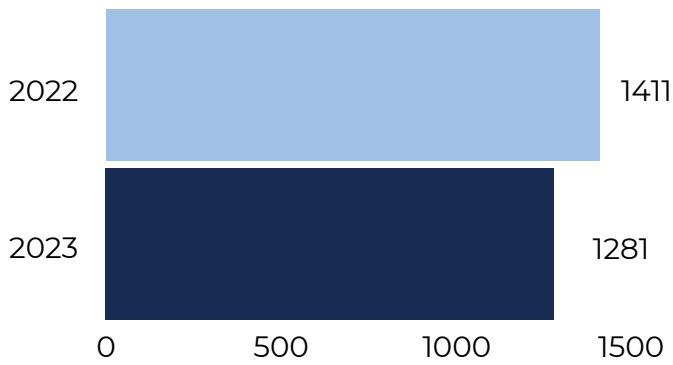


# AGGRAVATED ASSAULT & HOMICIDE



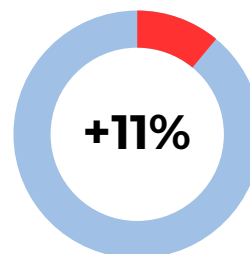
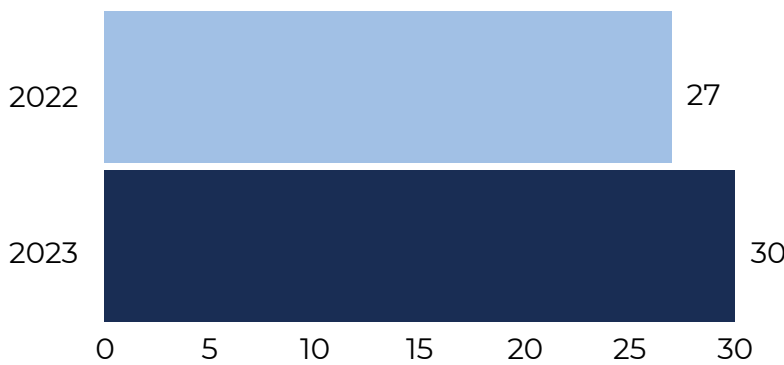
Aggravated assault is the unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner.[1]

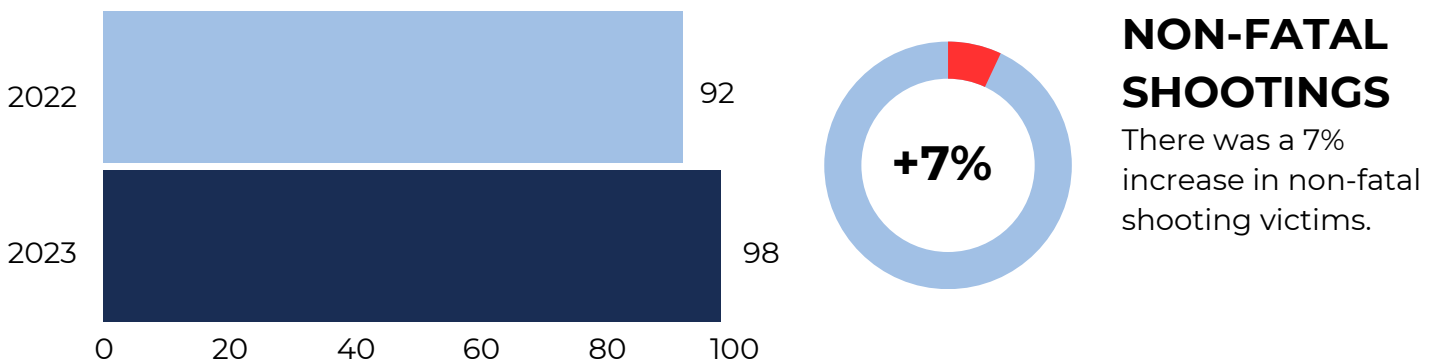
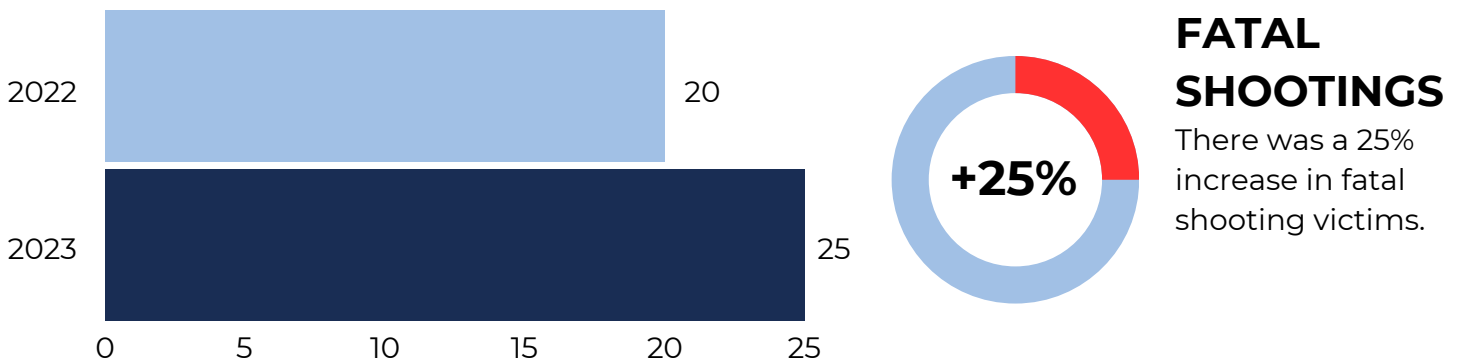
There was a 11% increase in homicides.



# FATAL & NON-FATAL SHOOTINGS

Fatal shootings fall under the homicide Federal Bureau of Investigation (FBI) uniform crime report (UCR) category. A fatal shooting is the unlawful shooting of another that results in death. The fatal shooting information below is reflective of the total count of victims for each year, not the total incidents.

Non-fatal shootings fall under the aggravated assault FBI uniform crime report (UCR) category. A non-fatal shooting is the unlawful shooting of another that does not result in death. The non-fatal shooting information below is reflective of the total count of victims for each year, not the total incidents.



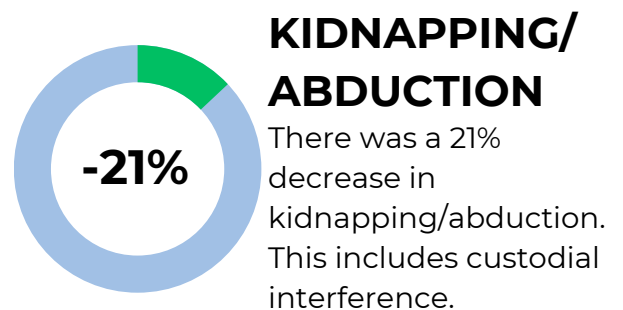
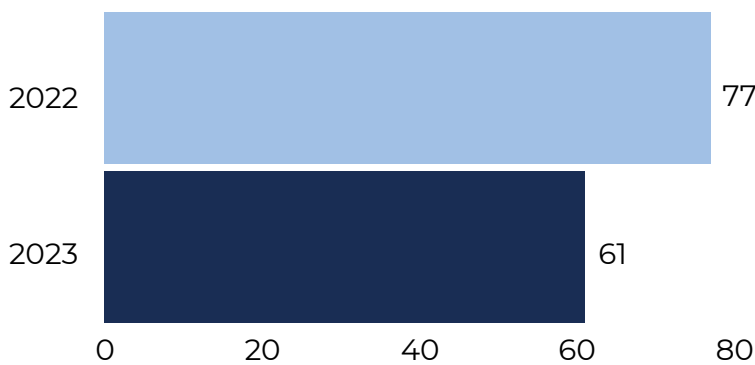
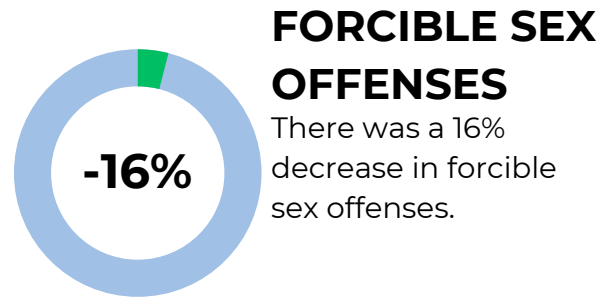
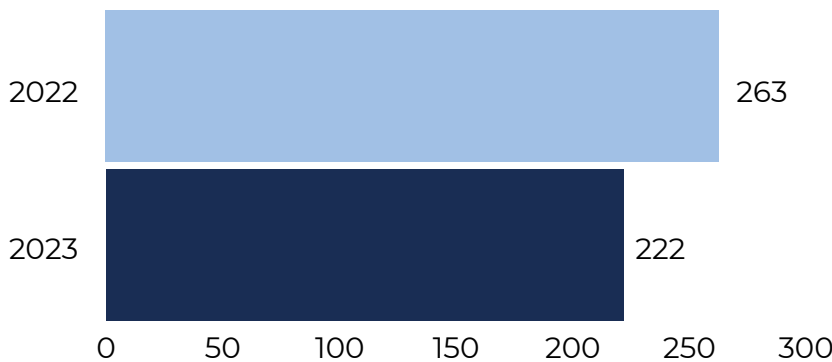




# FORCIBLE SEX OFFENSES & KIDNAPPING/ABDUCTION

Forcible sex offenses are defined as any sexual act directed against another person forcibly.[1]

Tennessee law defines kidnapping as knowingly abducting or confining someone in a manner that interferes with their liberty and exposes them to the substantial risk of injury.[1] The numbers that are reported reflect the textbook definition of kidnapping and additional custodial interference.

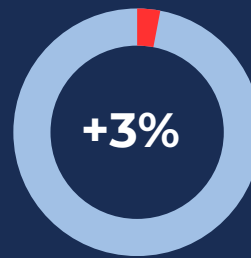
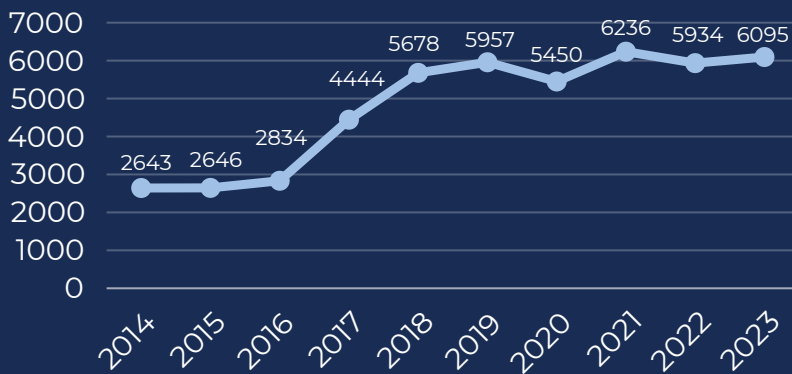




# CRIMES AGAINST SOCIETY

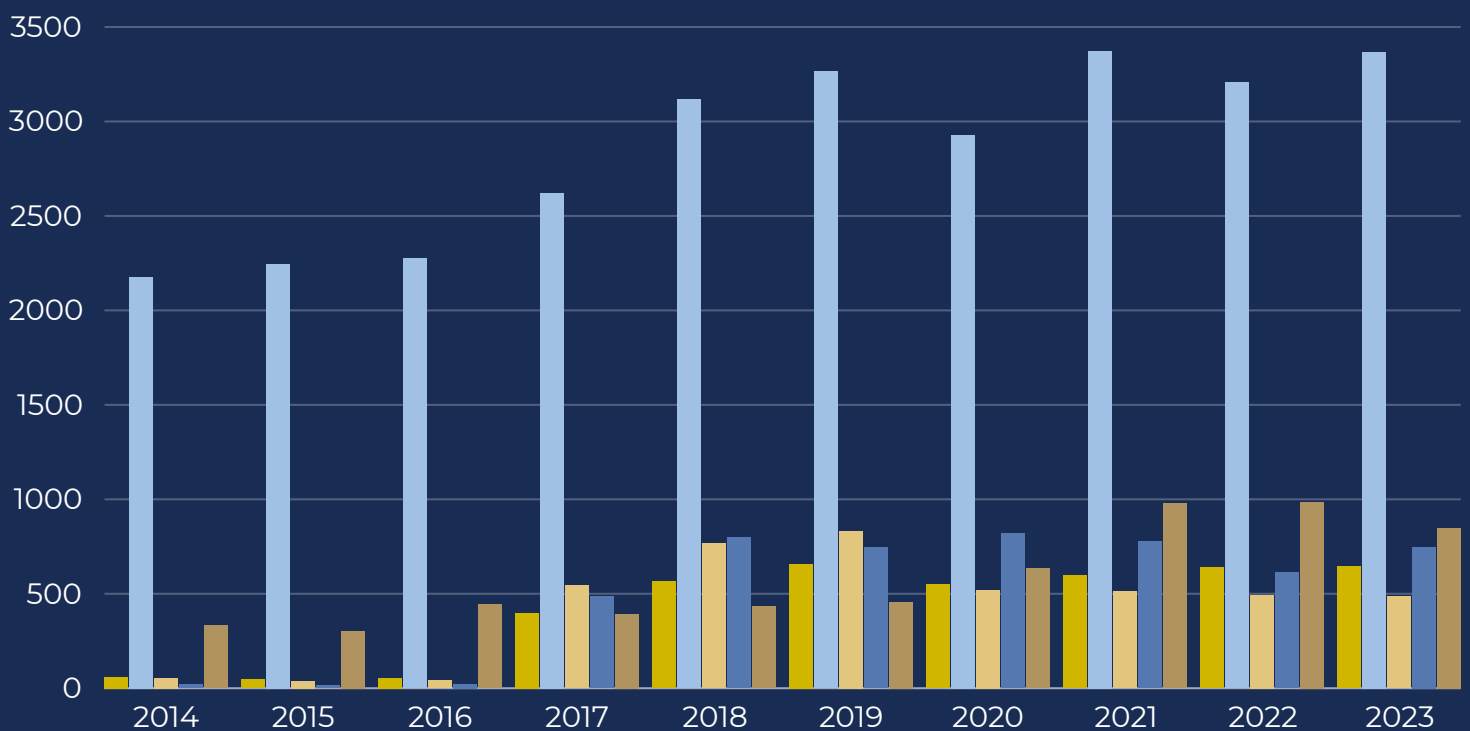
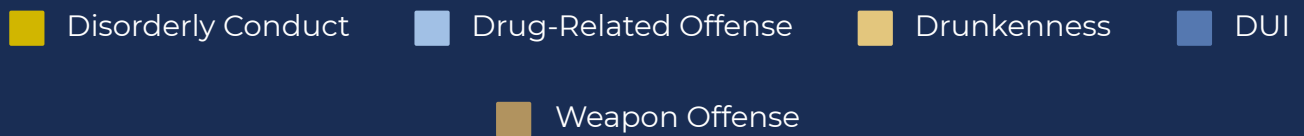
## CRIMES AGAINST SOCIETY TEN YEAR TREND BY YEAR

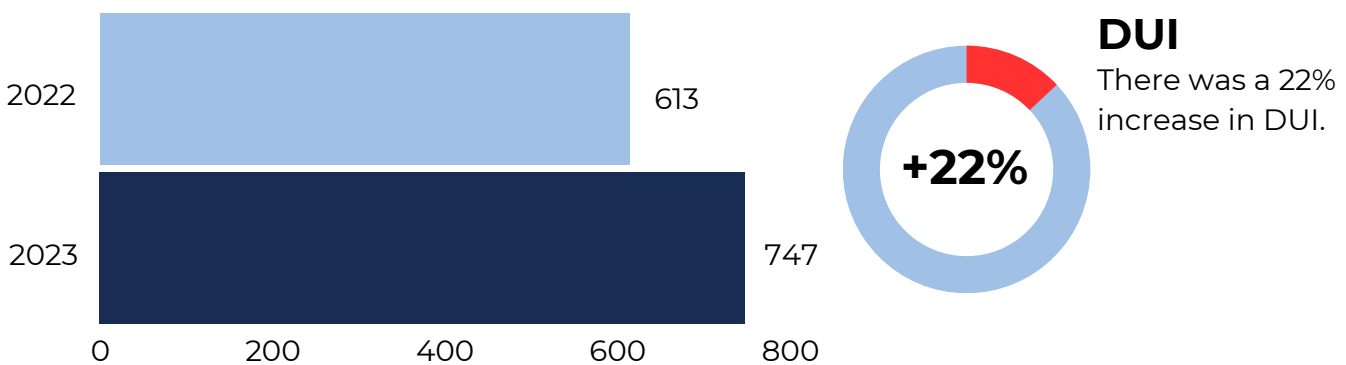
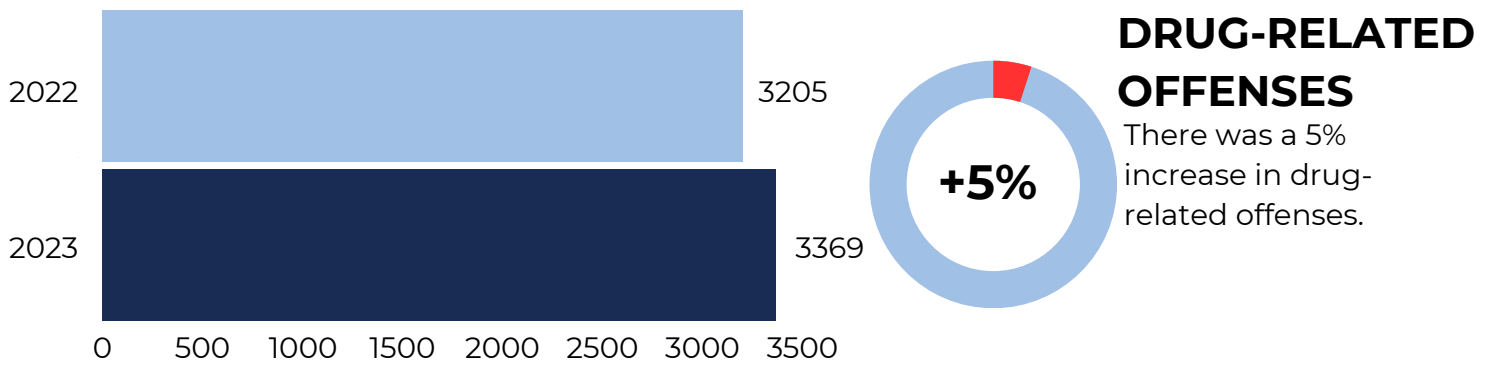


# DRUG-RELATED OFFENSES & DUI



A drug-related offense is when one unlawfully manufactures a controlled substance, delivers a controlled substance, sells a controlled substance, or is in possession of a controlled substance.[1]

Driving under the influence is when a person's ability to safely operate a motor vehicle is impaired. A person may be charged for a DUI if they are under the influence of an intoxicant such as marijuana, narcotic drugs, or alcohol.[1]

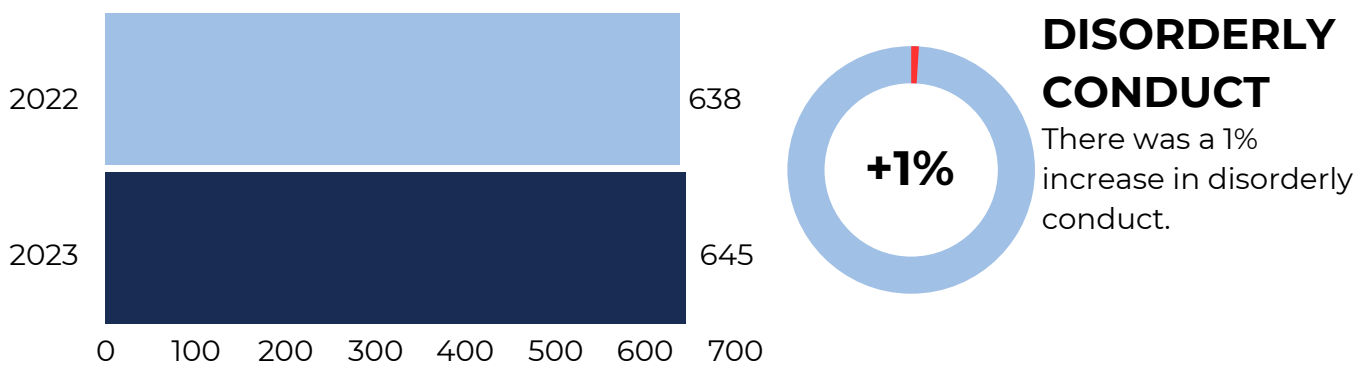
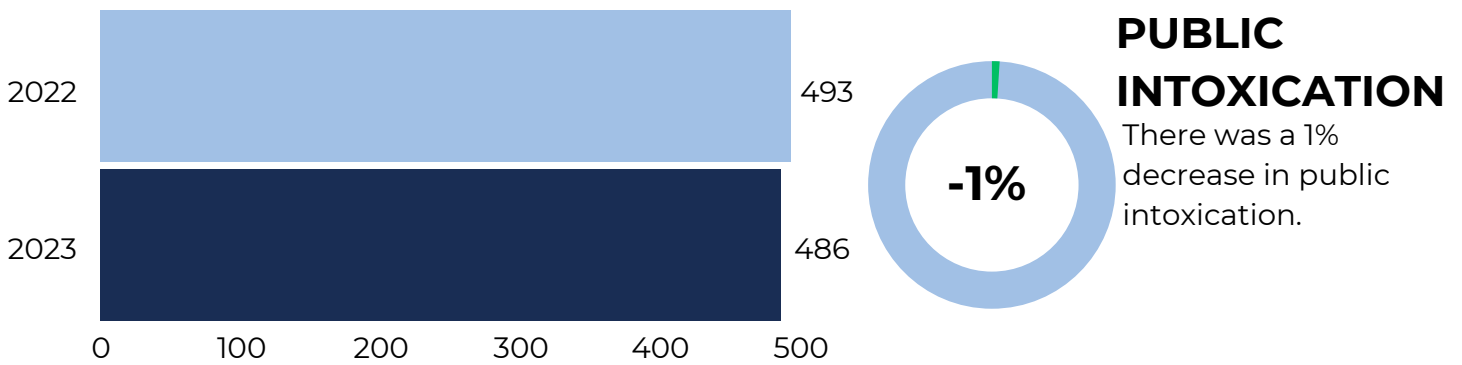




# PUBLIC INTOXICATION & DISORDERLY CONDUCT

In Tennessee, a person may be charged with public intoxication if he or she appears in public under the influence of alcohol or a controlled substance to the degree that the intoxicated person: may be endangered. presents a danger to other people or property, or unreasonably annoys people in the vicinity.[1]

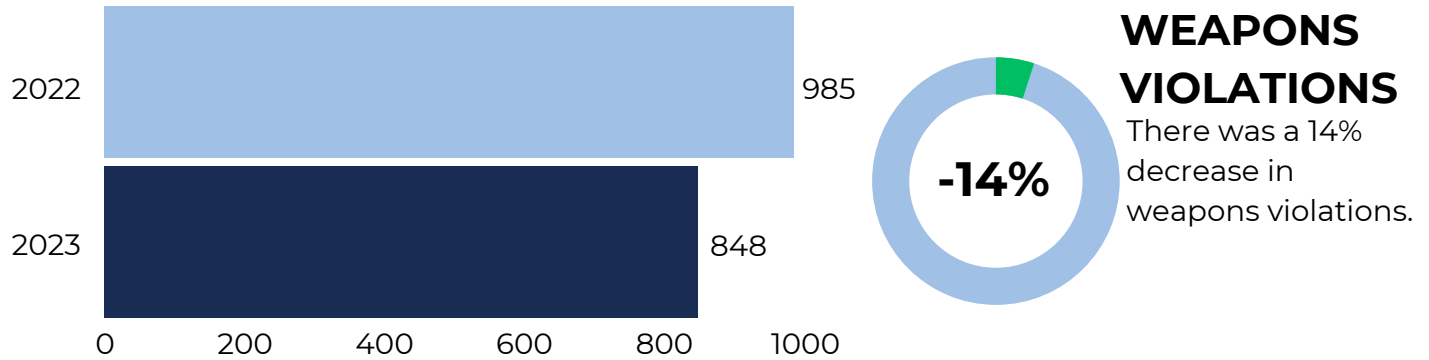
Disorderly conduct is when a person commits an offense who, in a public place and with intent to cause public annoyance or alarm.[1]



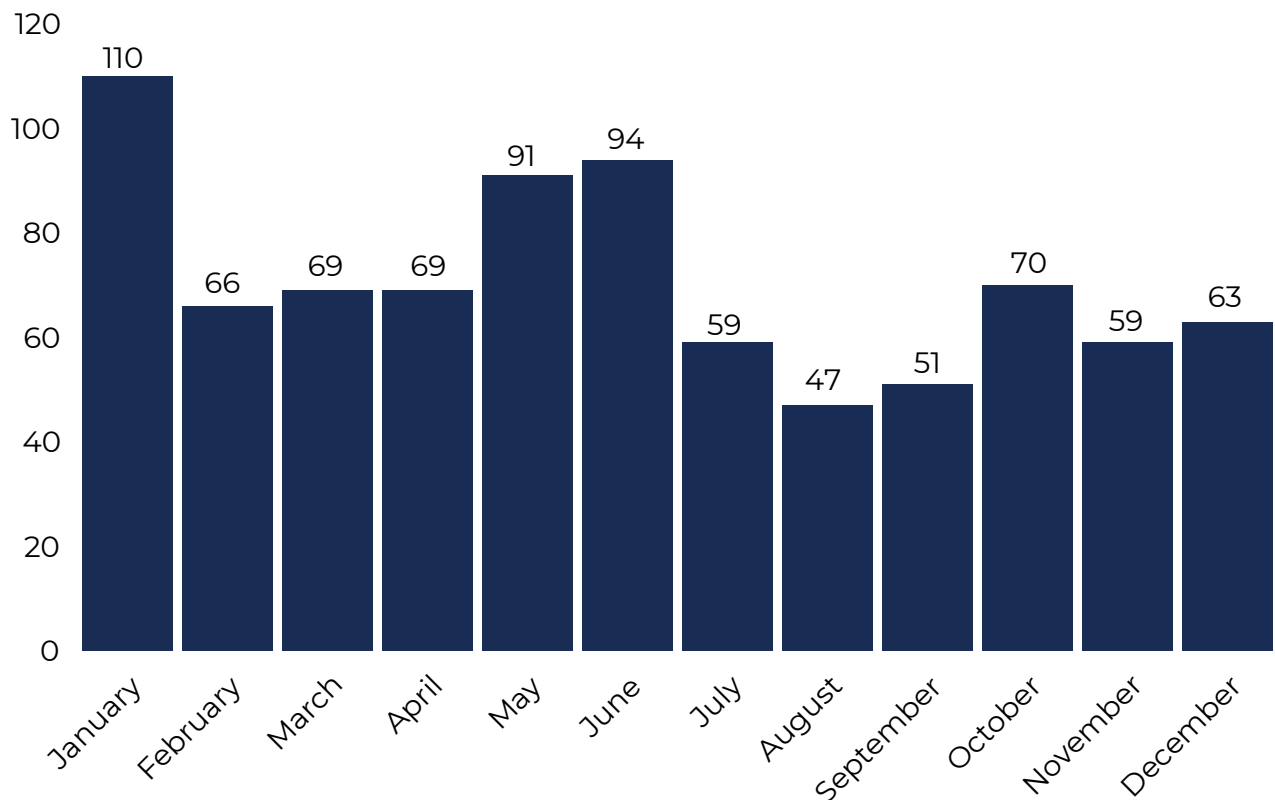


# WEAPONS VIOLATIONS

Weapons offenses are violations of statutes or regulations that control deadly weapons. Deadly weapons include firearms and their ammunition, silencers, explosives, and certain knives.[5]



## 2023 WEAPONS LAW VIOLATIONS BY MONTH



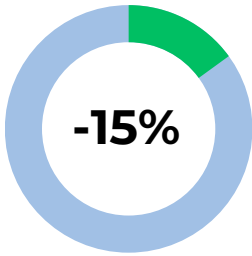
# Overdoses



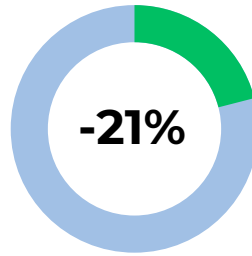
People can overdose through multiple substances, including prescription drugs, opioids, or a mixture of drugs. Opioid overdoses happen when there are many opioids or a combination of opioids and other drugs in the body that the victim is unresponsive to stimulation and/or breathing is inadequate.[4] Below are stats from the overall overdoses that occurred within the City of Chattanooga in 2023.

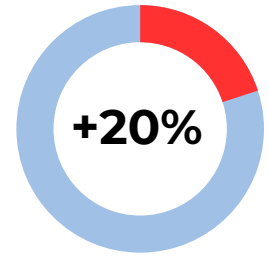
There was a 15% decrease in overdoses.



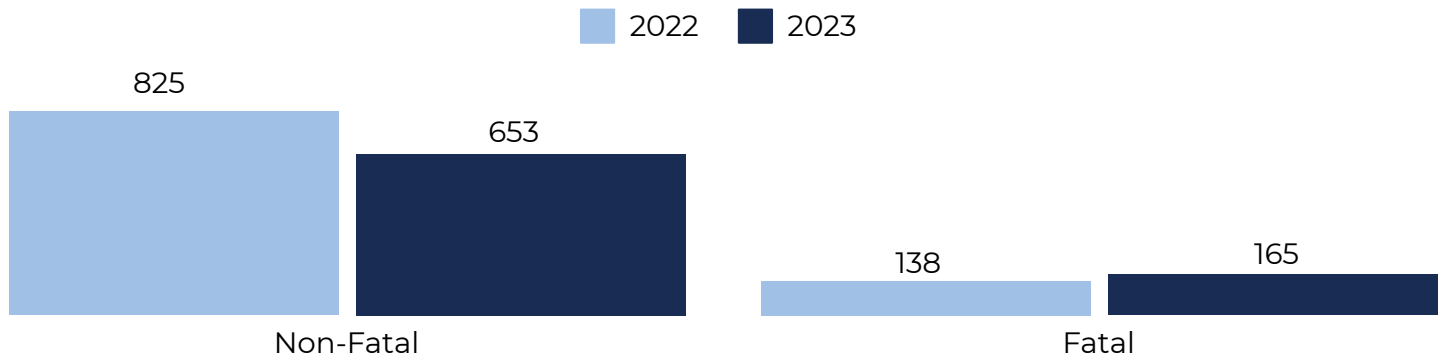
There was a 21% decrease in non-fatal overdoses.



There was a 20% increase in fatal overdoses.



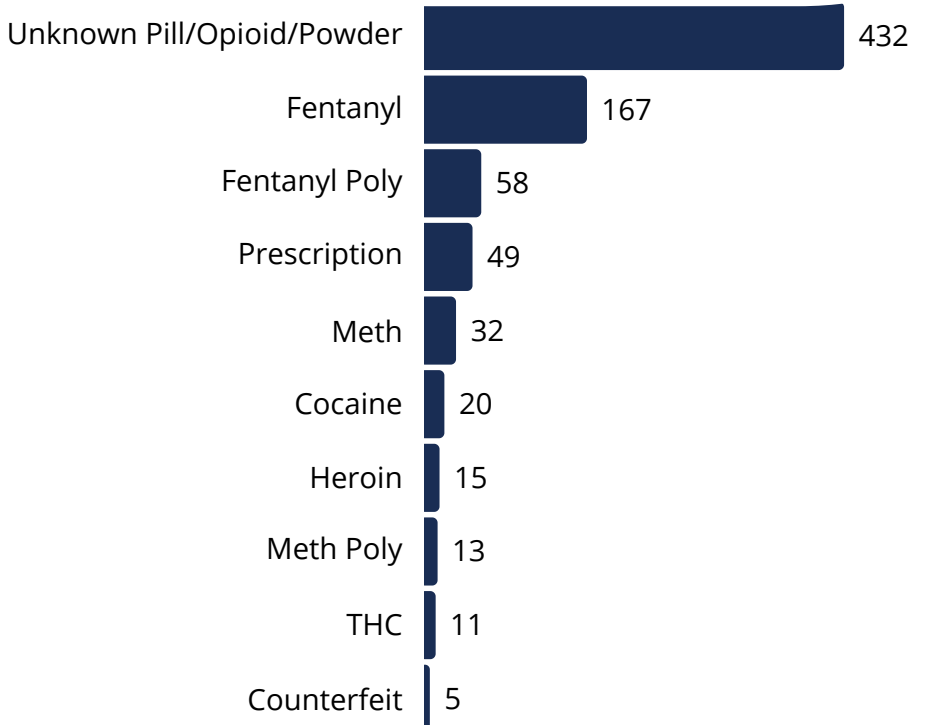

## 2023 Overdoses By Top Ten Drug Usage

To the right the chart shows overdoses by top ten drugs used in 2023. Of those overdoses, 432 overdoses worked by patrol within the city were due to unknown pills/opioids/powders.

One of the highest drug usage types for the last three years has been fentanyl/fentanyl poly, which has been the leading drug for fatal overdoses for the past several years.

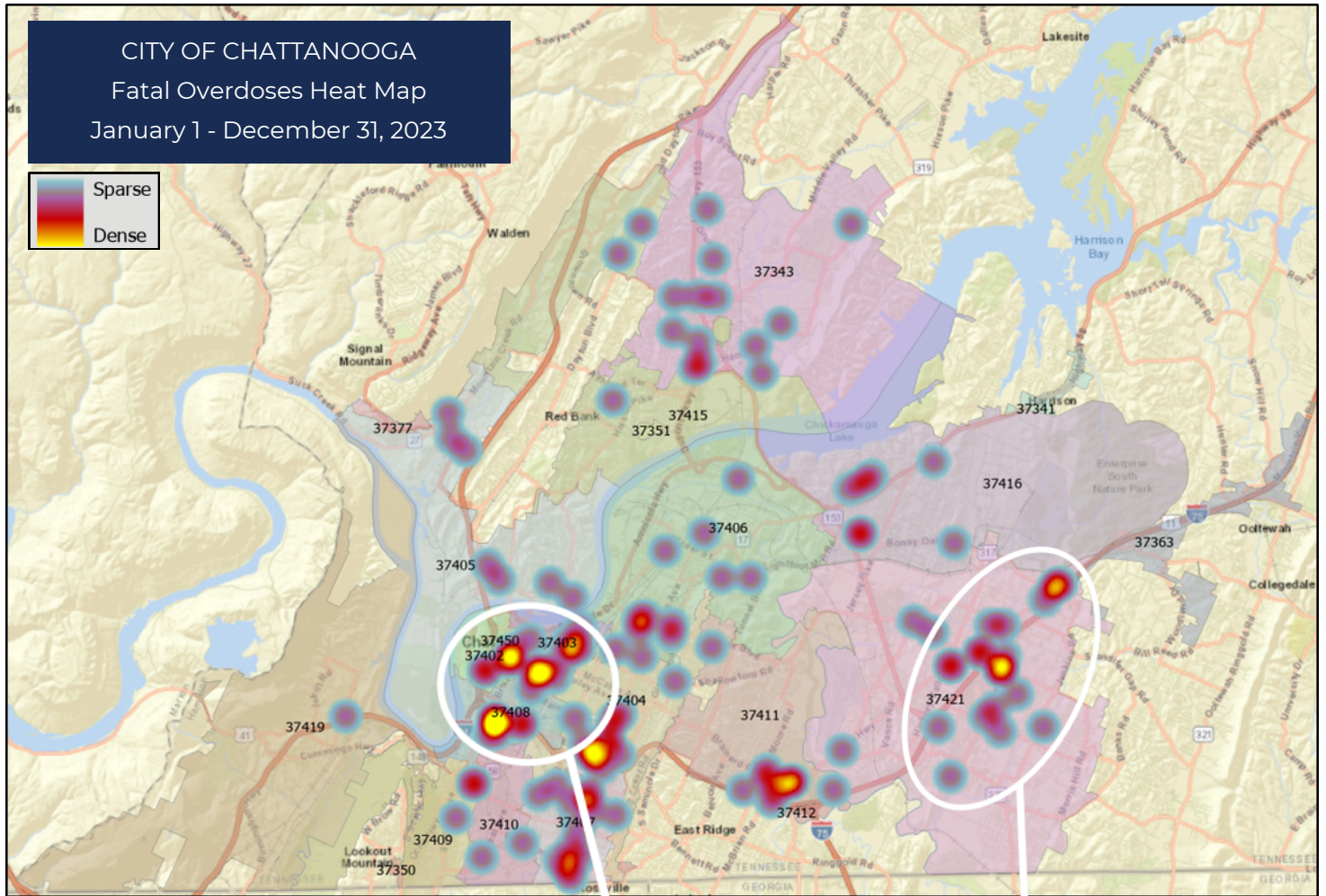




# Fatal Overdoses



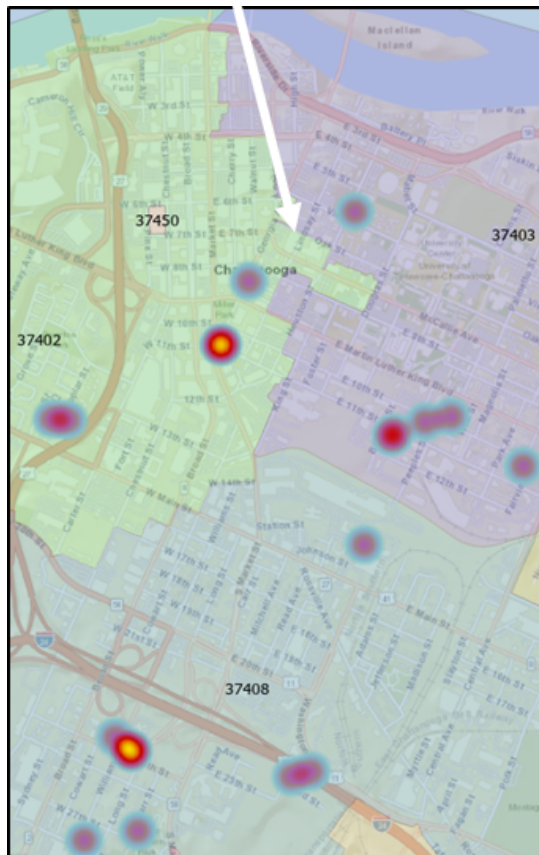
The overdoses mapped below reflect the location where the fatal overdose incidents occurred within the City of Chattanooga.

The zip code 37421 had the highest quantity of fatal overdoses.

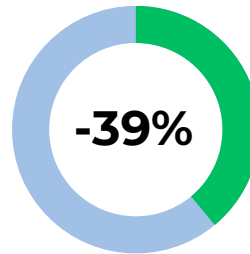
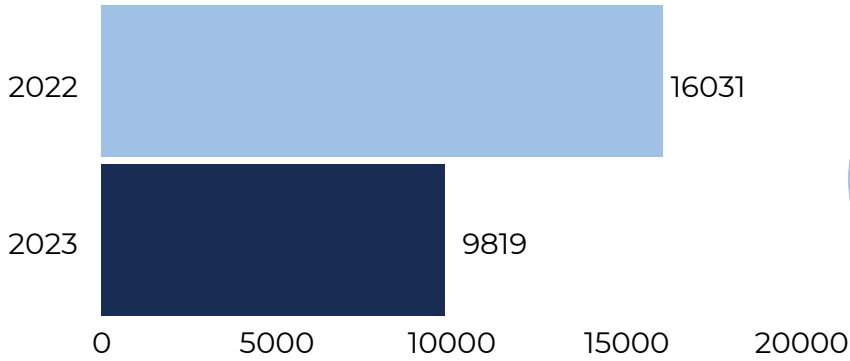
A large quantity of these fatal overdoses that occurred within the 37421 zip code occurred at either residential locations or extended-stay motels/hotels.



# TRAFFIC COLLISIONS



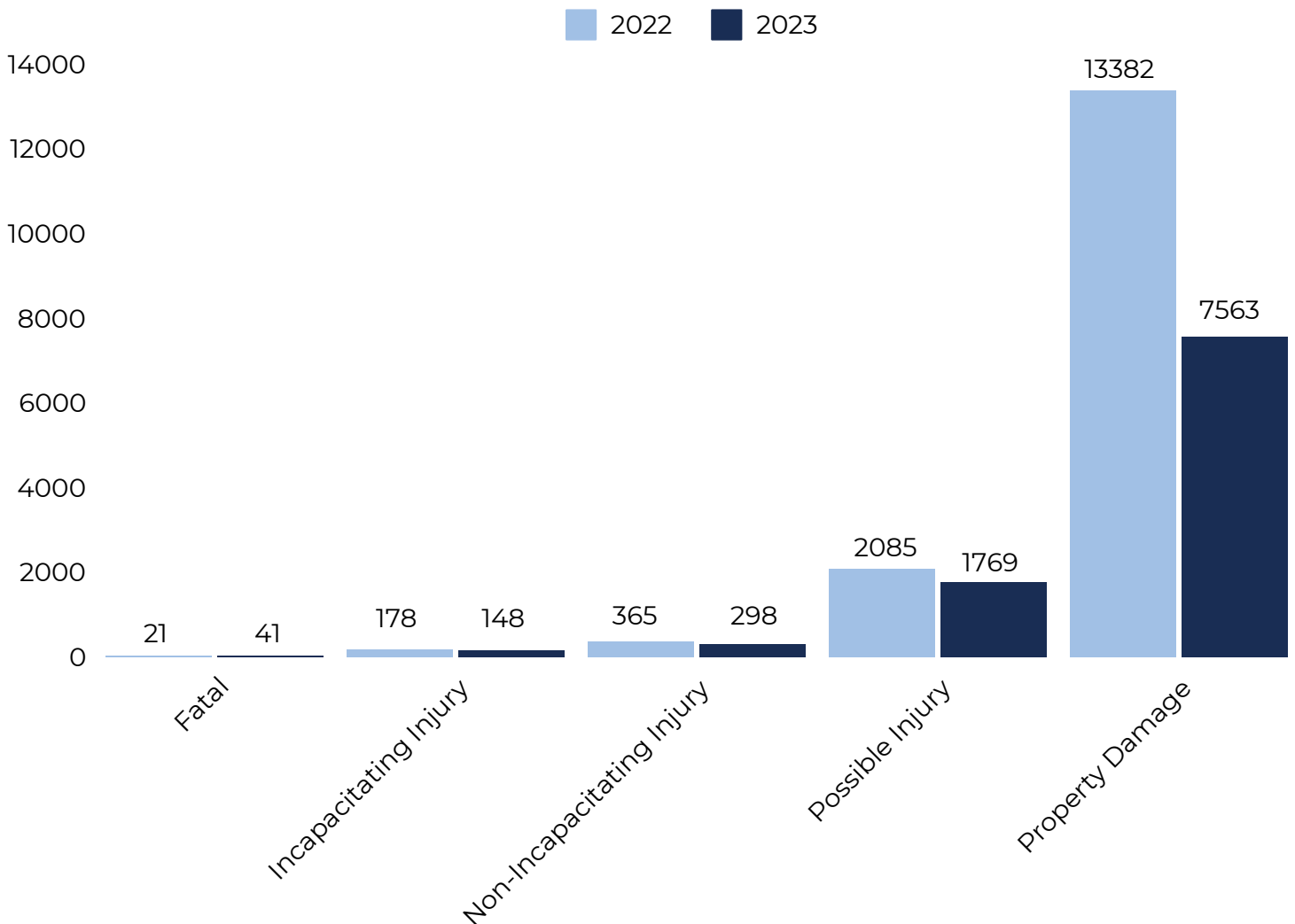
A traffic collision, also known as a motor vehicle collision occurs when a vehicle collides with another vehicle, pedestrian, animal, road debris, or other moving or stationary obstruction, such as a tree, pole or building.[3]

There was a 39% decrease in traffic collisions.

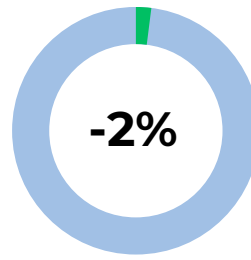
### 2022 / 2023 TRAFFIC COLLISIONS BY CRASH TYPE



# PEDESTRIANS STRUCK



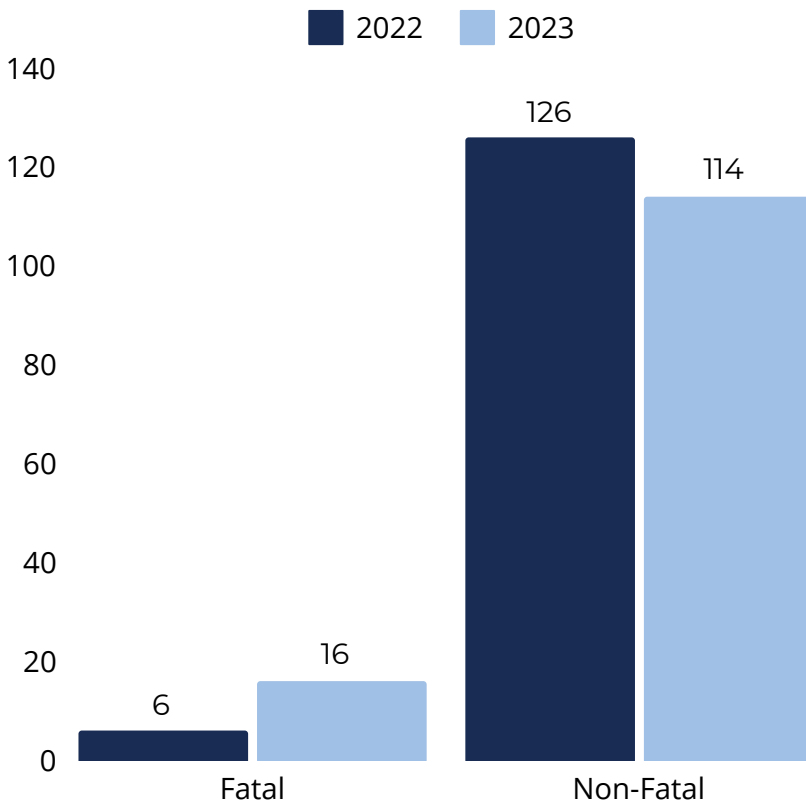

There was a 2% decrease in pedestrians struck.

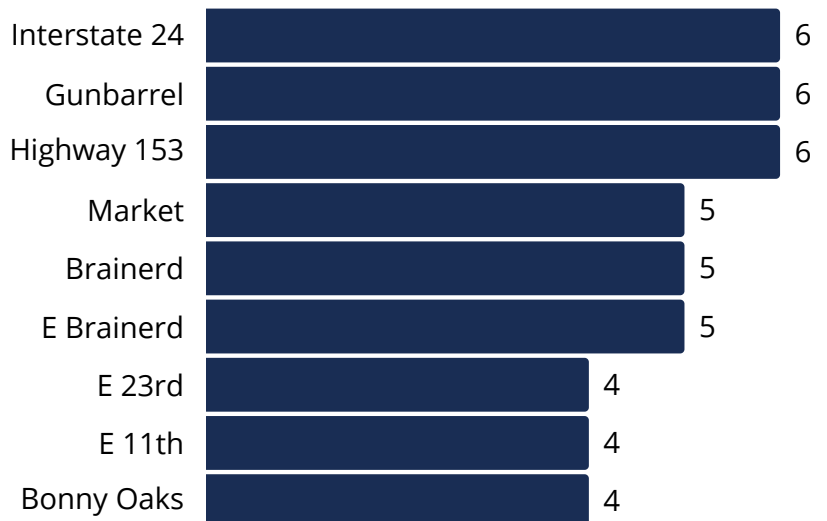
### 2022 / 2023 Pedestrian Struck Incidents

### 2023 Roadways with the Most Frequent Pedestrians Struck



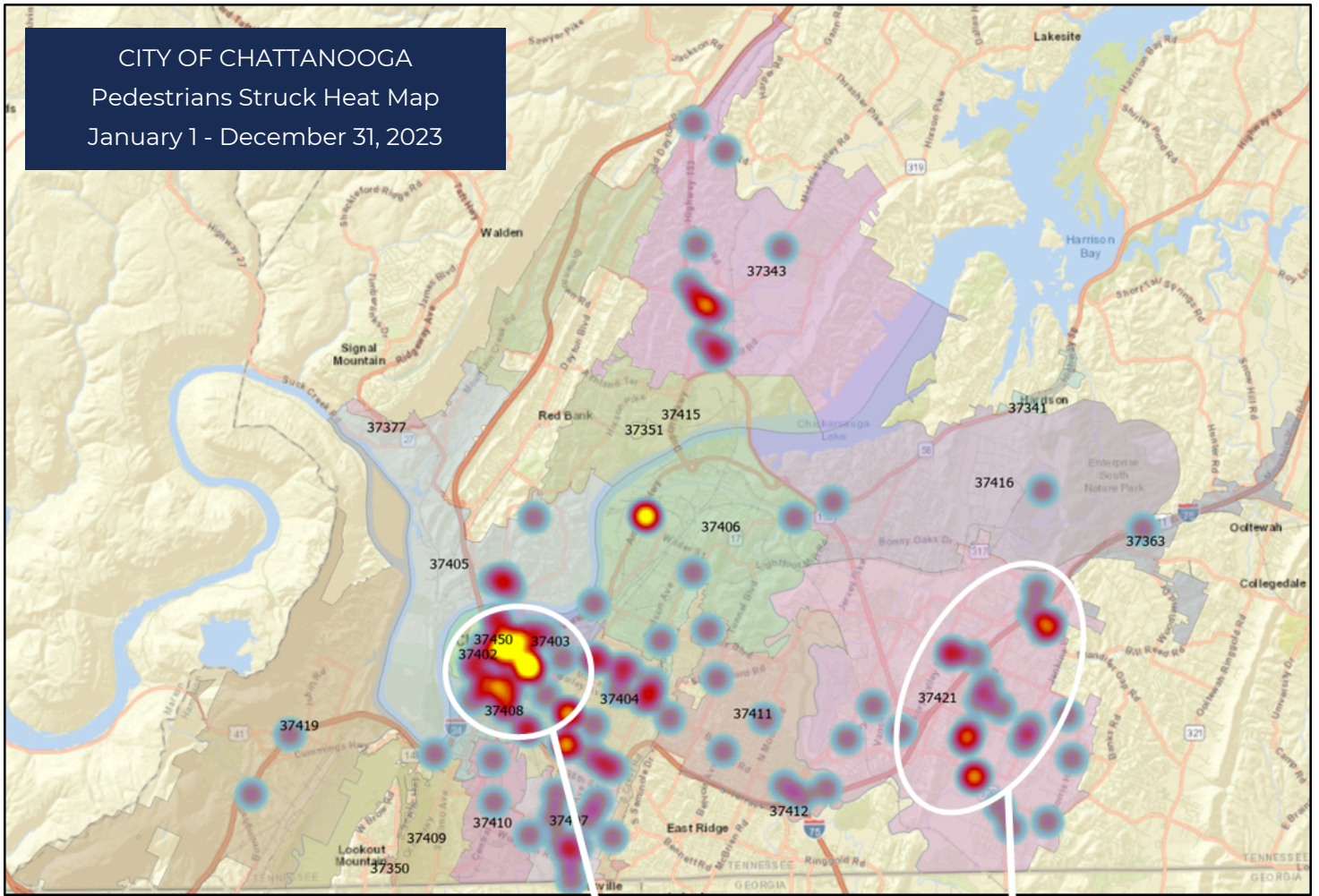

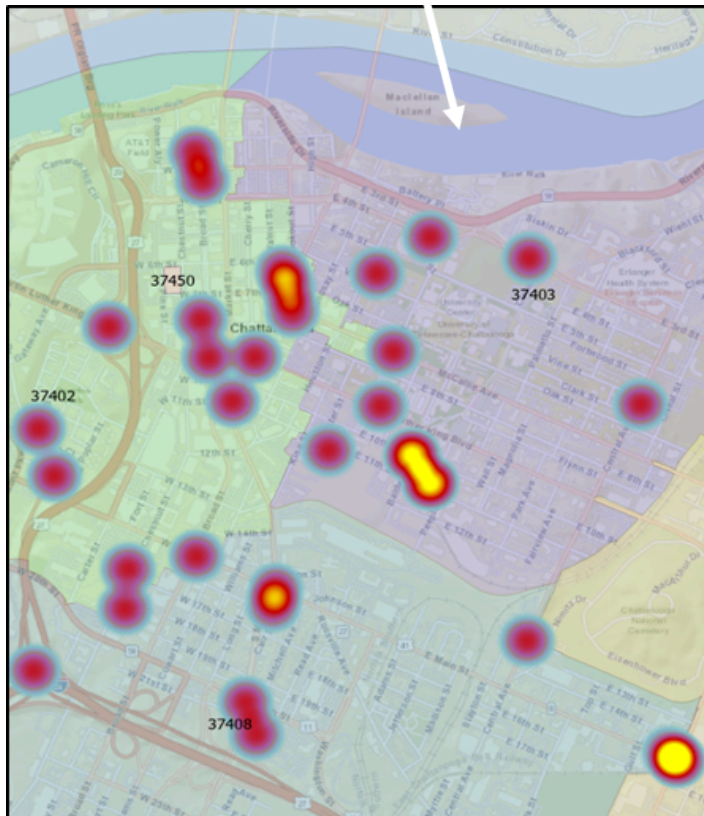

The zip code 37421 had the highest quantity of pedestrians struck.

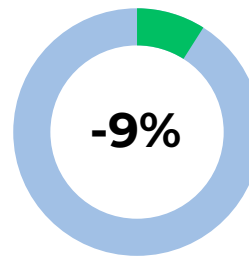
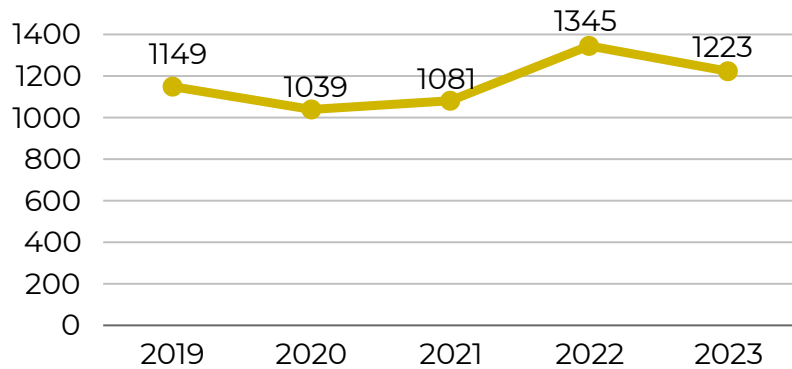




# DOWNTOWN PART ONE CRIME

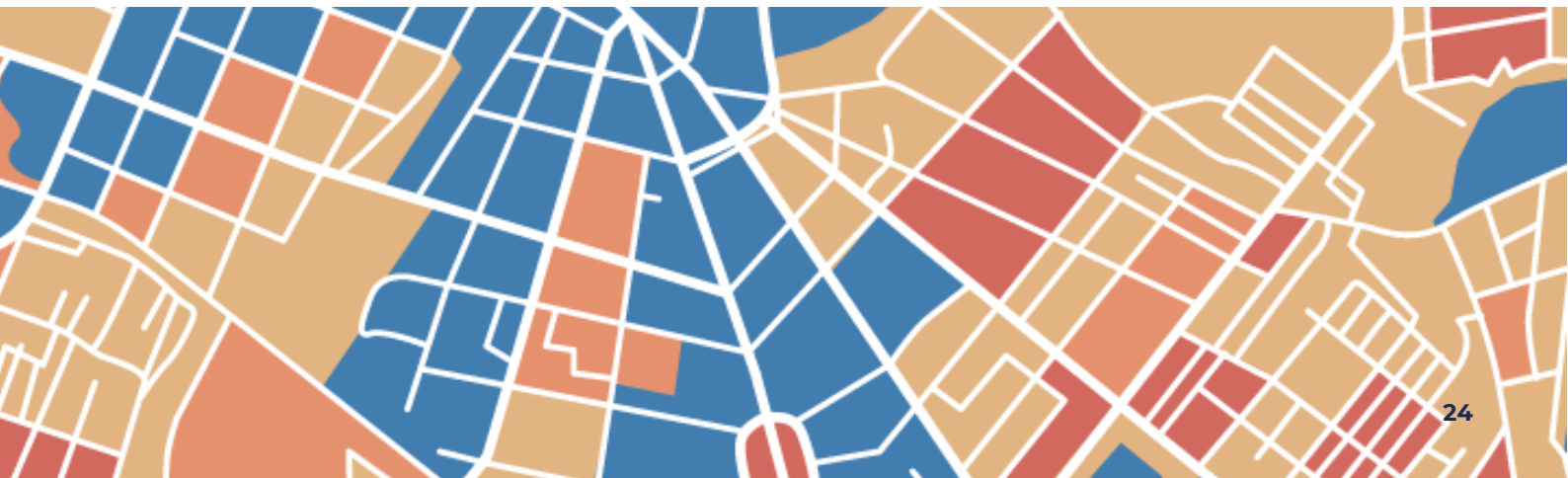
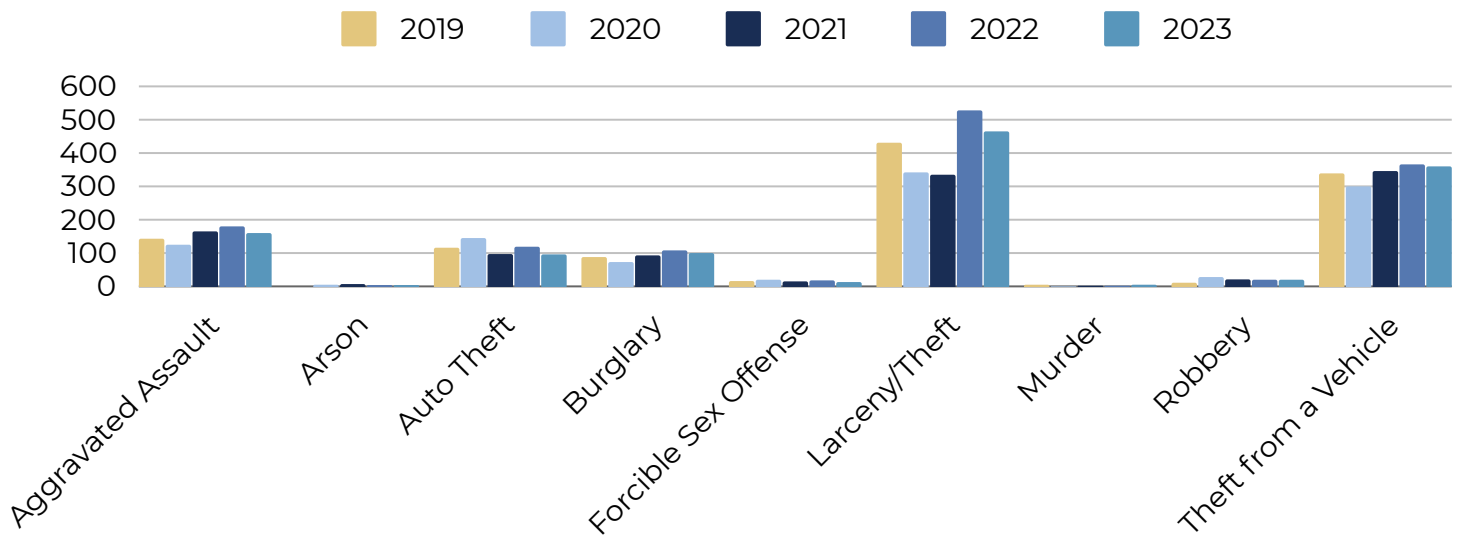
## PART ONE CRIMES WITHIN THE DOWNTOWN AREA FIVE YEAR TREND BY YEAR
